AN ORDINANCE ESTABLISHING THE MUNICIPAL PHARMACY IN THE LOCAL GOVERNMENT UNIT OF JAVIER, JAVIER RURAL HEALTH UNIT (RHU) AND APPROVING THE PHARMACY NAME, "JAVIER COMMUNITY PHARMACY", PROVIDING FUNDS THEREOF AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Sangguniang Bayan of Javier, Leyte, THAT:

SECTION 1. Short Title- This Ordinance shall be known as the "Javier Community Pharmacy Ordinance ".

SECTION 2. Establishment of Municipal Pharmacy – The Local Government Unit of Javier, Leyte, hereby establishes the Javier Community Pharmacy to provide effective but affordable medicines for Senior Citizens, AICS beneficiaries and PhilHealth eligible beneficiaries of the e-Konsulta Provider Program, which shall thereafter be refunded by PhilHealth to the RHU-Javier;

SECTION 3. Location and Management – The Javier Community Pharmacy shall be situated at the Municipal Health Office of Javier in which its management, operation, and administration rest upon.

SECTION 4. Funding- The funds that are necessary for the establishment of the Javier Community Pharmacy shall come from the General Fund of the Annual Budget of the LGU of Javier, Leyte, and which shall be used for, but not limited to the following:

.Renovation of a room for the Javier Community Pharmacy.

b. Pharmacy furniture and supplies

c. Cold Chain logistics and supplies

d. Preventive maintenance and calibration of equipments

SECTION 5. Continuity – The Javier Community Pharmacy, as contained in this Ordinance shall continue to be in full strength and effect, unless otherwise, repealed amended or modified accordingly.

SECTION 6. Separability Clause - If for any reasons, any part of provision of this Ordinance shall be held unconstitutional or invalid by competent authority, other parts or provision hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 7. Repealing Clause- All Ordinances, Resolutions, Local Executive Orders and/or Administrative Orders or parts thereof which are inconsistent with or contrary to any of the provisions of this Ordinance are hereby repealed and modified accordingly.

SECTION 8. Effective Clause- This ordinance shall take effect immediately upon its approval.
