<sup>i</sup> Section 447(i) and (iii) LGC - Fix and impose reasonable fees and charges for all services rendered by the municipal government to private persons or entities;

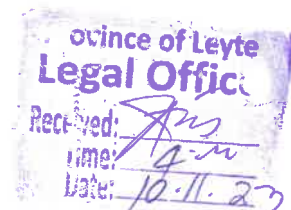
Prescribe the terms and conditions under which public utilities owned by the municipality shall be operated by the municipal government or leased to private persons or entities, preferably cooperatives;

<sup>ii</sup> Section 186 LGC- Local government units may exercise the power to levy taxes, fees or charges on any base or subject not otherwise specifically enumerated herein or taxed under the provisions of the National Internal Revenue Code, as amended, or other applicable laws: Provided, That the taxes, fees, or charges shall not be unjust, excessive, oppressive, confiscatory or contrary to declared national policy: Provided, further, That the ordinance levying such taxes, fees or charges shall not be enacted without any prior public hearing conducted for the purpose.

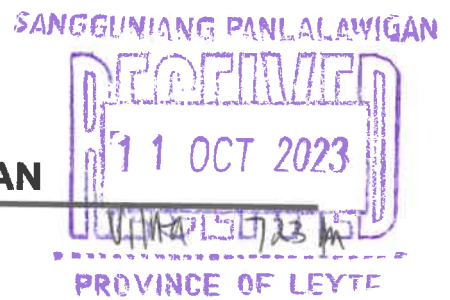

**MUNICIPAL ORDINANCE NO. 05-2023**

**AN ORDINANCE PRESCRIBING THE FEES AND OTHER CHARGES FOR THE OPERATION OF THE MATALOM COMMUNITY HOSPITAL, MATALOM, LEYTE.**

WHEREAS, under Republic Act 7160, otherwise known as the Local Government Code of 1991, local government units shall exercise such powers and discharge such functions and responsibilities as are necessary appropriate or incidental to efficient and effective provision of basic services and facilities which cover, among others, health services including secondary and tertiary hospitals;

WHEREAS, by virtue of Municipal Ordinance No. 08-2022, enacted by the Sangguniang Bayan of Matalom, Leyte, the Matalom Community Hospital was declared as a local economic enterprise and therefore needs to ensure the sustainability and of its operation while providing efficient healthcare services;

WHEREAS, there is a need to update the fees imposed on clinical tests and other services of the hospital in order to be at par with the standards of the industry and since price of the reagents being used have also increased;

BE IT ORDAINED by the Sangguniang Bayan in regular session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the "Matalom Community Hospital Fees and Charges Ordinance of 2023".

SECTION 2. IMPOSITION OF FEES AND OTHER CHARGES. The fees and charges for the use/availment of the facilities and other services of the Matalom Community Hospital are as follows:
