The incident serves as a sobering testament to the pressing need for urgent intervention.

Today, I rise before this August assembly to request our unwavering support in addressing this grave concern. It is imperative that we take immediate action to ensure the safety of our constituents and all road users in the vicinity.

I call upon the Sangguniang Panlalawigan to pass a resolution urging the Department of Public Works and Highways (DPWH) Regional Office, thru the Office of the Regional Director to:

- Conduct a comprehensive safety assessment of the steep road that leads to the Tigbao National Highway.
- Implement immediate safety measures, including the installation of warning signs, speed limits, and other necessary precautions to mitigate the risks associate with this hazardous road.
- Collaborate with the local community and businesses to develop a comprehensive, long-term solution that will enhance the safety of all road users.
