#### Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our review of the General Fund Supplemental Budget No. 3 FY 2023 of the Municipality of San Miguel, Leyte duly enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2023-03 with a total appropriation in the amount of P13,115,115.29 reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the appropriation for salaries to officials and employees implementing the Fourth Tranche Compensation Adjustment for Local Government Personnel is in accordance with the provisions of LBC 149 dated January 11, 2023 and the authorized rates thereof under Annex "A-6" & "Annex A-1":
- 2. The granting of Honoraria shall be subject to Secs. 288 & 289 of GAAM Vol. 1, LBC No. 62, BC No. 2004-5a and BC No. 2007-3 before its disbursement; It should also not be bigger than the Representation and Travelling allowance granted to department heads.
- 3. That all positions in the plantilla are incorporated in the Organizational Structure and Staffing Pattern of the LGU as approved by the Sanaguniana Bayan;
- 4. That the vacant positions shall be adequately provided with appropriations for salaries, allowances, benefits and fixed personnel expenditures to back up their legal existence, otherwise, the same shall be deemed abolished;
- 5. That the reversion of appropriations is duly authorized by the concerned officials and is backed up by cash collections and are made available to support the expenditures under Supplemental Budget No. 03;
- 6. As per COA Circular No. 2022-04 relative to the increase in the capitalization threshold from P15,000.00 to P50,000.00, tangible items below P50,000.00 should be declassified to Maintenance and Other Operating Expense.
- 7. That the procurement of Equipment, Civil Works and other related services shall be made pursuant to RA 9184 and its Implementing Rules and Regulations;

8. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances and COA procedures and all other existing laws shall be the responsibility of the implementing Local Government Unit.

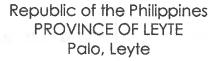

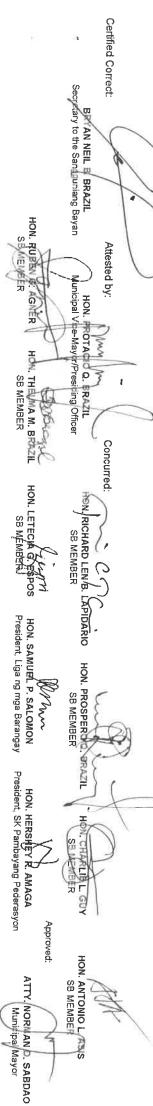
