Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 01 FY 2023** of the **Municipality of Capoocan**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 6**, **Series of 2023**, with a total appropriation in the amount of **P6,205,916.99** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- That the procurement of Goods, Supplies, Civil Works and other related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations;
- 2. That the Municipality created the following positions, to wit:
 - a. (1) Municipal Government Department Head/LDRRMO V
 - b. (1) Nutrition Officer I
 - c. (1) Senior Administrative Assistant I
 - d. (1) Veterinarian III
 - e. (1) Information System Analyst II

Attention is hereby invited to Section 5 of the Civil Service Commission (CSC) Memorandum Circular (MC) No. 12, series of 2022 which provides that the creation and funding of optional positions may be allowed after the mandatory positions have been created.

In view thereof, appropriations for the creation of the said optional positions are hereby deferred until such time that the mandatory positions have been created.

- 3. That the utilization of 20% Development Fund (DF) shall strictly adhere to DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020;
- 4. That the allocation and utilization of the 5% Local Disaster Risk Reduction and Management Fund (LDRRMIF) shall conform with the provisions of NDRRMC-DBM and DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
- That the grant of BAC Honoraria shall be subject to BC No. 2004-5a and BC No. 2007-3;
- 6. That LBP Form 3-A and LBP Form 3 shall indicate the compensation law/circular being implemented.

7. That funds are actually available to pay these proposed expenditures and shall be disbursed for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with CSC rules, DBM issuances, and accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1 FY 2023 OF THE MUNICIPALITY OF CAPOOCAN, LEYTE IN THE AMOUNT OF PhP6,205,916.99

Be it ordained in a Special Session assembled that:

Section 1. The Supplemental Budget No. 1 of the Municipality of Capoocan, Leyte for Fiscal Year 2023 in the total amount of PhP6,205,916.99, is hereby approved.

Section 2. Source of Funds. The sources of funds for Supplemental Budget No. 1 FY 2023 in the total amount of PhP6,205,916.99 as stated in the Statement of Funding Sources are as follows:

a. ACTUAL COLLECTION IN EXCESS OF THE ESTIMATED INCOME 2022 - PhP 231,649.93
b. SAVINGS FROM 2022 OPERATIONS - PhP3,284,079.99
c. REVERSION 20% DEVELOPMENT FUND (AB 2023) - PhP 500,000.00
d. REVERSION 20% DEVELOPMENT FUND (CONTINUING APPROPRIATION) - PhP1,106,990.00
e. REVERSION CAPITAL OUTLAY ACCOUNT (CONTINUING APPRORIATION) - PhP1,083,197.07

TOTAL ESTIMATED INCOME - PhP6,205,916.99

Section 3. This Appropriation Ordinance authorizes the Local Chief Executive and the Presiding Officer of the Sangguniang Bayan to augment items in the approved Supplemental Budget No. 1 for FY 2023, within the same expense class, as needed.

Section 4. Separability Clause: If, for any reason, any section or provision of this Ordinance is declared invalid or unconstitutional, other sections or provisions thereof which are not affected thereby shall continue to be in full force and effect.

Section 5. Effectivity. This Appropriation Ordinance shall take effect upon its approval.
