GABRIELES); MIDWIFE II SG 8 TO SG 11 (JOCELYN A. NUEVAS) AND MIDWIFE II SG 8 TO SG 11 (PEARL ANGELI C. PERANTE).

WHEREAS, pursuant to the mandate of the Local Government Code of 1991, every LGU shall design its own organizational and staffing pattern;

WHEREAS, Section 477 of RA 7160 provides for the Power, Functions of the Sangguniang Bayan which includes among other the determination of positions and salaries, wages, allowances and other emoluments and benefits of officials and employees of the LGU;

WHEREAS, In addition, the basis of the upgrading of the above positions is the DBM Local Budget Circular No. 137 dated July 13, 2021 - Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU);

WHEREAS, after a series of Committee Meetings and thorough study and discussion by the August Body, the herein ordinance is hereby enacted;

NOW THEREFORE, on motion by Hon. Jinky E. Gamez and unanimously seconded;

Section 1. Title - This ordinances shall be entitled "AN ORDINANCE UPGRADING THE SALARY GRADE OF THE FOLLOWING PLANTILLA ITEMS UNDER THE MUNICIPAL HEALTH OFFICE, THIS MUNICIPALITY AND APPROPRIATING FUNDS THEREOF, TO WIT: MIDWIFE II SG 8 TO SG 11 (AL A. Section 2. UPGRADING OF PLANTILLA POSITIONS.

The Salary Grade of the following is hereby upgraded:

The (3) MIDWIFE II under the Municipal Health Office, from Salary Grade 8 to Salary Grade 11

Section 3. FUNDING SUPPORT.

The upgraded salary grades of Three (3) Midwife II shall be automatically funded from the Personal Service component of this Local Government Unit for Budget Year 2024 and years thereafter.

Section 4. SEPARABILITY CLAUSE.

All previous ordinance and issuances inconsistent with this ordinance are deemed amended or repealed.

Section 5. EFFECTIVITY.

This ordinance shall take effect on January 2024.
