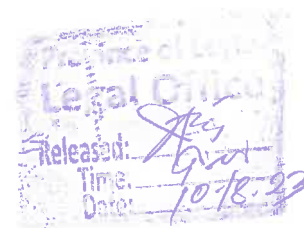

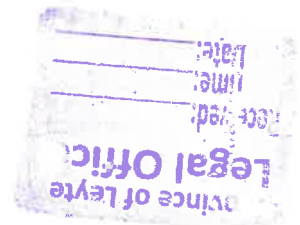
ⁱ Section 21 c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order: Provided, however, That no national or local road, alley, park, or square shall be temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned.

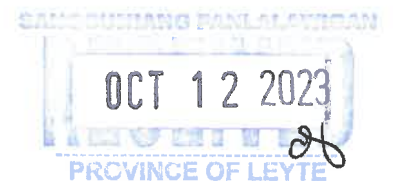



AN ORDINANCE AUTHORIZING THE TEMPORARY ROAD CLOSURE OF JUNCTION NATIONAL ROAD R.V. FULACHE STREET GOING TO M.L. FLORES STREET UP TO THE JUNCTION OF C.V. ALCUINO STREET FOR A PERIOD FROM SEPTEMBER UP TO NOVEMBER, 2023 TO PAVE THE WAY FOR THE ON GOING DRAINAGE CONSTRUCTION IN URBAN HILONGOS

WHEREAS, Section 21 of RA 7160, also known as the Local Government Code of 1991 provides that: Closure and Opening of Roads-

Thus, it is deemed necessary for a Municipal Ordinance be enacted thru a regular session of the Sangguniang Bayan.

BE IT ORDAINED, by the Sangguniang Bayan of Hilongos, Leyte in a regular session assembled that:

SECTION 1. Authority to Close Roads - The Sangguniang Bayan is empowered to temporarily close roads or alleys pursuant to the general powers as stated in Section 21 (a)(c), Chapter II, Book I, Title I, RA 7160, also known as the Local Government Code of 1991 which is as follows:

- a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park or square falling within its jurisdiction; Provided, however that in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all members of the Sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided;
- c) Any national or local road, alley, park or square may be temporarily closed during an actual emergency or fiesta celebration, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order.

SECTION 2. Road to be Temporarily Closed - Effective September, 2023 up to November, 2023 the temporary road closure of Junction National Road R.V. Fulache Street going to M.L. Flores Street up to the Junction of C.V. Alcuino Street to pave the way for the on going drainage construction in Urban Hilongos.

SECTION 3. Administrative Provision - The Office of the Municipal Mayor shall provide the necessary mechanisms in the implementation of this ordinance.

Moreover, it is imperative for the Executive Department to provide necessary traffic signages and safety precautionary measures to protect the riding public motorist and pedestrian.

SECTION 4. Effectivity. This ordinance shall take effect upon approval.




