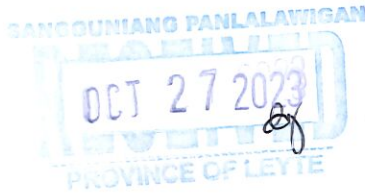

ⁱ Section 17 - Local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated herein.

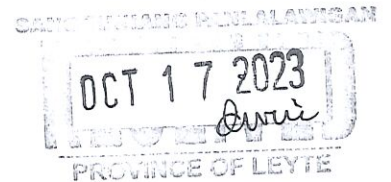

PREFATORY STATEMENT

SECTION 1. Official Hymn

The composition entitled "KANANGA, OUR BEAUTIFUL LAND" shall be hereby adopted as the official hymn of the Municipality of Kananga, Leyte. The lyrics and music of the hymn are attached hereto.



SECTION 2. Mandatory Singing

(a) The official hymn "KANANGA, OUR BEAUTIFUL LAND" shall be sung during all official and formal functions, activities, and programs of the Local Government Unit of Kananga, component barangays and other government agencies, offices within the territorial jurisdiction of Municipality of Kananga.

(b) All employees, officials, and attendees of such events are required to participate in the singing of the official hymn as a mark of respect, unity, and pride for the municipality.

SECTION 3. Penalties for Violations

Any individual or group found to be in violation of the provisions of this ordinance, including the refusal to participate in the singing of the official hymn during the designated events, shall be subject to penalties as provided in the Local Government Code of the Philippines and other relevant laws.

SECTION 4. Effectivity Clause.

This ordinance shall take effect immediately upon its approval and publication in accordance with the law.

MINUTES OF PUBLIC HEARING HELD BY THE SANGGUNIANG BAYAN ON SEPTEMBER 7, 2023 AT THE ABC HALL BUILDING, KANANGA, LEYTE FOR THE FOLLOWING MUNICIPAL ORDINANCES, TO WIT:

1. Ordinance No.23R.23-039 – An Ordinance adopting the “Kananga, Our Beautiful Land” as the official hymn of the Municipality of Kananga, Leyte prescribing its mandatory singing during official and formal functions, activities, and programs of the Local Government Unit of Kananga and providing penalty for violations thereof.
2. Ordinance No.23R.23-040- An Ordinance declaring 2nd Sunday of June of every year as the “Kananga Kaanyag Festival Day” and further declaring it as the highlight presentation of the Kananga Socio-Cultural Activities.

(Attendance hereto attached)

The Public Hearing was conducted by the Office of the Sangguniang Bayan spearheaded by the Office of the Vice Mayor thru Facebook Page and Posting in the public places. The following ordinances was referred to the SB Committee on Tourism chaired by Hon. Allan C. Espinosa. The Public Hearing was attended by the Punong Barangay of the 23 barangays of the municipality with the stakeholders from DEPED District I, II, III Supervisors and KNHS Principal, Representative from District I, Dr. John Kent Juanero, Mr. Allison M. Junio and Mrs. Marivic R. Pajaron, respectively and it was open at 9:40 in the morning with an opening prayer led by Hon. Sabelino Ablen-Punong Barangay of Brgy. Lonoy, and the Pambansang Awit conducted by Hon. Arlene Catingub-Punong Barangay of Brgy. San Ignacio. The SB Secretary Atty. Allan R. Castro acted as the master of the ceremony and presenter of the following ordinances. Before the introductory message of Atty. Castro he give the floor to the Municipal Vice Mayor Honorable Miguel Jorge P. Tan for his Welcome Address.

The first ordinance entitled: “ *An Ordinance adopting the “Kananga, Our Beautiful Land” as the official hymn of the Municipality of Kananga, Leyte prescribing its mandatory singing during official and formal functions, activities, and programs of the Local Government Unit of Kananga and providing penalty for violations thereof.* SB Secretary presented and discussed by section.

Hon. Espinosa(Chairman of the Committee on Tourism) give his thanks to the appearances of the invited guest. He informed that we invited all of you to give your suggestions, concerns, comments and objections, if any, before the sanggunian approved this proposed ordinances.

SB Secretary informed that if there is any suggestions and concerns, you can use our drop box available at the Office of the Vice Mayor. He added to include the provisions “*component barangays and other government agencies, offices within the territorial jurisdiction of Municipality of Kananga*” in Section 2(a).

Mr. Junio asked regarding the lyrics, he said the word “Sagrada Familia” appeared in the video that played recently, however in the presentation there is no more there.

Mr. Sia(Representative from the Tourism Office) answered that the video was uploaded long time and the Tourism Office had made some changes of the lyrics.

Mr. Junio asked the Tourism Office regarding the criteria or basis on making the Hymn.

Mr. Sia answered that the lyrics are originated and idea from Kanangahanons.

Mr. Junio asked any criteria for coming up this Hymn, or guidelines so that we can add or check if there is any missing.

Dr. Juanero answered and explained to what Mr. Allison query, he said that there is no criteria for making a good hymn. He said that he attended a seminar in Commission of Heritage for the purpose and the commission could not give a criteria as long as it is originally composed by your own. He said that he likes very much the lyrics.

The second ordinance entitled: *"An Ordinance declaring 2nd Sunday of June of every year as the "Kananga Kaanyag Festival Day" and further declaring it as the highlight presentation of the Kananga Socio-Cultural Activities.* SB Secretary presented and discussed by section. The following attendees raised their suggestions/questions:

Dr. Juanero asked regarding *Section 2. Fund Allocation - The Local Government Unit of Kananga shall include in its annual investment plan and annual budget of every succeeding year sufficient funds for the socio-cultural celebration of the Kananga Kaanyag Festival.* He informed that in there level it is already included in the Plan as priority of DEPED.

Mr. Junio asked if the barangays can also include this provision of funds in their AIP.

Hon. Gabilan(Punong Barangay of Montebello) answered that it depends the available budget of barangay.

Mr. Junio said that in occasion like this, the financial is their most concern. He hopes that the barangay can allocate funds for them also for the success of this event.

The closing and final message was rendered by Hon. Miguel Jorge P. Tan-Municipal Vice Mayor and public hearing formally ended at 10:25 in the morning.
