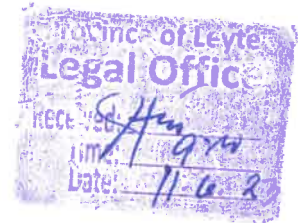

PROVINCE OF LEYTE

Be it ordained by the Sangguniang Bayan of Babatngon, Leyte in session assembled:

Section 1. - Provisional Clause - Section 1 (Scholarship Grant) (b) of Ordinance No. 331 of the Municipal Scholarship Program of the Municipality of Babatngon, Leyte is hereby amended to read as follows:

***Section 1. - Scholarship Grant.**

b.) All high school graduates who receive the award of "with highest honors, highest average rating" from any secondary school within the Municipality of Babatngon, Leyte will automatically be given a grant slot. They shall be exempt from taking the competitive examination as a reward for attaining the highest honors, highest average rating and academic excellence award; Provided that they belong to an indigent family and shall possess the qualifications of a scholarship grantee as enumerated in Section 2 of the scholarship ordinance."

Section 2. Applicability Clause - All other matters relating to the imposition of regulations provided in this ordinance shall be governed by the pertinent provisions of existing laws and other ordinances.

Section 3. Repealing Clause - All ordinances, rules and regulations or parts thereof, in conflict with, or inconsistent with any of the provisions of this ordinance, are hereby repealed or modified accordingly.

Section 4. Effectivity. - This ordinance shall take effect from the date of its posting in conspicuous places in the municipality.



RESOLVED, as it hereby resolves, to adopt Ordinance No. 331 that amends
Sections 1 and 3, Chapter 12, Article A (Municipal Scholarship Program) of Ordinance
No. 281, otherwise known as the Code of General Ordinances of the Municipality of
Babatngon, Leyte.

RESOLVED FURTHER, to enact the following ordinance:

ORDINANCE NO. 331

ORDINANCE AMENDING SECTIONS 1 AND 3, CHAPTER 12,
ARTICLE A (MUNICIPAL SCHOLARSHIP PROGRAM) OF
ORDINANCE NO. 281, OTHERWISE KNOWN AS THE CODE OF
GENERAL ORDINANCES OF THE MUNICIPALITY OF BABATNGON,
LEYTE.

Be it enacted by the Sangguniang Bayan of the Municipality of Babatngon, Leyte
assembled:

Section 1. - Provisional Clause - Sections 1 and 3, Chapter 12, Article A
(Municipal Scholarship Program) of Ordinance No. 281, otherwise known as the Code of
General Ordinances of the Municipality of Babatngon, Leyte is hereby amended to read
as follows:

Section 1. - Scholarship Grant.

There is hereby created a scholarship grant to be known as the Municipal Scholarship

School Year	1996 - 1997 (1st Year)	-	6
	1997 - 1998 (2nd Year)	-	6
	1998 - 1999 (3rd Year)	-	6
	1999 - 2000 (4th Year)	-	6
	And the years thereafter	-	6

In case there are more applicants in excess of the allowable number stated supra, and all have passed the Competitive Examination given by the Municipal Scholarship Committee, there will be no elimination for the Final Screening, if necessary.

✓ Section Year 2012-2013. - All high school valedictorians who graduated from any secondary school within the Municipality of Babatngon, Leyte will automatically be given a scholarship grant slot. They shall be exempt from taking the competitive examination as a reward for earning the highest honors and academic excellence award; provided that they belong to an indigent family and shall possess the qualifications of a scholarship grantee as enumerated in Section 2 of the scholarship ordinance.

Section 3. - The Benefits. - The scholarship shall be for a 4-year college course to a bachelor's degree in any of the government schools or institutions located in the Province of Leyte, covering tuition fees, and all miscellaneous fees such as matriculation, library, medical, dental school publication, laboratory, Officer Training Corps (ROTC-NSTP), guidance and counseling, and extra-curricular activities fees. There shall also be books and school materials allowance of P 1,200.00 per semester, a uniform allowance of P 1,200.00 per school year and an allowance of P 3,300.00 for their living subsidy for every school semester.


Section 2. - Applicability Clause. - All other matters relating to the imposition of the ordinance provided in the ordinance shall be governed by the pertinent provisions of existing laws and other ordinances.

Section 3. - Repealing Clause. - All ordinances, rules and regulations or parts thereof in conflict with, or inconsistent with any of the provisions of this ordinance, are hereby repealed or modified accordingly.

Section 4 - Effectivity - This code shall take effect after ten days from the date of its publication and posting in three conspicuous places in the local government office.
