#### Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the General Fund Supplemental Budget No. 1 CY 2023 of the Municipality of Calubian, Leyte duly enacted by the Sangguniana Bayan through Appropriation Ordinance No. 04, Series of 2023 with a total appropriation in the amount of P5,295,359.78, reveals substantial compliance with the same law and its implementing Rules and Regulations.


