AN ORDINANCE GRANTING CASH INCENTIVES TO CHILD DEVELOPMENT WORKERS (DAY CARE WORKERS) OF THE MUNICIPALITY OF BURAUEN, LEYTE AND PROVIDING FUNDS THEREFOR

WHEREAS, Section 2 (4), Article XIV of the 1987 Philippine Constitution provides that "The State shall encourage non-formal, informal, and indigenous learning systems, as well as selflearning, independent, and out of school study programs particularly those that respond to the community needs";

WHEREAS, Section 2 of RA No. 10410, entitled "An Act Recognizing the Age from Zero (0) to Eight (8) as the First Crucial Stage of Educational Development and Strengthening the Early Childhood Care and Development System, Appropriating Funds Therefor and For Other Purposes" also known as the "Early years Act (EYA) of 2013", states that "the age Zero (0) to Eight (8) years shall be the crucial stage of educational and human development";

WHEREAS, the Municipality of Burauen has 77 Child Development Workers/Teachers (Day Care Workers) educating the toddlers of the 77 barangays;

WHEREAS, Child Development Workers typically work for the families and care for children when the parents or other family members are not available;

WHEREAS, the role of the Child Development Workers may be more focused on the academics to prepare the children for Kindergarten;

WHEREAS, the Municipal Government of Burauen recognizes the Child Development Workers' good work and motivate them to higher accomplishment and performance through providing them incentive;

NOW THEREFORE, on motion of Hon. Cipriano R. Relatorres, Jr., Chairman, Committee on Education, Child Protection and Welfare, duly seconded by all Sangguniang Bayan members present;

BE IT ORDAINED, by the Sangguniang Bayan of Burauen, Leyte, in regular session assembled, that:

SECTION 1 – *Title.* This ordinance shall be known as, "Granting Cash Incentives to Child Development Workers (Day Care Workers) of the Municipality of Burauen, Leyte and Providing Funds Therefor"

SECTION 2 – Declaration of Policy.

- To promote, provide cash incentives and improve the total well-being of the Child Development Workers.
- b. To develop skills and capabilities of the Child Development Workers in order for them to become more responsive and equipped in delivering child care-education service and program in their areas of responsibility.
- c. To encourage all Child Development Workers to become effective partners in the implementations of all child care-education and other literacy-related programs and activities of the municipality.

SECTION 3 – Definition of Terms.

- a. Child Development Worker popularly known as Day Care Worker, he/she is one of those "service providers" engaged in teaching children ages 3-4 years old in the child development centers. He/she extends other early childhood education related services in a particular Barangay.
- b. Child Development Center popularly known as Day Care Center, it refers to a government facility located in every barangay where a Child Development Worker is implementing day care service and other ECCD programs.
- c. Early Childhood Care Development (ECCD) refers to the full range of health, nutrition, early education and social services program that provides basic holistic needs of young children, to promote their optimum growth and development.
- d. Local Council for the Protection of Children (LCPC) a council organized at the provincial, city, municipal and barangay levels that serves as the umbrella organization for all children's concerns.
- e. Accredited Child Development Worker and Child Development Center refers to the bearer of certificates that passed the standards set by the Department of Social Welfare and Development (DSWD) for a more efficient and effective delivery of Day Care Service. Both are interdependent with each other, hence, may either be accredited or not accredited.

SECTION 4 – Duties and Responsibilities.

- 1. The Child Development Worker shall attend the Regular and/or Special Meeting which is done every 3rd Friday of the Month or any day, if necessary.
- 2. During the said meeting/s, Child Development Workers shall bring with them their Session Plans and shall be checked by MSWDO staff, and other documents if deemed necessary.

- 3. The amount of incentives shall depend on the compliance and submission of necessary monthly documents.
- 4. The Child Development Worker's Logbook shall be the basis of the MSWDO staff to check the attendance and compliance of documents.
- 5. Along with the attendance during the Regular/Special Meeting, the Child Development Worker shall present his/her accomplished Monthly Session Plan and Quarterly Evaluation of the Early Childhood Care and Development (ECCD) Checklist for checking.
- 6. No attendance in regular meeting, no session plan presented, "No" Cash Incentive for the month.

SECTION 5 - Incentives.

Indicator/Qualifications	Amount of Incentive per Month
For Accredited Child Development Workers and Child Development Centers with complete monthly attendance and compliance with the documents needed for the month.	₱ 700.00
For Not Accredited Child Development Workers and Child Development Centers, provided, that the Child Development Worker has complete attendance and compliance with the documents needed for the month.	₱ 500.00
For Not Accredited Child Development Workers and Child Development Centers. That the Child Development Worker has incomplete attendance and incomplete documents needed for the month, regardless of the number of meeting/s conducted for the month.	₱ 250.00

SECTION 6 – *Implementing Office*. The Municipal Social and Welfare Development Office shall be the implementing office. The MSWD Officer shall be the over-all in-charge of the implementation. He/she shall formulate the regulations in carrying out the program in accordance with this ordinance, including the staffing.

SECTION 7 – *Funding.* Cash Incentives and Expenses to be incurred in connection with the implementation of this Ordinance shall be charged to the Local Council for the Protection of Children (LCPC) Fund under the Implementing Office.

SECTION 8 – *Manner of Disbursement.* The Disbursement shall be semi-annually, every June and December of the year and shall adhere to accounting and auditing rules and regulations.

SECTION 9 – *Repealing Clause.* All ordinances, resolutions, executive orders and all other issuances inconsistent herewith are deemed to be repealed or modified accordingly.

SECTION 10 - Separability Clause. If any of the provisions of this ordinance is declared invalid and unconstitutional, other parts or provisions hereof shall continue to be in full force and effect.

SECTION 11 - Effectivity Clause. This ordinance shall take effect upon its approval.
