



MUNICIPAL ORDINANCE NO. 45, S-2023-2025

AN ORDINANCE REGULATING THE APPLICATION TO LEASE MARKET STALLS AND IMPOSING FEES THEREOF

EXPLANATORY NOTE

The Local Government Code of 1991 states that, each local government unit shall exercise its power to create its own sources of revenue and to levy fees and charges subject to the provisions of the Code which shall accrue exclusively to the local government unit consistent with the basic policy of local autonomy.

It is a declared policy of the Local Government Unit of Villaba to promote and improve its capabilities to deliver desired public services and ensure the safety, comfort and well-being of vendors and the buying public as well.

The Sangguniang Bayan was tasked by the Local Chief Executive to pass an Ordinance for the imposition of stall rights in the newly constructed 20 stalls at Building No. 10 in the Municipal Public Market relative to Municipal Ordinance No. 18, S-2022-2025.

Hence, the passage of this ordinance.

C H A P T E R I GENERAL PROVISION

SECTION 1. – TITLE. This ordinance shall be known as the "Regulation for the Application to Lease Market Stalls in Villaba."

SECTION 2. – SCOPE. The ordinance shall govern all public market stalls in Building 10 which is owned and managed by the Municipality of Villaba.

SECTION 3. – POLICY. It is the policy of the Local Government Unit of Villaba to promote and improve its capabilities to deliver desired public services and ensure the safety, comfort and well-being of vendors and the buying public as well.

SECTION 4. – DEFINITION OF TERMS. As used in this Ordinance, the following terms are defined as follows:

- a. Public Market refers to any structure building or place of any kind which have been established, designated, or authorized by the Municipal Council, whether government or privately-owned and operated dedicated to the service of the general public where basic food items and other commodities are displayed and offered for sale.
- b. Market Stalls refers to any allocated space, stand, compartment, store or any place wherein merchandise is sold, offered for sale, or intended for such purpose in the public market.
- c. Stallholder refers to the awardee of a definite space or spaces within a public market who pays a rental fee thereof for the purposes of selling his/her goods or commodities or service.
- d. Lease/Award refers to the document that grants to lessee/tenant the right to occupy the stall. Lease or award as a term may be used interchangeably and shall mean the same.
- e. Stall Rights Fee refers to the fee paid to and collected by the Municipal Government thru the Municipal Treasurer's Office for the rights and privilege of using the stalls in building 10.

SECTION 5. – APPLICATION. Filipino citizens who are actual residents of the Municipality of Villaba shall be given preference in the award of public market stalls. All application to lease or rent shall be filed to the Office of the Municipal Treasurer in a form prescribed herein.

A Stall Rights Fee of Ten Thousand Pesos (Php 10,000.00) shall be collected to cover the necessary expenses relative to the award and lease of the stall and any excess thereof shall form part of the general fund.

The application form to be issued by the Municipal Treasurer's Office shall be in the following form which shall be made under oath:

Should the above-mentioned stall be awarded to me for lease in accordance with Municipal Ordinance No. 18, S-2022-02025, other ordinances, rules and regulations, I promise to hold the same under the terms and conditions of the contract of lease and subject to the following undertakings:

- (2) That I shall keep the stall at all times in good, clean and sanitary condition and comply strictly with all market rules and regulations on sanitation now existing or which may hereafter be promulgated;
- (3) That I shall pay the corresponding application and market stall fees for the stall in the manner prescribed in this Ordinance or in other pertinent ordinances;
- (4) That I shall not sell or transfer my rights or privilege to lease the stall, or otherwise permit other persons to conduct business therein.

Any violation on my part to any of the undertakings shall be a sufficient cause for market administrator to cancel or revoke the contract of lease to be executed in may favor.

SECTION 6. - DURATION OF REGULAR LEASE. Any awarded lease in any form upon approval of this Ordinance shall be five (5) years renewable contract subject to review by the Market Administrator, who will determine if the conditions of the lease/award are faithfully complied with by the stallholder/awardee during his last five (5) years preceding the contract. In case of violations, said stall shall be declared vacant and will be declared available for occupancy to any new qualified applicant.

SECTION 7. -PROHIBITION OF THE TRANSFER OF RIGHTS. No lessee of any market shall convey, transfer, assign, mortgage, encumber or in any other manner dispose of his rights or interests thereto during the term of the contract. Any person other than the lessee, his helpers or registered partner/s or in case of death, the lessee's surviving spouse or legal heir, found selling in the leased premises shall be prima facie evidence of transferring or sub-leasing. Such shall be a ground for the outright revocation of the contract of lease.

SECTION 8. - INSURANCE. The lessee shall not take any fire insurance on properties within the leased premises without first securing a written approval from the Market

For this purpose, the lessee shall submit beforehand an inventory of the property or goods within the leased premises to be insured, subject to the inspection, review and verification by the Municipal Government through its duly authorized representatives.

SECTION 9. - FORFEITURE OF RIGHTS. Failure to occupy an awarded stall within sixty (60) days from the date of award shall mean automatic forfeiture of the right to lease the stall.

SECTION 10. - REPEALING CLAUSE. Any Ordinances which are in conflict with any provisions of this ordinance, are hereby repealed or modified accordingly.

SECTION 11. - SEPARABILITY CLAUSE. If, for any reason, any section or provision of this ordinance shall be held to be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other sections or provisions thereof.

SECTION 12. - DATE OF EFFECTIVITY. This Ordinance shall take effect upon its approval.

APPLICANTS TO LEASE BUILDING 10 OF THE PUBLIC MARKET

In the proposed ordinance, the indicated stall rights fee which must be paid prior to the occupation is Php 10,000.00 and there will be an application letter which will be submitted to the Treasurer's Office that needs to be filled up and notarized. Here, the applicants suggested to reduce the rental to 7,500.00 due to the competition in the market. However, the Hon. Umpad explained the rationale on why PHP 10,000.00 is beneficial for both the Local Government Unit and to the lessees. Eventually, the applicants agreed to the said rate as indicated in the proposed ordinance.

On the other hand, the applicants also raised their concerns about the garbage collection because the collector failed to announce or inform them as to the schedule of their collections, which the Presiding Officer took notice.

Eventually, the applicants agreed to the said rate as indicated and to all other provisions in the proposed ordinance.

The Committee Hearing ended at 11:00 in the morning.

No other matters were discussed.

The committee hearing was adjourned at 11:00 in the morning.
