RESOLUTION REQUESTING THE HONORABLE MEMBERS OF THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF LEYTE FOR RECONSIDERATION FOR THE APPROVAL OF MUNICIPAL ORDINANCE NO. 443 ENACTED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF BABATNGON LEYTE LAST SEPTEMBER 11, 2023, RE: RECLASSIFICATION OF LANDS COVERING AN AREA OF 83. 5799 HECTARES, FROM AGRICULTURAL TO INDUSTRIAL ACQUIRED BY AGRI VENTURES CORPORATION OF TACLOBAN CITY LOCATED AT BRGY. SAN AGUSTIN AND BRGY. TAGUITE, BABATNGON, LEYTE.

WHEREAS, the 83.5799 Hectares of Agricultural land was acquired by Agri Ventures Corporation of Tacloban City from several private individual owners;

WHEREAS, said 83.5799 hectares of agricultural land was not even developed since 1901 up to present for the period of 122 years, the very reason that the owners of said property given up and sell said properties considering that it is no longer productive and they could not even pay real property taxes for every year;

WHEREAS, for economic growth and development of LGU Babatngon, Leyte, the Sanggunlang Bayan was convinced to enact an ordinance reclassifying such 83.5799 hectares of lands from agricultural into industrial, in giving higher economic value and consideration for the benefits of the constituents of said barangays where the property was located;

WHEREAS, the property owner and the company proponent for the establishment of solar power plant and the LGU Babatngon, Leyte humbly request the Sangguniang Panlalawigan of the Province of Leyte, particularly the Honorable Members of the committee concern to give chance to discuss and present needed requirements from the proponent and the LGU Babatngon, Leyte and giving consideration for the welfare of the people of the Municipality of Babatngon, Leyte hardly aspiring to uplift its people from poverty;

WHEREAS, one among the ordinances submitted by the sangguniang bayan of Babatagon, Leyte was Ordinance No. 429 reclassifying agricultural land to industrial with an area of 4,000 square meters located at Brgy. Bacong, Babatagon, Leyte, portion of almost 7 has. Agricultural land also covered by CARP Program Intended for establishment of Palm Oil depot /factory.

WHEREAS, considering that 9 lots out of the 15 lots proposed to be reclassified are under CARP, the remaining 6 lots should have been declared valid and issued a separate SP Resolution;

WHEREFORE, on motion of the Honorable Federico P. Elizaga, Jr., duly seconded in mass, be it

RESOLVED, as it hereby resolves, to request the Honorable Members of the Sangguniang Panialawigan of the Province of Leyte for reconsideration for the approval of Municipal Ordinance No. 443 enacted by the Sangguniang Bayan of the Municipality of Babatngon, Leyte last September 11, 2023, re: reclassification of lands covering an area of 83. 5799 hectares, from Agricultural to Industrial acquired by Ventures Corporation of Tacloban City located at Brgy. San Agustin and Brgy. Taguite, Babatngon, Leyte.

RESOLVED FURTHER, to forward copies of this resolution to the Sangguniang Panlalawigan of Leyte for their information and consideration.
