#### Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 3 CY 2023** of the **Municipality of Dulag, Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 2023-III** with a total appropriation in the amount of **P4,990,827.87** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the reversion of funds taken from 2014-2022 Development/Continuing Programs and Projects is duly certified as savings which is not restricted by law or other obligations and are made available to support the capital expenditures under Supplemental No. 3;
- 2. That the expenditures under this budget shall be incorporated in the Investment Program.
- 3. That the procurement Goods, Supplies, Civil Works and related services shall be made pursuant to RA 9184 and its Implementing Rules and Regulations; and
- 4. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances and accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.
