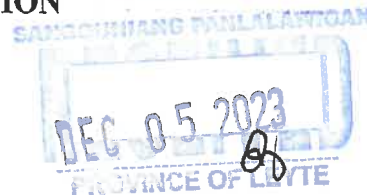

**NOTICE OF HEARING**

Applicant, **CHRISTIAN MUSIC POWER, INC.**, a 100% Filipino domestic corporation duly organized and existing under and by virtue of Philippine Laws, registered with the Securities and Exchange Commission (S.E.C.), and a grantee of a legislative franchise under R.A. No. 11580, requests for the issuance of a **Certificate of Public Convenience (CPC)** to install, operate and maintain FM Radio Broadcast Station in **VILLABA, LEYTE**.

Applicant, further requests for the issuance of a **Provisional Authority (PA)** pending final determination of the application.

In view thereof, this will be heard by this Commission on **DEC. 06, 2023, (Wednesday) at ten thirty in the morning (10:30 A.M.)** at the Legal Branch, 3<sup>rd</sup> Floor, NTC Building, National Telecommunications Commission, BIR Road, East Triangle, Diliman, Quezon City, via zoom hearing; wherein applicant shall present its compliance with the Commission's jurisdictional requirements, as well as its evidences, if warranted.

In lieu of face to face hearing, a virtual hearing shall be conducted. A link to join the virtual hearing will be sent to your e-mail address on the same day of hearing at least 15 minutes before the scheduled time. In connection to this, you are hereby ordered to send your e-mail address through **legal@ntc.gov.ph** and **secretariat@ntc.gov.ph**.


However, should the hearing date be declared a holiday or non-working day due to force majeure, the said hearing shall be held on the NEXT regular working day.

At least fifteen (15) days prior to the date of hearing, applicant shall publish this Notice of Hearing in a newspaper of general circulation in the Philippines. This Notice, as well as the copy of the application shall also be served by registered mail or through personal delivery to all listed affected parties.

Any party opposed to the granting of the application is hereby directed to appear at the scheduled hearing and must file its verified opposition, on or before the date of hearing, furnishing the applicant with a copy of the same. Failure on the part of any affected party to file its opposition on time and to appear at the scheduled hearing shall be construed as a waiver of its right to be heard and the Commission shall proceed to hear and decide the application on its merit.

**APPLICATION**

COMES NOW, Applicant, Christian Music Power, Inc. (CMPI) by and through undersigned counsel, and unto this Honorable Commission, respectfully states, that:

1. Applicant CMPI is a domestic corporation duly organized and existing under Philippine laws, with Company Reg. No. 186899 and virtual office address at 76 Fatima Lane St., La Milagrosa Village, Marikina Heights, Marikina City.

Attached as an integral part of this application are copies of CMPI's Certificate of Filing of Amended Articles of Incorporation, Amended Articles of Incorporation and By-Laws, hereto marked as Annex "A", "A-1" and "A-2, respectively, and submitted as proof of its juridical personality and capacity.

2. CMPI is wholly-owned and managed by Filipino citizens; its primary purpose is "to acquire, own, lease, rent and operate radio broadcasting stations, with any and all types of transmission facilities to apply for, receive and hold all licenses that may be necessary or required from any licensing agency, national or municipal; to do any all things necessarily incident to the operation of such broadcasting stations, including but not limited to contracting for transmission of programs and entering into such other contracts as the board of directors of the corporation may, from time to time, deem proper and expedient."<sup>1</sup>
3. It is a grantee of a Congressional Franchise to construct, establish, operate and maintain radio broadcasting stations in the Philippines by virtue of Republic Act (R.A.) No. 11580<sup>2</sup>; a copy of which is hereto attached as Annex "B".

10. CMPI warrants the observance of all applicable laws, technical and programming standards, and such rules and regulations pertaining to the operation of the proposed radio station in a proper and suitable manner.
11. It is humbly submitted that the approval of this application will serve public interest and necessity for radio remains to be a valuable tool for information dissemination, entertainment, and worship, particularly in the provinces.
12. In the best interest of the service, it is respectfully prayed that the instant application for CMPI to install, operate and maintain a commercial, religious, and educational FM radio station in Villaba, Leyte be given due consideration and immediate action.

### PRAYER

WHEREFORE, it is respectfully prayed that, after due notice and hearing, that the application of Christian Music Power, Inc. for a Certificate of Public Convenience to install, operate and maintain an FM radio broadcasting station in the municipality of Villaba, Province of Leyte be GRANTED.

OTHER RELIEFS JUST AND EQUITABLE IN THE PREMISES ARE LIKEWISE PRAYED FOR.
