<sup>&</sup>lt;sup>1</sup> (viii) Determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs. projects, services, and activities of the municipal government;

<sup>&</sup>quot; (a) The total appropriations, whether annual or supplemental, for personal services of a local government unit for one (1) fiscal year shall not exceed forty-five percent (45%) in the case of first to third class provinces, cities and municipalities, and fifty-five percent (55%) in the case of fourth class or lower, of the total annual income from

regular sources realized in the next preceding fiscal year. The appropriations for salaries, wages, representation and transportation allowances of officials and employees of the public utilities and economic enterprises owned, operated, and maintained by the local government unit concerned shall not be included in the annual budget or in the computation of the maximum amount for personal services. The appropriations for the personal services of such economic enterprises shall be charged to their respective budgets;

(g) The creation of new positions and salary increases or adjustments shall in no case be made retroactive;

**SECTION 1 – Title of the position – There shall be created the following plantilla positions** and salary grades in various offices of the Local Government Unit of Tunga.

- a. Municipal Agriculture Office Agriculturist II, SG-15
- b. Municipal Environment and Natural Resources Office Environmental Management Specialist II, SG 15
- c. Municipal Engineering Office **Draftsman I, SG-6**

SECTION 2 —Functions, Duties and Responsibilities — The various plantilla positions shall have their respective following functions, duties, and responsibilities:

  - **b.** Acts as team leader/member in the conduct of field surveys/monitoring of the different programs and activities.

**c.** Assists the Municipal Agriculturist in the organization of statistical data and submission of necessary reports, and recommendations and perform other related jobs as may be required.

#### 2. Environmental Management Specialist II, SG 15

- a. Assist the MENRO in monitoring of SWM of the different barangays, and commercial and industrial establishments within the municipality.
- **b.** Prepares and consolidates SMR-CMR for submission to the national Agencies.
- c. Receives and records incoming and outgoing communications and reports.
- **d.** Prepares information and education campaigns on environmental awareness, management, conservation, and protection.
- e. Facilitates and coordinates meetings, learning events, and seminars.
