

Dear Vice Governor,

Warm Christian greetings.

The Local Government Unit (LGU) of Baybay City submitted to your good Office last **02 August 2023**, for review and consideration, **Appropriations Ordinance No. 1, S-2023**. The subject ordinance pertains to the **supplemental budget** of the LGU for Calendar Year 2023 amounting to Php 159,240,307.57. Last **27 October 2023**, the *Sangguniang Panlungsod* of this City received a copy of the *Sangguniang Panlalawigan's* Resolution No. 2023-442 directing the return of the subject Appropriation Ordinance to the City *Sanggunian* for compliance with the findings and recommendations of the Local Finance Committee (LFC). The LFC Report enumerated therein several items which they believed needed rectification from the LGU.

Under Paragraph 2 of Section 327 of the Local Government Code (LGC), the reviewing *Sanggunian* is given a period of ninety (90) days within which to review the said ordinance and declare the same to be valid or inoperative in its entirety or in part. However, upon perusal of Resolution No. 2023-442 of the *Sangguniang Panlalawigan*, we noted that there was no adverse declaration on the subject Appropriations Ordinance. There was also no advice to the Local Chief Executive (LCE) from your Office or from the LFC regarding the ordinance under review as mandated by **Section 327 of the LGC.** This adverse declaration or advice is a requirement provided for by law in order to suspend the effectivity of the subject Appropriations Ordinance.

It must be emphasized that **Section 320 of the same Code** explicitly provides that "an ordinance enacting a supplemental budget, however, shall take effect upon its approval or on the date fixed therein". The subject Appropriations Ordinance is a supplemental budget of the City for this calendar year 2023 for the items enumerated therein. Without the adverse declaration of the *Sangguniang Panlalawigan* and without the proper advice as mandated under Section 327 of the LGC, the subject Appropriations Ordinance No. 1, S-2023 shall continue to be in full force and effect as



provided for under Paragraph 2 of Section 327 of the LGC. Moreover, without this adverse declaration or advice, the said ordinance is deemed to have been reviewed in accordance with law. We are of the opinion that the effectiveness of the LGU's supplemental budget is not contingent on the approval or denial of the reviewing *Sanggunian*. It may be suspended only if there is an adverse declaration by the reviewing *Sanggunian* or advice to the LCE, which is absent hereof.

Nevertheless, we deem it proper to answer all the items discussed in the LFC Report. We find that the grounds cited by the LFC are still not enough to prevent the subject ordinance from being operative. Discussed hereunder, in *seriatim*, are our answers to the findings of the LFC, to wit:

1. The first item in the LFC findings. It would appear that the LFC recommended the deferment of the appropriations for the appointive positions at the City Mayor's Office (CMO), the City Agriculture Office (CAO), and the City Treasurer's Office (CTO). The LFC opined that mandatory positions should first be created prior to the creation and funding of such optional positions in line with CSC Memorandum Circular No. 12, S-2022.

The LGU respectfully begs to disagree with this finding of the LFC. The LGU believes that CSC MC No. 12 does not apply to positions already created prior to the issuance of the said circular.

The ordinance in support of the creation of the positions mentioned in the subject supplemental budget was enacted by the City *Sanggunian* on **11 October 2022** under **City Ordinance<sup>1</sup> No. 07**, **S-2022**. In fact, this *Sangguniang Panlalawigan* had already passed **Resolution<sup>2</sup> No. 2023-012** dated **10 January 2023** approving and declaring as valid City Ordinance No. 07, S-2022.

The CSC circular relied upon by the LFC took effect on **03 November 2022**. These **optional positions of the LGU were created prior to the effectivity of CSC MC No. 12**. Thus, the said CSC MC No. 12 does not **apply to City Ordinance No. 07**, S-2022. The said MC has no retroactive effect that will bind the LGU in the creation of these appointive positions funded in the subject ordinance. Even so, the LGU has designated employees already of the LGU to concurrently act as its Public Employment Service Office Manager, its City Senior Citizens Affairs Head, and its City Tourism Officer.<sup>3</sup>

It must be stressed that in so far as the creation of mandatory and optional positions in the Local Government Unit, **Section 454** of the LGC governs.

"SEC. 454. Officials of the City Government. - (a) There **shall** be in each city a mayor, a vice-mayor, sangguniang panlungsod members, a secretary to the sangguniang panlungsod, a city treasurer, a city assessor, a city accountant, a city budget officer, a city planning and development coordinator, a city engineer, a city health officer, a city civil registrar, a city administrator, a city legal officer, a city veterinarian, a city social welfare and development officer, and a city general services officer.

(b) In addition thereto, the city mayor **may** appoint a city architect, a city information officer, a city agriculturist, a city population officer, a city environment and natural resources officer, and a city cooperatives officer. The appointment of a city population officer shall be optional in the city: Provided, however, That cities which have existing population offices shall continue to maintain such offices for a period of five (5) years from the date of the effectivity of this Code, after which said offices shall become optional. XXXX\*

On the other hand, the national laws that were made legal basis in CSC MC No. 12 in the creation of the six (6) listed mandatory positions are as follows:

- a. The City Agricultural and Biosystems Engineer (RA 10915)
- b. The City Cooperative Development Officer (RA 11535)
- c. The City Persons with Disability Affairs Office (RA 10070)
- d. The City Public Employment Service Office Manager (RA 10691)
- e. The City Senior Citizens Affairs Head (RA 9994)
- f. The City Tourism Officer (RA 9593)

From the foregoing, it is noteworthy to mention that among the six (6) laws mentioned above, only RA 11535 specifically amended Section 454 of the LGC. Section 2 of RA 11535 provides that:

**"Section 2.** Section 454, Book III, Title Three, Chapter 2 of Republic Act No. 7160, is hereby amended to read as follows:

"SEC. 454. Officials of the City Government. - (a) There **shall** be in each city a mayor, a vice-mayor, sangguniang panlungsod members, a secretary to the sangguniang panlungsod, a city treasurer, a city assessor, a city accountant, a city budget officer, a city planning and development coordinator, a city engineer, a city health officer, a city civil registrar, a city administrator, a city legal officer, a city veterinarian, a city social welfare and development officer, and a city general services officer. **A city CDO shall also be appointed**: *Provided*, That the city has the **option** to appoint a full-fledged CDO or merge such position to an existing position or official in a related office, unit or department in the city government: *Provided*, further, That if the city



shall appoint a full-fledged CDO, the city has the option to set the rank, remuneration and other emoluments of the city CDO subject to existing laws, rules and regulations.

(b) In addition thereto, the city mayor may appoint a city architect, a city information officer, a city agriculturist, a city population officer, and a city environment and natural resources officer. XXX\*\*

However, even if there is an express amendment of Section 454, still RA 11535 provides only for an **option** of the LGU to appoint a City Cooperative Development Officer (CDO) as provided under Paragraph 1, Section 2 of RA 11535. As to the other five (5) laws, there is no express amendment or repeal of Section 454 of the LGC. Instead, it merely provides for a general repealing clause to the effect that all laws, decrees, executive orders, and other administrative issuances and parts thereof that are inconsistent with the provisions of these laws are hereby modified and/or superseded. With these general repealing clauses, there arises a legal question as to whether or not the other five (5) laws supersede the express provision of the LGC.

It is our humble opinion that the Local Government Code of 1991, being a special law that deals exclusively with local government units and outlining therein its powers and functions in accordance with the constitutional mandate of local autonomy, controls, and is superior to the other five (5) laws mentioned above. Thus, the five "mandatory" positions mentioned in CSC MC No. 12 cannot defeat the specific provision of the LGC to create offices mandated by Section 454 thereof and to "create such other offices as may be necessary to carry out the purposes of the city government."<sup>4</sup>

Moreover, it bears to note that one of the key considerations in the creation of these mandatory positions is that the LGU must have the corresponding budget thereof, duly approved by the *Sanggunian*, in order to be considered valid. As of this writing, the LGU has no approved budget yet for the mandatory positions identified by the LFC.

2. As to the second item in the LFC findings, the documents submitted to the Sangguniang Panlalawigan for review and consideration already include therein a copy of City SP Resolution No. 20230-274 dated 06 July 2023 which granted authority to our LCE for the reversion of the continuing balances from the capital outlay of the Sangguniang Panlungsod Office for Calendar Year 2020, 2021 and 2022. This is the document that supports the expenditures in the subject supplemental budget ordinance.

- **3. As to the third item in the LFC findings**, it bears to emphasize that the **Statement of Supplemental Appropriation** (LBP Form No. 9) submitted to the **Sangguniang Panlalawigan** complies with the reference coding structure prescribed in the Budget Operations Manual for the LGU.
- 4. As to the fourth item in the LFC findings, the City Budget Officer inadvertently failed to provide the account code for the item "Poverty Mitigation (AICS)". As such, attached hereto as Annex "C" is the amended Statement of Supplemental Appropriation (LBP Form No. 9) depicting the account code for the item "Poverty Mitigation (AICS)".
- **5. As to the fifth item in the LFC findings**, the LGU is fully aware of the CSC Guidelines and Budget Circular No. 2016-2 in the appropriation for additional Terminal Leave Benefits/ Monetization of Leave Credits. The City LGU is obligated to comply with these guidelines.
- **6. As to the sixth item in the LFC findings**, the appropriations for *Personnel Services* (Object of Expenditures) of the various appointive positions in the CMO, CAO and the CTO were based on the computation covering the period of July 2023 to December 2023 as per the Budget Operations Manual for the LGU.
- **7. As to the seventh item in the LFC findings**, the City LGU is obligated to comply with all the laws and issuances relative to the granting of Performance Based Bonus for the Fiscal Year 2023.
- **8. As to the eighth item in the LFC findings,** the City LGU is obligated to comply with all the laws and issuances relative to the procurement of goods, supplies, civil works, and related services.
- **9. As to the ninth item in the LFC findings,** the City LGU is obligated to comply with all the laws and issuances relative to the disbursement of funds for specific purposes.

From the above-mentioned disquisitions, the deferment of our supplemental budget under **Appropriation Ordinance No. 1, S-2022** has no legal basis to stand on. Aside from the fact that there was no adverse declaration from the reviewing *Sanggunian* on the ordinance in review that would have stall the implementation of the said ordinance, the grounds cited by the LFC are still, not sufficient enough to warrant the suspension of the implementation of the subject appropriations ordinance.

Foregoing considered, the City LGU, through the *Sangguniang Panlungsod*, hereby **REQUEST** that **City Appropriation Ordinance No. 1, S-**



**2022** be **formally and officially** declared as valid and operative as the same is within the powers vested in the LGU.

Other reliefs are likewise prayed for.



Thus, the excess PS expenditure appropriations of Year-end Bonus, Retirement & Life Insurance Premium, Philhealth Contributions & Employees Compensation Premiums in the total amount of P202,687.87 shall not be disbursed and shall be reverted back to the unappropriated surplus/balance.

- 7. That the grant of Performance Based Bonus(PBB) for the Fiscal Year 2023 to officials and employees shall be in accordance to Memorandum Circular No. 23 dated August 22, 2023 under Executive Order No. 80;
- 8. That the procurement of Goods, Supplies, Civil Works and related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations, and
- 9. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit";

**WHEREAS**, the August Body, upon review, deem it proper to return to the Sangguniang Bayan of origin the subject Supplemental Budget and Appropriation Ordinance, for compliance with the Local Government Code of 1991 and its Implementing Rules and Regulations;

**NOW THEREFORE**, on omnibus motion presented by Atty. Carlo P. Loreto, duly seconded by Atty. Ronnan Christian M. Reposar, be it

RESOLVED, as it is hereby resolved, TO RETURN TO THE SANGGUNIANG BAYAN OF CALUBIAN, LEYTE APPROPRIATION ORDINANCE NO. 03 AND TO THE SANGGUNIANG PANLUNGSOD OF BAYBAY CITY GENERAL FUND SUPPLEMENTAL BUDGET NO. 01 CY 2023, FOR COMPLIANCE OF THE FINDINGS OF THE LOCAL FINANCE COMMITTEE.

WHEREAS, Section 76 of RA7160, otherwise known as the Local Government Code of 1991, provide that every local government unit shall design and implement its own organizational structure and staffing pattern, taking into consideration its service requirement and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 458 (a) of the same code (RA 7160) also provides that Sangguniang Panlungsod is empowered to determine the positions, salaries, wages and other emoluments and benefits of officials and employees, wholly or mainly from the city funds and provide for the expenditures necessary for the proper conduct of programs, projects, services and activities of the city;

WHEREAS, the Local Chief Executive manifested the city's endeavour to improve its organizational structure and staffing pattern and requested for the creation of the new plantilla positions to provide efficient delivery of services to the Baybayanon constituents.

WHEREFORE, on motion of Honorable Romulo B. Alcala, and duly seconded by the majority of the council members present,

BE IT ORDAINED, by the 6th Sangguniang Panlungsod of Baybay, during its 14th regular session assembled, on October 11, 2022, an ordinance is hereby adopted, to wit:




SECTION IV. Separability Clause. The provisions of this Ordinance are hereby declared separable and if one or more provisions are held invalid, or unconstitutional, the remaining provisions hereof are not affected and shall remain valid and in full force and effect.

SECTION V. Repealing Clause. All ordinances, rules and regulations, or parts thereof, the provision of which are in conflict with or contrary to, the provision of this Ordinance are hereby repealed, amended and modified accordingly.

SECTION VI. Effectivity Clause. This Ordinance shall take effect after due compliance with all the requirements provided under RA 7160, otherwise known as the Local Government Code of 1991.

By virtue of the authority vested in me as the City Mayor of Baybay City, Leyte, pursuant to Section 6 of R. A. 9994 otherwise known as the Expanded Senior Citizens Act of 2010, you are hereby appointed as the Head of the Office of the Senior Citizens Affair (OSCA) in the City of Baybay.

As the Head of the said office (OSCA), you are to perform the following functions, to wit:

- 1. In consultation with the City Social Welfare and Development Officer, and duly registered senior citizen organizations, to plan, develop, implement, consolidate and monitor yearly work programs in pursuance of the objectives of R.A. 9994 and its Rules;
- To draw up a list of available and required services which can be provided by the registered federations and associations of senior citizens;
- To maintain and regularly update on a quarterly basis the list of senior citizens and to issue national individual uniform individual identification cards and purchase booklets, free of charge, which shall be valid anywhere in the country;
- To serve as a general information and liaison center for the needs of the senior citizens;
- 5. To monitor compliance of the provisions of this act particularly the grant of special discounts and privileges to senior citizens;
- To report to the mayor, an individual, establishments, business entity, institutions or agency found violating any provision of this act;
- To facilitate the creation of a city coordinating and monitoring board consisting of the OSCA Head, the City Social Welfare and Development Officer, and the presidents of concerned duly registered senior citizen organizations to deliberate and act on complaints;
- 8. To assist the senior citizens in filing complaints or charges against any individual, establishments, business entity, institution, or agency refusing to comply with the privileges under this act before the Department of Justice (DOJ), the Provincial Prosecutor's Office, the regional or the municipal trial court, the municipal court in cities, or the municipal circuit trial court.
- 9. To assist and coordinate with the concerned person, natural or juridical, establishments, agencies in investigating fraudulent practices and abuses of the privileges granted to senior citizens;
- 10. To establish linkages and work together with the accredited NGOs, people's organizations, and the barangays in their respective areas; and
- 11. To do other acts as may be ordered by the City Mayor in relation to his office.

In addition to your duties stated above, you shall be assisted by the City Social Welfare and Development Officer, and shall report to the Office of the Mayor which shall exercise supervision over the OSCA relative to its plans, activities, and programs for senior citizens.

As Head of the OSCA, you shall be entitled to receive an honorarium in accordance with R.A. 9994 and its Rules to be approved by the local government, and in accordance with the rules and regulations of the Commission on Audit.

This office order shall take effect immediately and shall remain in full force and effect for a period of three (3) years without reappointment but without prejudice to an extension if exigency so requires.
