Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 3 CY 2023** of the **Municipality of Babatngon, Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 442** with a total appropriation in the amount of **P12,660,858.50**, reveals compliance with the same law and its implementing Rules and Regulations.

- 2. That the procurement of Civil Works and other related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations;
- 3. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances and COA procedures and all other existing laws shall be the responsibility of the implementing Local Government Unit.

SECTION 1. – The Supplemental Budget No. 3 of the Municipality of Babatngon, Leyte for Fiscal Year 2023 of the General Fund in the total amount of TWELVE MILLION SIX HUNDRED SIXTY THOUSAND EIGHT HUNDRED FIFTY-EIGHT PESOS AND 50/100 (P 12,660,858.50) is hereby approved.

The Supplemental Budget No. 3 documents consisting of the following are incorporated herein and made integral part of this Ordinance:

- Certification of Availability of funds signed by the Municipal Treasurer and Municipal Accountant.
- Statement of Funding Sources signed by the Municipal Treasurer & Municipal Accountant
- Statement of Supplemental Appropriations prepared by the Municipal Budget Officer and approved by the Municipal Mayor.

SECTION 2. Sources of Funds. The sources of funds for Supplemental Budget No. 3 in the total amount TWELVE MILLION SIX HUNDRED SIXTY THOUSAND EIGHT HUNDRED FIFTY-EIGHT PESOS AND 50/100 (P 12,660,858.50) shall be from Unutilized amount of 20% LDF 2022.

SECTION 3. Use of Funds. The amount of PhP 12,660,858.50 is hereby appropriated for Supplemental Budget No. 3, FY 2023 of the Municipality of Babatngon, Leyte.

SECTION 4. Separability Clause. If, for any reason, any section or provision of this Appropriation Ordinance is disallowed is declared invalid or unconstitutional, other sections or provisions therereof that are not affected thereby shall continue to be in full force and effect.

SECTION 6. Effectivity. This ordinance shall take effect upon approval.
