312	Mr. Chair, this is an Ordinance declaring the water ways of Arabunog River,
313	Pongso River and Himanglos River traversing several Barangays of Barugo to be
314	excluded from the application for Quarry Concessions. The Provincial Legal Office

315	rendered an opinion that it is a valid exercise of the powers of the Sangguniang Bayan
316	However, this representation would like to take exception to that, Mr. Chair. The power
317	to grant the quarry concessions is lodged with the Sangguniang Panlalawigan. So, the
318	Sangguniang Bayan cannot be literally declaring certain areas as it is beyond their
319	scope. It is the power of the Sangguniang Panlalawigan as this is mandated by the
320	Local Government Code. This is a National Law RA 7160.
321	On that note, Mr. Chair, I move that we pass a resolution declaring this
322	Ordinance as ultra vires, as it is beyond the power of any Sangguniang Bayan to dives
323	the Sangguniang Panlalawigan of authority to grant quarry concessions directly o
324	indirectly. I so move.
