

A RESOLUTION ENACTING AN ORDINANCE: ORDINANCE TO IMPLEMENT THE COUNTERPART MUNICIPAL AWARD AND TO FACILITATE THE PROGRAMS FOR CENTENARIANS AND SENIOR CITIZENS AT LEAST NINETY YEARS OLD, GRANT BENEFITS AND SPECIAL PRIVILEGES, AND FOR OTHER PURPOSES.

WHEREAS, cognizant of ARTICLE 100 par. 5, sub-par. (xvii) of IRR of RA No. 7160 which provides in part, that the Sangguniang Bayan, as the legislative body of the municipality, shall approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities, and in addition to said services, shall appropriate funds to support programs and projects for the benefit of the elderly;

WHEREAS, consonant to and with urgency considering the fragile condition of these Centenarians,

WHEREFORE, the Sangguniang Bayan of Tanauan, Leyte, and on motion of Hon. Maria Martina L. Gimenez, and with the unanimous accord of the rest of the Members present;

RESOLVED, AS IT IS HEREBY RESOLVED, TO ENACT AN ORDINANCE: ORDINANCE TO IMPLEMENT THE COUNTERPART MUNICIPAL AWARD AND TO FACILITATE THE PROGRAMS FOR CENTENARIANS AND SENIOR CITIZENS AT LEAST NINETY YEARS OLD, GRANT BENEFITS AND SPECIAL PRIVILEGES, AND FOR OTHER PURPOSES, TO WIT:

#### **ORDINANCE NO. 2012-06**

#### BE IT ENACTED BY THE SANGGUNIANG BAYAN OF TANAUAN, LEYTE, IN SESSION ASSEMBLED THAT:

Section 1. Statement of Policy and Objectives. - It is a rare achievement and a distinction worthy of emulation and public recognition for a person to live for a century and beyond. While the State may design programs of social security for these Centenarians, it is recognized that as it is the duty of the family to look after its elderly members and considering that most if not all of these persons of advanced aged need special care and attention, this too is a laudable feat of those who take care of such Centenarians, deserving praise. Premised on these the following are the declared policies of this Ordinance:

(a) To motivate and encourage the Centenarian citizen to serve as an example of excellent discipline and as an inspiration to the next generations, and thus even at a ripe age still contribute to nation building;

To encourage their families or benefactor and the communities they live with to reaffirm the valued Filipino tradition of caring for the Centenarian citizens.

in accordance with these policies, this Ordinance aims to:

(1) Recognize in a positive manner the rare achievement of being a Centenarian;

- (2) Award a Centenarian and grant benefits in such a way that he/she is able to enjoy life in a privileged way;
- (3) Adopt measures whereby the Centenarians are assisted and appreciated by the community as a whole;
- (4) Establish programs beneficial to the Centenarian, his family, and the community.

Section 2. Definition of Terms. – As used in this Ordinance, the term "Centenarian" or "Centenarian citizen" shall mean any Filipino citizen at least one hundred (100) years old and a resident of Tanauan, Leyte.

The term "family" shall mean any person or group of persons related to the Centenarian by consanguinity or affinity who takes care of him/her as a dependent.

The term "benefactor" shall mean any person whether related to the senior citizen or not who takes care of him/her as a dependent.

The term "Committee" shall mean the Review, Verification and Facilitation Committee established for the purpose.

Section 3. Resolution of Felicitation and Cash Incentive. – Upon his/her 100<sup>th</sup> birthday, a Centenarian shall be honored with:

- (a) A resolution of felicitation from the Sangguniang Bayan:
- (b) A Centenarian's cash incentive in the amount of Fifty Thousand Pesos (Php 50,000.00); and
- (c) In the event of death, a totally free, non-transferable, non-renewable, non-convertible to cash perimeter niche.

Section 4. National Respect for Centenarians Day. - September 25 of each year having been declared as such, all Filipinos who have turned Centenarian in the current year shall be awarded a plaque of recognition in a ceremony especially provided for the occasion.

Also, all living Centenarians who reached their one hundredth (100<sup>th</sup>) birthday in prior years shall be honored on the celebration of the first nation Respect for Centenarians Day, or on September 25, 2012. They shall each be awarded a plaque of recognition and the Resolution of felicitation and Centenarian's incentive referred to in Section 3 hereof.

In the same event, posthumous plaques of recognition in honor of deceased Centenarians shall be presented to the nearest surviving relative of each centenarian or his/her representative.

Section 5. Additional Privileges — By January 1<sup>st</sup> of the year in which they will celebrate their 100<sup>th</sup> birthday, all Centenarians shall be entitled to the grant of fifty percent (50%) discount and exemption from the value-added tax (VAT), if applicable, on the sale of goods and services from all establishments, for their exclusive use and enjoyment or availment. For this purpose an identification card is to be issued by the Committee to facilitate the Centenarian's transactions.

Section 6. Additional Incentives. —By virtue of Sec. 447 (5) (XVII) in relation to Sec. 16 of R.A. No. 7160, it is hereby ordained that a resident Senior Citizen who reaches the age of Ninety (90) shall be awarded a cash incentive of Ten Thousand Pesos (Php 10,000.00).

Hence, all resident senior citizens who are more than ninety years old shall automatically qualify for said award.

The implementation of this clause shall be non-retroactive and only applicable to qualified senor citizens who are still living as of the approval date of this ordinance.

Section 7. Review, Verification, and Facilitation COMMITTEE. - Within fifteen (15) days from the approval of this ordinance there shall be established in the Office of the Sangguniang Bayan a Review, Verification and Facilitation Committee to be headed by a Councilor who shall be designated by the Sangguniang Bayan and assisted by the Civil Registrar, Municipal Treasurer, Municipal Health Officer, Community Development Officer, as de oficio members, and the Office for Senior Citizen Affairs (OSCA) representative. The functions of this Committee are:

- (a) To promulgate the necessary guidelines for and take the lead in the effective implementation of this Ordinance, such as, but not limited to, the following:
  - The residency requirement of potential awardees.
  - Effective information dissemination for this program.
  - Tasking of the different departments or members of the Committee.
  - The manner of issuance of iDs and monitoring of business establishments.
- (b) To plan, implement and monitor yearly work programs in pursuance of the objectives of this Ordinance:
- (c) To draw up a list of qualified awardees for the present year to be accomplished by the last Friday of January of each year;
- (d) To maintain and regularly update on a yearly basis the list of senior citizens who are potential centenarians for the next succeeding five years and to monitor their health and well-being:
- (e) To evaluate, review, and verify the veracity as to the qualifications of a potential
- To service as a general information, facilitation, and liaison center for the benefit of the centenarian citizen.

Section 8. Separability Clause. - If any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other provisions hereof which are not affected thereby shall continue to be in

Section 9. Effectivity. - This Ordinance shall take effect immediately following its posting and publication in a conspicuous area of the Municipal Hall, the Marketplace, and any other public place designated for the purpose.
