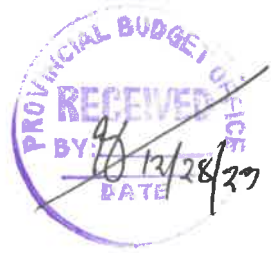

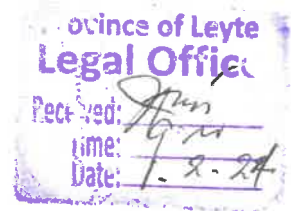

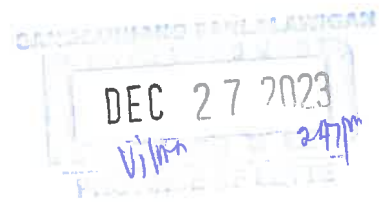

**EXCERPT FROM THE MINUTES OF THE 70<sup>TH</sup> REGULAR SESSION OF THE SANGGUNIANG BAYAN OF BURAUEN, LEYTE, HELD AT THE MUNICIPAL SESSION HALL, EXECUTIVE AND LEGISLATIVE BUILDING ON OCTOBER 31, 2023**

**MUNICIPAL ORDINANCE NO. 23-21  
 SERIES OF 2023**

**AN ORDINANCE FOR TEMPORARY ROAD CLOSURE ALONG LA PURISIMA ST. (FROM THE CORNER OF SAN AGUSTIN ST. TO THE CORNER OF SAN JOSE ST.) AND ALONG STO. NIÑO ST. (FROM THE CORNER OF LA PURISIMA ST. TO THE CORNER OF STA. ANA ST.) TO BE UTILIZED FOR THE UPCOMING ANNUAL FIESTA CELEBRATION AND YULETIDE SEASON ACTIVITIES OF THE MUNICIPALITY OF BURAUEN, LEYTE UNTIL DECEMBER 31, 2023**

**BE IT ORDAINED**, by the Sangguniang Bayan of Burauen, Leyte, in regular session assembled, that:

**SECTION 1 – Authority to Close Roads.** The Sangguniang Bayan is empowered to temporary close roads or alleys, pursuant to Section 21 (a) (c), Chapter II, Book I, Title I of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 which states:

**“Section 21. Closure and Opening of Roads. –**

- (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, that in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure, is provided,**
- (b) Any national or local road, alley, park or square may be temporarily closed during ..... or fiesta celebrations...”**


**SECTION 2 – Roads to be Temporarily Closed.** Effective immediately, La Purisima St. (from the corner of San Agustin St. to the corner of San Jose St.) and Sto. Niño St. (from the corner of La Purisima St. to the corner of Sta. Ana St.) shall be temporarily closed to give way to the upcoming Annual Fiesta Celebration and Yuletide Season Activities of the Municipality of Burauen, Leyte;

**SECTION 3 – Administrative Provision.** The Office of the Municipal Mayor, through the Engineering Department and Traffic Enforcers shall provide the necessary mechanisms in the implementation of this ordinance;

The Office of the Municipal Engineer shall provide the necessary traffic signages, and provide safety precautionary measures to protect the riding public and motorists.
