Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities,

improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.



MUNICIPAL ORDINANCE NO. 23-22 SERIES OF 2023

AN ORDINANCE PROVIDING CASH INCENTIVES TO TOPNOTCHERS (TOP 10) IN PROFFESIONAL LICENSURE EXAMINATIONS CONDUCTED BY THE PROFESSIONAL REGULATION COMMISSION (PRC), WHO ARE GRADUATES OF BURAUEN COMMUNITY COLLEGE (BCC) AND APPROPRIATING FUNDS THEREFOR

SECTION 1 – *Title.* This ordinance shall be known as, "An Ordinance Granting Cash Incentives to Topnotchers (Top 10) in Professional Licensure Examinations, who are Graduates of Burauen Community College"

SECTION 2 – Declaration of Policy. It shall be the policy of the Local Government Unit of Burauen, Leyte to recognize board passers who are students of Burauen Community College, as well as to motivate board examination takers of licensure examinations administered by the PRC.

SECTION 3 – Definition of Terms.

Professional Regulation Commission (PRC) – an agency that administers, implements and enforces the regulatory laws and policies of the country with law and policies of the country with respect to the regulation and licensing of the various professions and occupations under its jurisdiction, including the enhancement and maintenance of professional and occupational standards and ethics and the enforcement of the rules and regulations relative thereto.

Burauen Community College (BCC) – a local college under the Local Government Unit of Burauen, Leyte.

SECTION 4 – Coverage and Scope. All licensure examination passers that have graduated from Burauen Community College with at least 2 years of enrolment, who attained Top 10 spots on PRC board examinations.

SECTION 5 - Incentives.

Top 1 shall receive One Hundred Thousand Pesos (P 100,000.00) each.

Top 2 shall receive Fifty Thousand Pesos (P 50,000.00) each.

Top 3 shall receive Thirty Thousand Pesos (P 30,000.00) each.

Top 4-10 shall receive Twenty Thousand Pesos (₱ 20,000.00) each.

SECTION 6 – Funding Support and Implementation. The Cash Incentives shall be funded under the Special Program, Awards and Incentives of the Office of the Mayor. The same shall be the implementing office.

SECTION 8 – *Repealing Clause.* All ordinances, resolutions, executive orders and all other issuances inconsistent herewith are deemed to be repealed or modified accordingly.

SECTION 9 - Separability Clause. If any of the provisions of this ordinance is declared invalid and unconstitutional, other parts or provisions hereof shall continue to be in full force and effect.

SECTION 10 - Effectivity. This ordinance shall take effect upon its approval.
