<sup>i</sup> (c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order: Provided, however, That no national or local road, alley, park, or square shall be temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned.

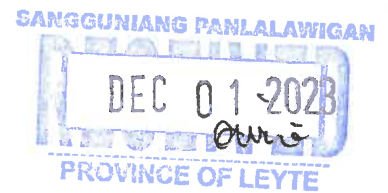

**AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF THE INNER STREETS BETWEEN R.V. VILLAFLORES UP TO VELOS RESIDENCE AT THE MABINI STREET AND MILLAN'S RESIDENCE AT THE MABINI STREET CORNER RIVERA STREET, BARANGAY EASTERN POBLACION RELATIVE TO THE CONDUCT OF A PUBLIC RALLY**

**WHEREAS**, Section 21 of RA 7160, also known as the Local Government Code of 1991 provides that: Closure and Opening of Roads;

**WHEREAS**, the Office of the Sangguniang Bayan thru the Secretary to the Sanggunian is in receipt of an urgent measure dated October 19, 2023 and received on October 23, 2023 at 8:30 in the morning to act on the request for a temporary road closure;

**NOW THEREFORE**, on motion of Hon. Francisco M. Ortega, in unanimous accord enacted Municipal Ordinance, thus;

**BE IT ORDAINED**, by the Sangguniang Bayan of Hilongos, Leyte in a regular session assembled that:

**SECTION 1. Authority to Close Roads** - The Sangguniang Bayan is empowered to temporarily close roads or alleys pursuant to the general powers as stated in Section 21 (a)(c), Chapter II, Book I, Title I, RA 7160, also known as the Local Government Code which is as follows:

(c) Any national or local road, alley, park or square may be temporarily closed during an actual emergency or fiesta celebration, public rallies, agricultural or industrial fairs or an undertaking of public works and highways, telecommunications and waterworks projects, the duration of which shall be specified by the Local Chief Executive concerned in a written order.

**SECTION 2. Road to be Temporarily Closed** - The date for the temporary closure will be on October 28, 2023, Saturday from 3:00 in the afternoon until 12 midnight.

Said closure of the road will be on the inner streets between R.V. Villaflores Street up to Velos Residence at the Mabini Street and Millan's Residence Corner Rivera Street, in Barangay Eastern, Hilongos, Leyte.

**SECTION 3. Administrative Provision** - The Office of the Municipal Mayor shall provide the necessary mechanisms in the implementation of this ordinance.

Moreover, it is imperative for the Executive Department to provide necessary traffic signages and safety precautionary measures to protect the riding public motorists and pedestrians.

**SECTION 4. Effectivity.** This ordinance shall take effect upon approval.




