AN AMENDMENT TO SECTION 9 OF ORDINANCE NO. 10, S-2022-2025 ENTITLED – "SETTING STANDARDS AND REGULATORY REGUIREMENTS ON REGISTRATION, TRANSFER AND TRANSPORT OF ALL DOMESTICATED POULTRY, LIVESTOCK AND OTHER SPECIES AND MEMBERS OF THE BOVINE FAMILY AND ITS BY-PRODUCT IN THE MUNICIPALITY OF VILLABA, PROVINCE OF LEYTE AND IMPOSING PENALTY AND VIOLATION THEREOF AND FOR OTHER PURPOSES".

INTRODUCED BY: FELIPE S. CASAS, SR. SB-MEMBER

Section 447 (a) of the Local Government Code of 1991 provides that the Sangguniang Bayan, as a Legislative Body of the Municipality, shall enact ordinances, approve resolution and appropriates funds, for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this code and in the proper exercise of the corporate powers of the municipality as provided.

On October 17, 2022, the Sangguniang Bayan approved Municipal Ordinance No. 10, S-2022-2025.

However, reports from the farmer constituents revealed that there is a need to amend the provision on the imposition of registration of ownership, transfer of ownership and transport fees in order to encourage more raisers or owners of livestock to buy and sell their products within the Municipality

Be it ordained by the Sangguniang Bayan in regular session duly assembled that:

SECTION 1. SHORT TITLE. This ordinance shall be known as "An Ordinance Amending Sections 7 & 9 of Municipal Ordinance No. 10, S-2022-2025".

SECTION 2. SECTION 7 of MUNICIPAL ORDINANCE NO. 10, S-2022-2025 is hereby amended to read as follows:

"Section 7. Duties of Poultry raisers/owners — The poultry raisers/owners are hereby required to register the said project with the Municipal Treasurer for which a certificate of ownership shall be issuedupon payment of the registration fees. However, the raiser/owner may opt to obtain a certificate of ownership from the/ barangay.

AN ORDINANCE SETTING STANDARDS AND REGULATORY REQUIREMENTS ON REGISTRATION, TRANSFER AND TRANSPORT OF ALL DOMISTICATED POULTRY, LIVESTOCK AND OTHER SPECIES AND MEMBER OF THE BOVINE FAMILY AND ITS BY-PRODUCT IN THE MUNICIPALITY OF VILLABA, PROVINCE OF LEYTE AND IMPOSING PENALTY FOR THE VIOLATION THEREOF AND FOR OTHER PURPOSES

Introduced By. Hon. Felipe S. Casas SR. SB Member

WHEREAS, Section 447 (a) of the Local Government Code of 1991 provides that the Sangguniang, Bayan as a Legislative Body of the Municipality, shall enact ordinances, approve resolutions and appropriate funds, for the general welfare of the Municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the Municipality as provided for under Section 22 of this Code;

WHEREAS, Presidential Decree No. 533 S. 1974, the Anti-Cattle Rusting Law states that large animals are indispensable to the livelihood and economic growth of our people particularly the agricultural workers, large animals are used for burden/work of our farmers and the source of fresh meat and dairy products for our people and provide raw materials for our tanning and canning industries in our country;

WHEREAS, reports from the law enforcement agencies and from our farmer constituents revealed that there is a resurgence of thieves of small and ruminant animal particularly carabaos and cattle in our Municipality commonly known as "Cattle Rustling" especially in our rural areas thereby directly prejudicing the livelihood of the agricultural works and adversely affecting our food production program for self-sufficiency in rice, corn and other staple crops as well as in fresh meat and other animal products;

WHEREAS, there is an urgent need to protect our poultry small and large ruminant animals industries and small time animal raisers/owners from the nefarious activities of lawless elements in order to encourage our hardworking animal raisers and farmers to raise more small and large ruminant animals and concentrate in their agricultural works, thus increasing our source of meat and dairy products as well as our agricultural production activities;

Article I General Provisions

Section 1. - This Ordinance shall be known as "An Ordinance setting standards and regulatory requirements on registration, transfer and transport of all domesticated poultry, livestock and other species and member of the bovine family and its by-product in the Municipality of Villaba, Province of Leyte and imposing penalty for the violation thereof and for other purposes

Section 2. – Policy and Purposes – As contained in the 1987 Philippine Constitution it is the declared policy of the state to protect and promote the right of the people and instill consciousness among them. This Ordinance is enacted for the purpose of setting standard and regulatory requirements in the transport of all domesticated poultry, livestock and other member of the bovine family and it's by product in the Municipality of Villaba, Province of Leyte and imposing penalty for the violation thereof and for other purposes.

Section 3. - Objectives -

- To ensure that small and large ruminant animal owners are protected by the Presidential Decree No. 533 "The Anti-Cattle Rustling Law of 1974".
- To regulate the mobility of the domesticated poultry and livestock from one Municipality/Cities to another.
- 3. To encourage Poultry, large and small ruminant animal owners/raisers to register their animals in their possession at the Municipal Treasurer and to the Municipal Agricultural Office of the said Municipality.

Section 4 – Scope and Coverage

 This Ordinance shall strongly be enforced in the territorial jurisdiction of the Municipality of Villaba, Province of Leyte, and shall cover all poultry small and large ruminant animal livestock owners and peddlers peddling their animals in the Municipality and other neighboring Municipalities/cities in the Province of Leyte and beyond.

Section 5. – Definition of terms – the following terms are conceptually and operationally defined as:

- Large ruminant Animals includes Cattle, Carabao, Horse, Mule Ass and other member of the bovine family with four (4) compartments stomachs.
- 2. Small ruminant animals includes Goat and Sheep having also four (4) compartments stomach.
- Owners/Raisers shall include the herdsman caretaker, employee or tenant or any firm entity engage in the raising of the domesticated fowls and livestock or other person in lawful possession of such animals.
- 4. Cattle rustling is the taking away of the animals by any means, method or scheme without the consent of the owner/raiser.
- 5. Prison mayor is a type of sentence penalizing the violators for six (6) years and one (1) day to eight (8) years.
- Reclusion temporal is a type of sentence penalizing the violators for twelve (12) years and one (1) day to fourteen (14) years and eight (8) months to 20 years.
- 7. Reclusion Perpetua is a penalty imposed serious felonies defined and penalized under penal code.
- 8. Poultry refers to the raising of all domesticated fowls such as (Chicken, Turkey, Peacock, and ostrich).

9. Sows – are those female matured pig already breeding.

Section 6. - Duties of the livestock owners/raisers to register - the owners/raisers, before the large animal belonging to him, shall attain the age of six (6) months or two (2) years, register the same with the office of the Municipal treasurer where such animals are raised. The Municipality concerned may imposed and collect the fees authorized by the existing laws for such registration and the issuance of a certificate of ownership/credential to the owner/raiser.

Section 7. - Duties of poultry raisers/owners - The poultry raisers/owners are hereby required to register the said project with the Municipal Treasurer for which a certificate of ownership shall be issued upon payment of the registration fees.

Section 8. – Administrative Provision – 1.) The ownership of large animals or its sale or transfer of ownership to another person, shall be registered with the Municipal Treasurer. All branded and counter branded large animal presented to the Municipal Treasurer, shall be registered in a book showing among others, the name and the residence of the owner, the consideration or purchase price of the animal in cases of sale or transfer and the class color, sex, brands and other identification marks of the animals. These data shall also be stated in the certificate of ownership issued to the owner of the large ruminant animals.

2.) The transfer of large ruminant animals regardless of age, shall be entered in the registry book setting forth, among others, the name and the residence of the owners and purchasers. The consideration or the purchase price of the animal for sale or transfer, class, sex, brand and other identifying marks of the animals, a reference by number to the original certificate of ownership with the name of the Municipality issued to it. No entries of transfer shall be made or certificate of transfer except upon the production of the original certificate of ownership and certificate of transfer and such other documents that show title to the owner.

Section 11. – Clearance for Shipment – Any person, partnership, association, corporation or entity desiring to ship or transport any of the domesticated poultry and livestock and its by-product from any point of the province or cities, shall secure a permit for such purpose from the office of the Municipal, Mayor where the animal is registered before the issuance of the permit herein prescribed in Section 3 hereof or certificate from the Municipal Veterinarian representative from the office of the Municipal Agriculture of the said municipality, will certify that such animal, live or meat, are free from any disease and such other documents or records as may be necessary to the shipment of animal its hide, live or meat from one province and municipalities/cities outside the Province of Leyte without first this securing the necessary permit from the municipal treasurer of the place of origin.

Section 12. – Duties of the Municipal Treasurer and other concerned public officials and employees – All public officials and employees concerned to the registration of the animal are required to observe strict adherence with pertinent provision of chapter 22, Section 511 to 534 of the Revised Administrative Code, except insofar as they may be inconsistent with the provision of this Decree.

Section 13. – Presumption of Cattle Rustling – Every person having in his possession, control or custody of small and ruminant animals, shall upon demand by competent authority, exhibit the documents prescribed in the preceding sections. Failure to exhibit the required documents shall be the prima facie evidence that such animal in his possession, control or custody, are the fruits of the crime.

Section 14. - Penal Provisions -

1.) Any person convicted of cattle rustling, as herein defined, shall irrespective of the value of large animal involved, be punished by prison mayor in its maximum period of reclusion temporal in its medium period if the offense is committed without violence against or intimidation of persons or forces upon things. If the offense is committed with violence against intimidation of persons or force upon things the penalty of reclusion temporal in its maximum period to reclusion Perpetua, shall be imposed of a person who seriously enforced or killed as a result or on the occasion of the commission of cattle rustling, the penalty or reclusion Perpetua to death, shall be imposed.

When the offender is a government official or employee he shall, in addition to the foregoing penalty, be disqualified from voting or being voted upon in any election referendum and from holding any public office or employment.

When the offender is an alien he shall be deported immediately upon the completion of the service of his sentence without further proceedings.

2.) Any persons convicted by cattle rustling and a violator of this Ordinance be penalized. A penalty amounting to One Thousand Pesos (Php. 1, 000.00) per animal for first offense committed. Two Thousand pesos (Php. 2, 000.00) per animal for second offense and Five Thousand Pesos (Php. 5, 000.00) per animal for the third offense and imprisonment of not exceeding six (6) months upon the discretion of the court.

In case of Poultry – Any person caught and a suspect of stealing likewise be penalized. A penalty in the amount of Two Thousand Pesos (Php. 2,000.00) per Bird for Fighting cock and Five Hundred Pesos (Php. 500.00) per bird for an ordinary Bird for consumption. On the other hand,

Any person convicted by Cattle Rustling and a violator of this Ordinance be penalized.

A penalty amounting to One Thousand Pesos (Php. 1, 000.00) per animal for first offense committed, Two Thousand Pesos (Php. 2, 000.00) per animal for the second offense and Five Thousand Pesos (Php. 5, 000.00) per animal for the third offense and imprisonment of not exceeding six (6) months upon the discretion of the court.

Section 17. Functions/Roles of the Punong Barangay - All Punong Barangays of Thirty five (35) Barangays of the Municipality of Villaba are mandated to fully implement this Ordinance by regulating persons engage in buy and sell and to transport any poultry and livestock in their area of jurisdiction by apprehending persons bringing in his possession, the live poultry particularly the small and large ruminant animals whether the required documents are properly complied, if, and when the person who has in his possession the live poultry and livestock without proper documents upon the demand of the Punong Barangay, the Punong Barangay has the authority to hold in abeyance the said animals and be turned over to the higher authorities for further The Philippine National Police (PNP) and other agencies involved in the implementation of this Ordinance, shall have a common agreement in the resolution of this matter. If found guilty the violators will be penalized as stipulated in Section 14 of this Ordinance.

Section 18. Separability Clause - If for reason or reasons, the provisions of this Ordinance shall be held invalid or unconstitutional other parts thereof which are not affected shall continue to be in full force and affect.

Section 19. Repealing Clause - All Ordinances rules and regulations or any part thereof whose provisions are in conflict to the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

Section 20. - Effectivity Clause - This Ordinance shall take effect upon approval and publication in a newspaper of local circulation in the Province of Leyte.

NOW THEREFORE, on motion raised for approval of this ordinance by the Sangguniang Bayan Member Felipe S. Casas, Sr., duly seconded en masse, the motion was carried.
