

### Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 01 FY 2023** of the **Municipality of Dagami**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 7**, **Series of 2023**, with a total appropriation in the amount of **P11,513,373.80** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the grant of Terminal Leave Benefits and Monetization of Leave Credits shall be subject to CSC guidelines and Budget Circular No. 2016-2.
- That the procurement of Goods and other related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations;
  - 3. That the allocation and utilization of the 5% Local Disaster Risk Reduction and Management Fund (LDRRMIF) shall conform with the provisions of NDRRMC-DBM and DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013:
  - 4. That funds are actually available to pay these proposed expenditures and shall be disbursed for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit.
