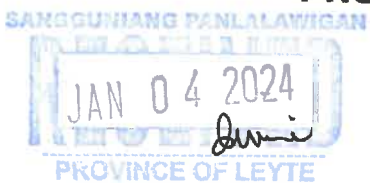

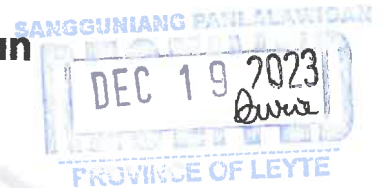

**MUNICIPAL ORDINANCE NO. 484-061123**

**AN ORDINANCE GRANTING THE HINABLAYAN SPORTS CENTER, INC., LOCATED AT 628 RIZAL ST., BARANGAY GUIWAN I, PALOMPON, LEYTE, TO ESTABLISH, MAINTAIN AND OPERATE A COCKPIT FACILITY IN THE MUNICIPALITY**

BE IT ORDAINED by the Members of the Sangguniang Bayan of Palompon that:

**SECTION 1. NATURE AND SCOPE OF FRANCHISE** – Subject to the provisions of the Constitution and R.A. 7160 known as the Local Government Code 1991 and applicable laws and ordinances, rules and regulations, there is hereby granted to the Hinablayan Sports Center, Inc. a franchise to maintain and operate, in the interest of the public, a cockpit facility in the Municipality of Palompon, for recreation and entertainment.

**SECTION 2. ESTABLISHMENT AND OPERATION** – The cockpit facility of the grantee shall be constructed, maintained and operated in accordance with the existing applicable laws and ordinances.

**SECTION 3. AUTHORITY OF THE MUNICIPAL MAYOR** – The grantee shall secure from the Municipal Mayor and Operator's Permit the appropriate license for the establishment and operation of such sports facility. The Municipal Mayor shall see to it that all requirements and regulations are complied with in consonance with the provisions to the existing rules, regulations and other ordinances.

**SECTION 4. RESPONSIBILITY TO THE PUBLIC** – As an enterprise, the grantee shall operate and maintain its sports facility in satisfactory manner at all times, and as far as practicable and necessary, improve or change such facilities for public convenience.

**SECTION 5. TERM OF FRANCHISE** – This franchise shall be for a term of twenty-five (25) years from the date of effectivity of this ordinance. Penalty will be imposed in the event that the grantee fails to comply the following conditions.

- a) Commence operations within one (1) year from the approval of its Franchise and Permits
- b) Fulfillment of the requirements as provided for by existing rules, regulations and other ordinance.

**SECTION 6. FRANCHISE FEE**- It is hereby required for the grantee to pay the amount of Twenty-Five Thousand Pesos (P25,000.00) as Franchise fee, provided however, that this amount is payable within Three (3) years and that the first payment shall not be less than Ten Thousand Pesos (P10,000.00) excluding taxes, fees and charges for the operation franchise.

**SECTION 7. ACCEPTANCE AND COMPLIANCE** – Acceptance of this franchise shall be given in writing within sixty (60) days from the effectivity of this ordinance. Upon acceptance the grantee shall exercise the privileges granted under this ordinance. Non acceptance shall render the franchise null and void.

**SECTION 8. TAX PROVISION** – The grantee shall be liable to pay taxes on their real estate, building if there is any and personal property and other taxes, fees or charges as required by law or ordinance.

Further, the grantee keeps a separate books and accounts on its business transactions and income realized by it and shall furnish the Municipal Treasurer's Office a copy of such account not later than the 31<sup>st</sup> of January of each year, for the preceding twelve (12) months.

**SECTION 9. SALE, LEASE, TRANSFER, ETC.** – The grantee shall not lease, transfer, sell or assign this franchise or the rights and privileges acquired thereunder to any person, firm, company, corporation or entity, not shall the controlling interest in the grantee be transferred, whether as a whole or in parts and whether simultaneously or contemporaneously, to any such person, firm, company, corporation, or entity without the prior approval of the Sangguniang Bayan of Palompon except when such person, firm, company, corporation or entity has a valid legislative franchise.

**SECTION 10. PENAL PROVISION** – For the violation of any provision of this ordinance, an administrative penalty shall be imposed on the grantee, thus:

- First Offense - warning/reprimand
- Second Offense - a penalty of ₱2,500.00
- Third Offense - suspension of franchise and/or revocation of franchise to be determined by Sangguniang Bayan and after due process

**SECTION 11. SEPERABILITY CLAUSE** – If any of the sections or provisions of this ordinance is held invalid, all the other provisions not affected thereby shall valid.

**SECTION 12. REPEALABILITY CLAUSE** – This franchise shall be subject to amendment, alteration or repeal by the Sangguniang Bayan of Palompon when the public interest so requires.


**SECTION 13. REPORTORIAL REQUIREMENT** – Upon approval the grantee shall submit an annual report to the Sangguniang Bayan of Palompon on its compliance with the terms and conditions of its franchise and on its operations for three (3) years upon approval of the grantees.

**SECTION 14. EFFECTIVITY** – This ordinance shall take effect immediately upon its approval.
