



### Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 03 FY 2023** of the **Municipality Kananga**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 23L.23-048** with a total appropriation in the amount of **P14,998,000.00** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- That the reversion of appropriations is duly authorized by the concerned officials and is backed up by cash collections and are made available to support the expenditures under Supplemental Budget No. 03. - 3. That the grant of One-Time Service Recognition Incentive shall conform with the terms and conditions stipulated under Budget Circular No. 2023-2 dated December 13, 2023;
- 4. That the appropriation and grant of Gratuity Pay shall be pursuant to the provisions of Budget Circular Number 2023-3 dated December 14, 2023; and
- 5. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and all other accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.

(Series of 2023)

AN ORDINANCE APPROPRIATING THE AMOUNT OF FOURTEEN MILLION NINE HUNDRED NINETY EIGHT THOUSAND PESOS (P14,998,000.00) EMBODIED UNDER SUPPLEMENTAL BUDGET NO. 3 CY 2023 FOR THE CONTINUED OPERATION OF THE MUNICIPAL GOVERNMENT OF KANANGA, LEYTE FOR THE PERIOD FROM JANUARY 1 TO DECEMBER 31, YEAR 2023, AND FOR OTHER PURPOSES.

WHEREAS, the Local Chief Executive, in pursuance of the provision of Section 444 (3) (ii) of Republic Act No. 7160, has caused the preparation of Supplemental Budget No. 3 outlining therein the Budgetary Requirements for the continued delivery of basic services, facilities, other functions of the Local Government under Section 17 of the said Code;

WHEREAS, the Sangguniang Bayan, through the Committee of the Whole, in the exercise of its power under the Local Government Code, has considered the proposed Supplemental Budget, reviewed evaluated and recommended the approval of the ordinance embodying the proposed appropriation for the Supplemental Budget No. 3 for Calendar Year 2023.

NOWTHEREFORE, considering the above cited premises; be it enacted by the 23rd Sangguniang Bayan of Kananga, Leyte on a special session duly assembled on this 20th day of December 2023 and upon motion of SB Member Alma N. Orfano, seconded en masse, to wit:

Section 1. Appropriation of Funds - It is hereby appropriated the sum of Fourteen Million Nine Hundred Ninety Eight Thousand Pesos (P14,998,000.00).

Section 2. Source of Funds - SB Ordinance No. 23L.23-047, entitled: "An Ordinance reverting fund in the amount of Fourteen Million Nine Hundred Ninety Eight Thousand Pesos (P14,998,000.00) from the available appropriated funds of the Maintenance and Other Operating Expenses (MOOE) and Personal Services (PS) for CY 2023 of the different offices in the LGU-Kananga.

Section 6. Effectivity Clause - This Ordinance shall take effect upon approval.



### **ORDINANCE NO. 23L.23-047** Series of 2023

AN ORDINANCE REVERTING FUND IN THE AMOUNT OF FOURTEEN MILLION NINE HUNDRED NINETY EIGHT THOUSAND PESOS (P14,998,000.00) FROM THE AVAILABLE APPROPRIATED FUNDS OF THE MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) AND PERSONAL SERVICES (PS) FOR CY 2023 OF THE DIFFERENT OFFICES IN THE LGU-KANANGA.

#### PREFATORY STATEMENT

WHEREAS, the Municipal Mayor requested for the reversion of funds in the amount of Fourteen Million Nine Hundred Ninety Eight Thousand Pesos (P14,998,000.00) from the available appropriated funds of the Maintenance and Other Operating Expenses (MOOE) and Personal Services (PS) for CY 2023 of the different offices in the LGU-Kananga, as contained in his letter dated December 18, 2023;

WHEREAS, the said request is supported with: (1) the List of Continuing Legislative Appropriation for Reversion as certified by the Municipal Budget Officer, and (2) a Certification duly signed by the Local Finance Committee, certifying among others that the accounts of the continuing legislative appropriations recommended for reversion have no obligations to settle and are not encumbered and available for reversion;

WHEREAS, Section 322 of the Local Government Code of 1991, provides: Reversion of Unexpended Balances of Appropriations, Continuing Appropriations. - Unexpended balances of appropriations authorized in the annual appropriations ordinance shall revert to the unappropriated surplus of the general fund at the end of the fiscal year and shall not thereafter be available for the expenditure except by subsequent enactment. However, appropriations for capital outlays shall continue and remain valid until fully spent, reverted or the project is completed. Reversions of continuing appropriations shall not be allowed unless obligations therefor have been fully paid or otherwise settled.

WHEREAS, after a thorough and careful study of the subject matter, it is recommended by the Committee of the Whole to enact and approve the ordinance reverting funds to the unappropriated savings.

NOW THEREFORE, on motion of SB Member Fernando M. Aseo, duly seconded en masse, BY VIRTUE OF THE POWERS VESTED IN THE 23rd SANGGUNIANG BAYAN OF KANANGA BY LAW, BE IT ORDAINED, IN A REGULAR SESSION ASSEMBLED, THAT:

**SECTION 2.** Application of Funds. – The funds hereby reverted shall form part of the unappropriated savings of the Local Government Unit of Kananga in the amount of P14,998,000.00, which shall correspondingly be accounted to its respective records of accounts as provided by law.

No funds from the said unappropriated savings shall be utilized except through appropriation ordinance which may be later on be enacted by the Sangguniang Bayan.

**SECTION 3**. Separability Clause – should any of the provision of this ordinance be declared inoperative by the Courts for being inconsistent with the Constitution or the law, the other unaffected provision of this Ordinance shall remain in full force and effect.

**SECTION 4**. Repealing Clause – Any and all ordinances or parts thereof which are inconsistent with the provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 5. Effectivity. This ordinance shall take effect upon approval.
