247 Can I say something regarding this Supplemental Budget?

248

249 HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

250 Go ahead maam.

251 HON. TRINIDAD G. APOSTOL: 2<sup>ND</sup> DISTRICT BOARD MEMBER

252 This is regarding this Supplemental Budget. It is written here for the "grant of  
253 Service Recognition (SRI) incentive for FY 2023 and provision of funds for the Gratuity  
254 Pay of the Job Order Contracts (JOs) and Contract of Service (Cos) personnel of the  
255 Provincial Government of Leyte. So, Mr. Chairman of the Committee on Appropriation,  
256 this particular budget which is being reverted which is to be given as Service  
257 Recognition for the Job Orders of the Province of Leyte. Am I correct?

258 HON. WILSON S. UY: 1<sup>ST</sup> DISTRICT BOARD MEMBER

259 Not only the Job Orders but all the employees of the Provincial Government of  
260 Leyte.

261 HON. TRINIDAD G. APOSTOL: 2<sup>ND</sup> DISTRICT BOARD MEMBER

262 But we approved also another Supplemental Budget last session. I think that was  
263 for the employees' bonus.

264 HON. WILSON S. UY: 1<sup>ST</sup> DISTRICT BOARD MEMBER

265 Yes, that was only for the bonus.

266 HON. TRINIDAD G. APOSTOL: 2<sup>ND</sup> DISTRICT BOARD MEMBER

267 So, this is also for the bonus of the Employees and the Job Orders. Or the Job  
268 Orders only?

269 HON. WILSON S. UY: 1<sup>ST</sup> DISTRICT BOARD MEMBER

270 Yes, Mr. Chair, last session we approved the Supplemental Budget and that was  
271 for the bonus for the provincial employees of the Provincial Government of Leyte. This  
272 time this came from the Administrative Order No. 12 coming from the Office of the  
273 President, granting additional incentive, they call it, Service Recognition (SRI) Incentive  
274 to all the employees and to all Local Government Units.

275 HON. TRINIDAD G. APOSTOL: 2<sup>ND</sup> DISTRICT BOARD MEMBER

276 Thank you.

277 I have no objection to this, provided that all the employees will be able to get this.



278 Thank you so much, Mr. Chairman and Honorable Floor Leader.

282 Supplemental Budget and the previous one. This will be based on the length of service.

283 Whereas, the other one was fixed of P25, 000.00 for everybody. So this will defer on

284 the number of years the employee has been in service.

288 Just a manifestation, Mr. Chairman.

289 HON. TRINIDAD G. APOSTOL: 2<sup>ND</sup> DISTRICT BOARD MEMBER

290 Mr. Chairman, can I say something?

291 You know, Mr. Floor Leader, we just want to be clear because of so many

292 supplemental budgets already. How many supplemental budgets do we have Mr.

293 Chairman?

295 This is No. 7 Supplemental Budget.
