894	language, the police power is the power of the LGU to promote the general welfare
895	which is, an example would be, when there is a crazy dog, 'no, roving the municipality
896	and causing the disturbance or injury to the inhabitants, then the LGU can pass a law to
897	take out the dog or to imprison who is causing injury or crimes in the LGU. That is a
898	police power, Mr. Chair, to promote the general welfare.
899	Another example would be, when there is danger like for the protection of the
900	sugar industry, the Congress can pass a law providing for the sugar fund or the coco
901	levy fund or the oil price stabilization fund which is for every liter of the fuel imported,
902	Php1.00 was contributed to this fund which will be used in case there is fluctuations in
903	the price of crude oil in the international market. So, to promote the general welfare, Mr.
904	Chair. That's the objective of Section 56, which is, if I may say so, incorrectly cited, 'no,
905	as basis for this ordinance, which is just declaring a holiday, 'no.
906	HON. RAISSA J. VILLASIN: 2 ND DISTRICT BOARD MEMBER
907	Mr. Chair.
