This refers to the Letter of Protest of Hon. Noel Sia on the MDC Meeting for the approval of the Municipal Investment Plan for CY 2022 of La Paz, Leyte dated, December 10, 2021, which was referred to the Provincial Legal Office, pursuant to Sangguniang Panlalawigan Resolution No. 2021-675.

For reference, the said protest raised the following for resolution:

- 1. A roll call, which is the basic principle for a quorum to be established did not occur during the MDC Meeting;
- Concerns and objections of some Punong Barangays were not acknowledged by the Presiding Officer, who continued to ignore the same, and proceeded to approve the said Annual Budget, thereby abusing his authority;
- 3. The Punong Barangays were not included in the planning of the Municipal Annual Investment Plan; and,
- 4. His Motion to divide the house for the approval of the Municipal Annual Investment Plan for CY 2022 was not recognized.

Submitted to this committee is the Findings and Recommendations of the Provincial Legal Office which is hereto attached and made an integral part of this Report.

The records of the case would disclose that after the referral of the case to the Provincial Legal Office, the latter requested the protestee Mayor of La Paz, Leyte, Hon. Angel A. Sia, Jr., to file a comment to the protest, which was complied with. And as both the protest and comments were already on record, the Provincial Legal Office proceeded with its investigation and examined whether or not there were indeed irregularities in the parliamentary procedures during the questioned in MDC meeting held on November 23, 2021 for the approval of the Municipal Annual Investment Plan (AIP) of the municipality of La Paz, Leyte for the year 2022.

After investigation, the Provincial Legal Office resolved that the protestant was not able to validate his claims for lack of legal and factual basis, as the same failed to submit supporting documents to substantiate his allegations. On the other hand, when the protestee submitted his comment, the same was able to produce documents controverting the allegations of the protestants, which led to the recommendation of the Provincial Legal Office for the TERMINATION and consequently the DISMISSAL of the instant protest of protestant, Hon. Noel Sia.

Perusal of the records indeed disclosed that contrary to the allegations of the protestant, the Minutes of the MDC meeting held on November 23, 2021 would establish that a quorum has been declared prior to the conduct of the meeting and that the concerns of the attendees were acknowledged and responded to. The minutes also showed that the Presiding Chairperson asked the body for questions after the presentation, but no questions were raised. Without any proof controverting the Minutes of the questioned MDC meeting, this committee agrees with the findings of the Provincial Legal Office that the protest as it is, holds no water.

Further, the committee also agrees with the Provincial Legal Office that the burden of proof lies upon the protestant and therefore has the burden of proof to substantiate his allegations. Without any supporting document or proof to show that the objections of several Punong Barangays to include the objection of the protestant himself were not acknowledged, the same stands as mere allegations which could not controvert the records contained in the questioned Minutes.

Therefore, the committee resolves to adopt the Findings and Recommendations of the Provincial Legal Office, dated November 17, 2023 and hereby recommends for the Dismissal of the protest of Hon. Noel Sia on the MDC Meeting for the approval of the Municipal Investment Plan for CY 2022 of La Paz, Leyte dated, December 10, 2021.
