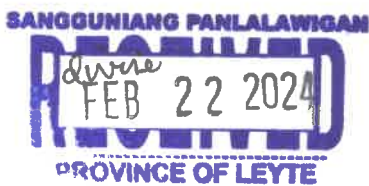



- . Eligibility: Career Service (Professional)
Second Level Eligibility

Section 3. Repealing Clause.

All ordinances, resolutions, local executive orders or rules and regulations contrary or inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

Section 4. Separability Clause.

If any provision of this Ordinances be held invalid other parts or provisions that are not affected thereby shall continue to be in full force and effect.

Section 5. Effectivity.


This Ordinance shall take effect after the final review of the members of the Sangguniang Panlalawigan of Leyte and the requirement of posting is complied with.






