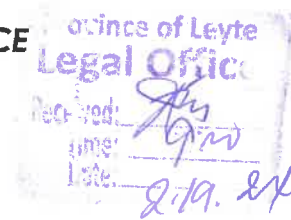

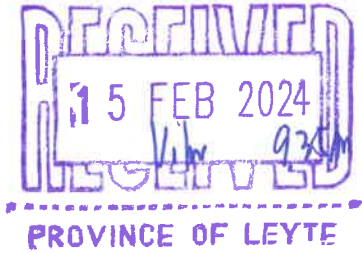

**Section 1. Definition of Terms.** For purposes of implementing this ordinance, the following terms shall be construed as follows:

- a. Sow – adult female hog;
- b. Backyard Fattening – the fattening, or finishing, phase starts as the piglets leave the transition phase, at between 9 and 14 weeks, and ends when the pigs are sent to slaughter when they reach 85-120 kg.
- c. Commercial Swine Production – focused on producing high quality, wholesome and reasonably priced pork products for consumers
- d. Hog – a domesticated pig, especially one over 120 pounds (54kg) and reared for slaughter
- e. Fattening – between 9 and 14 weeks, and ends when the pigs are sent to slaughter when they reach 85-120kg.
- f. Breeding – the approach taken to pairing a boar and a gilt or sow for breeding in order to incorporate or maintain desired traits
- g. Densely Populated – contains a large amount of people
- h. backyard piggeries – raising of swine in a household backyard for the purpose of household consumption.

**Section 2. Swine Production Categories.** For purposes of implementing this ordinance, the foregoing categories shall be adopted:








1. Piggery Projects involve a maximum of 10 heads for fattening and 2 heads sow for breeding;

2. Their operation shall be subject to the condition that will be clean and sanitary at all times and will not be nuisance;

3. These facilities shall be exempted from the requirements of locational clearance on the zoning ordinance of the municipality;

4. A Sanitary Permit issued by the Local Health Authority is required for operating a backyard piggery;

5. It requires a septic tank in every backyard farm.

6. There should be sufficient water supply at all times.

#### 2.2 PIG FARM:

1. A medium scale piggery has a maximum of 11-24 heads while large scale piggeries have 25 heads or more; May be allowed in remote/isolated areas.

2. In medium scale piggery, only 3 sows shall be allowed

3. These are required to secure a Locational Clearance or a Municipal Zoning Clearance;

4. These require a Sanitary Permit issued by the Local Health Authority. This is needed before the piggery is allowed to operate (PD 522 and 856);


#### Section 3. Locations of Piggery Farm:

3.1 For backyard piggery should be located at least 25 meters away from food establishments;


3.2 For medium scale piggery should be located 50-100 meters from build up areas (residential, commercial, institutional and industrial);





3.3 For Commercial Scale piggery should be located 500 to 1,000 meters away from build up areas (residential, commercial, institutional and industrial);

3.4 These operations always require a septic tank to ensure proper waste disposal.

3.5 There should be sufficient water supply at all times.

3.6 For Town Poblacion swine production shall be strictly prohibited within the 25 meter radius within the Municipal Poblacion.

The three Poblacion Barangays shall determine the point of reference where the 25-meter radius shall start in coordination with the Municipal Planning and Development Office (MPDO) who shall provide the technical assistance in drawing up the sketch to define the 25-meter radius.

3.7 Barangays Outside the Town Poblacion. For largely populated areas outside the Municipal Poblacion, the raiser, breeder must adopt the "Baboy Na Walang Amoy" Technology, which will be demonstrated by the Office of the Municipal Agriculture and must strictly adhere the "septic tank" policy for proper disposal of waste.

The Office of the Municipal Agriculture shall provide the necessary know-how by conducting trainings to swine raisers on the matter.

Piggery Farm that are affected by this Ordinance shall be given a grace period of one year from the effectivity of this ordinance to comply with the provisions herein stipulated.

The Barangays shall determine the point of reference where the 25-meter radius shall start in coordination with the Municipal Planning and Development Office (MPDO) who shall provide the technical assistance in drawing up the sketch to define the 25-meter radius.


**Section 4. Registration of all backyard swine producers.** All backyard and commercial swine producers, raisers, breeders must register with the








- a. Name and Address of the producer, raiser, breeder;
- b. Location where the swine production is being conducted;
- c. Number of sow, pigs being raised or bred;
- d. Sketch plan of the pig pens showing measurements;

The registration must be done at least Two (2) weeks prior to stocking. An inspection shall be done by the Monitoring Team created for the purpose to validate the veracity of the information given in the application form.

Backyard & Enhanced/Medium Scale shall be free from paying the required registration Fee.

**Section 5. Terms and Conditions for backyard piggeries, Commercial Swine Production and Breeding.** Any person who shall engage in backyard swine production, piggeries in the municipality must conform to the foregoing terms and conditions:

- a. The space requirement of the pig pens for fattening shall be at least 1x1 square meter per head;
- b. The space requirement of the pig pens for breeding shall be at least 1.5x2 square meters per head;
- c. All pig pen should have adequate source of water supply to ensure that cleanliness shall be observed at all times.


#### **Section 6. Administrative Provisions.**

In cases of unforeseen events like occurrence of African Swine Fever (ASF) proper disposal of swine population shall be in accordance with Administrative Orders promulgated by Line-agencies concerned for the purpose.





It shall be unlawful for piggery owners, swine producers to dump the waste from their piggeries to flow directly to streams, rivers, and the municipality's drainage system. For this purpose, disposal of waste in the barangays shall be through septic tank.

**Section 7. Creation of the Swine Production Monitoring Team.** For purposes of effectively and efficiently implementing this ordinance, a Swine Production Monitoring Team shall be created, to be composed of the foregoing:

- Chairman - Office of the Municipal Agriculture
- Vice-Chairman- Municipal Sanitation Inspector
- Members - Municipal Engineer
- Mun. Env't. and Nat'l. Resources Officer (MENRO)
- Municipal Treasurer
- COP, Matag-ob Police Station

The Committee shall formulate its own powers, duties and functions and it shall be approved by the Municipal Mayor.

The monitoring of the construction of the pig pen shall be done within the next One (1) month from stocking. The inspection of the pig pen shall be done before, during and after construction. To ensure that the construction conforms to standards.


**Section 8. Creation of Oversight Committee.** There shall be created an Oversight Committee who shall be tasked to formulate the Implementing Rules and Regulations (IRR) for the efficient and effective implementation of this ordinance. The oversight Committee shall be composed of the following:

- Chairman : Municipal Agriculturist
- Vice-Chairman : MENRO
- Members : Sanitation Inspector
- Municipal Planning and Dev't. Coordinator (MPDC)
- SB, Cmte. On Agriculture
- SB, Cmte. On Environment
- SB, Cmte. On Health
- Chief of Police (COP), Matag-ob Police Station




- Bureau of Fire Protection (BFP),  
Matag-ob BFP Station

**Section 9. Penal Clause.** Any person/s found violating any provision of this ordinance shall upon conviction be meted the foregoing penalties:

First offense – a fine of not less than 500.00;  
Second Offense – a fine of not less than 1,000.00;  
Third Offense – a fine of not less than 2,000.00 and suspension of one (1) year from engaging in swine production.

**Section 10. Separability Clause.** If any provision of this ordinance is found to be violation of any national laws the other parts not affected thereby shall be in full force and effect.

**Section 11. Repealing Clause.** Municipal Ordinance No. 01 series 1994 and all other ordinances inconsistent herewith is hereby repealed and/or modified accordingly.

**SECTION 12. AMENDMENTS CLAUSE** - This ordinance may be amended or modified as necessary through the appropriate legislative process.

**Section 13. Effectivity Clause.** This ordinance shall take effect upon approval.

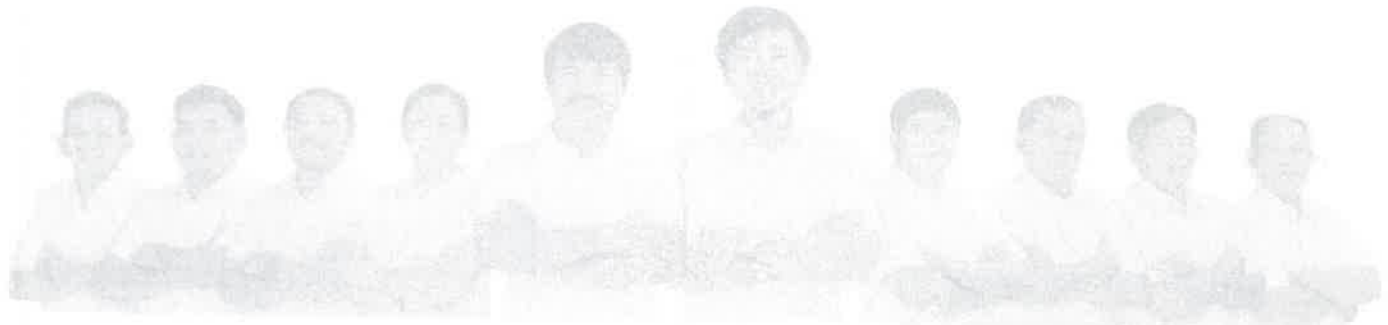

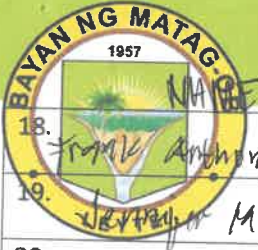
