EXPLANATORY NOTE

The 1987 Philippine Constitution in pursuance to Section 13 Article II thereof mandates that; quoted hereunder in a penultimate paragraph

"the State shall recognize the vital role of the youth in nationbuilding and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being and shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs"

AN ORDINANCE APPROVING THE INSTITUTIONALIZATION OF THE YOUTH DEVELOPMENT ACTIVITIES OF THE SANGGUNIANG KABATAAN FEDERATION OF THE MUNICIPALITY OF ABUYOG, PROVINCE OF LEYTE PROVIDING FUNDS THEREOF AND OTHER PURPOSES

BE IT ENACTED by the Sangguniang Bayan of Abuyog, Leyte in session assembled duly called for; that:

SECTION 1. TITLE. This ordinance shall be known and referred to as "The 2023 Institutionalization of the Youth Development Activities of the Sangguniang Kabataan Federation of the Municipality of Abuyog, Province of Leyte providing funds thereof and other purposes."

SECTION 2. DECLARATION OF POLICY. It is hereby declared the policy of Municipality thru the Youth Development Council to promote physical education and encourage sports program, league competitions and amateur sports including training for international competition, to foster self-discipline, teamwork and excellence for a healthy and alert citizenry;

The Municipal Government believes that physical education and sports will contribute in inculcating fundamental human values underlying in the full

development of a person.

The Municipal Government recognizes that sports development will effectively address the need for a comprehensive grassroots sport program centered on values formation inherent in the practice of sports and play (e.g. patriotism, nationalism, self-discipline, respect for law and order, hard work, teamwork, camaraderie, sportsmanship and fair play), thus, preventing a child's chances of becoming a juvenile delinquent.

SECTION 3. SCOPE AND COVERAGE. The following shall be the institutionalize youth development activities, to wit:

1st Quarter

- 1. Fire Prevention Month Socio-Cultural Activities (Fire Olympics, Poster Making & Symposiums)
- 2. Women's Month Symposium Socio-Cultural Activities (Poster Making & Symposiums)
- 3. Summer Youth Sports Festival

2nd Quarter

- Earth Month Socio-Cultural Activities (Clean-Up Drive, Tree-planting & Symposiums)
- 2. Pride Month Celebration Socio-Cultural & Sports Activities (Volleyball Tournament, Pride Parade Best in Costume, LGBTQIA+ Pageant and Symposiums)

3rd Quarter

- 1. Abuyog Youth Camp
- 2. Linggo ng Kabataan
- 3. SK Federation Night (Linggo ng Abuyog)
- 4. Youth Leadership Summit

4th Quarter

- Mental Health Month Socio-Cultural Activities (Poster Making & Symposiums)
- 2. Drug Abuse Prevention & Control Week Celebration Socio-Cultural Activities (Poster Making & Symposiums)
- 3. Year-End Assessment & Wemboree

SECTION 4. FUNDING FOR THE PROGRAM. Funding for this program shall come from the Municipality 10% Development Fund and Sports Fund.

For this purpose, the municipal local government may:

- Receive funding assistance from national agencies such as the Philippine Sports Commission (PSC) and private sectors such as private and multi-national corporations and business establishments operating in the municipality to address the need of high standard sports facilities, supplies and equipments; and
- Make representations and to receive donations, grants-in-aid and other forms of contributions whether in cash or in kind necessary for the advancement of sports development and other youth development programs of the Municipality of Abuyog, Leyte.
- 3. Include in the municipal development program the construction and provision of adequate and high standard sports facilities, supplies and equipment with the allocation of necessary funds for the same purpose; and
- 4. To improve the management, maintenance and operation of sport facilities owned and under the jurisdiction of the Municipal Local Government.

SECTION 5. INFORMATION DISSEMINATION CAMPAIGN:

Sports development cannot be achieved without information-dissemination, documentation, research and marketing, hence, the municipality shall:

- 1. Maximize the use and recognize the importance of media in promoting sports development in the locality;
- 2. Develop a data bank, records section, and sports library which will help in the proper documentation, records, management and in the conduct of research relative to sports.
- 3. Market sports not only to augment financial resources but to promote and enhance recognition of athletes, coaches, trainors, including sports organizations from among the members of the community;

To further bolster and enhance sports development in the Municipality, the Municipal Local Government in coordination with local sports organizations including private individuals and sponsors shall promote sports through the launching of sports tournaments sponsored, fully or partly, by the municipal local government for events where it has greater chances of winning in the regional, national and international competitions.

- SECTION 6. DOCUMENTATION. The Sangguniang Kabataan Federation through its Sports Coordinator shall maintain a system of the documentation of all sports competitions participated in by athletes from the municipality whether local, regional or national. The same office, in coordination with the Public Information Office, shall be tasked to document the achievement of the said athletes through photographs, videotapes and other media for future reference.
- **SECTION 7. CONTINUITY OF THE PROGRAM.** The integrated Sports Development Program, as contained in this ordinance, shall continue to be in full force and effect unless otherwise repealed, amended, or modified accordingly.
- SECTION 8. SUPPLETORY CLAUSE. This ordinance shall also include all mandatory activities of the youth with corresponding funding provided thereof in coordination with the Municipal Youth Development Council and the Municipal Local Government Operations Office of the Department of Interior and Local Government.
- **SECTION 9. SEPARABILITY CLAUSE.** If any part or provision of this ordinance maybe declared as invalid or unconstitutional by any court or competent authority, other provisions of this ordinance shall not be affected thereby and remain valid and in effect.
- **SECTION 10. EFFECTIVITY.** The provisions of this Ordinance shall take effect upon approval.

SECTION 11. REPEALING CLAUSE. Any provision, rules and regulations and/or parts thereof inconsistent with the provisions of this ordinance are hereby repealed and/or modified accordingly.
