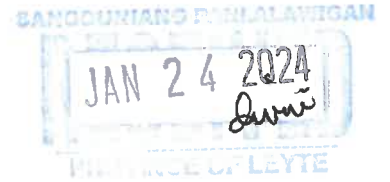

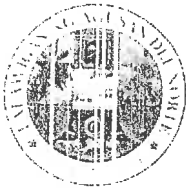

SANGGUNIAN RESOLUTION NO. 541 - 2023

RESOLUTION STRONGLY SUPPORTING SENATE BILL NO. 1378 FILED BY SENATOR MARK A. VILLAR, ENTITLED: "AN ACT PROVIDING FOR AN INCREASE AND AUTOMATIC ADJUSTMENT MECHANISM IN THE PERSONNEL ECONOMIC RELIEF ALLOWANCE (PERA) GRANTED TO GOVERNMENT EMPLOYEES" AND REQUESTING THE SENATE OF THE PHILIPPINES FOR ITS IMMEDIATE PASSAGE

WHEREAS, presented to the Sangguniang Panlalawigan of Agusan del Norte through the Provincial Vice-Governor and Presiding Officer, Hon. Enrico R. Corvera for appropriate legislative action is a letter, dated September 22, 2023 from the Provincial Governor, Honorable Ma. Angelica Rosedell M. Amante, requesting for a resolution strongly supporting Senate Bill No. 1378 filed by Senator Mark A. Villar, entitled: "An Act Providing for an Increase and Automatic Adjustment Mechanism in the Personnel Economic Relief Allowance (PERA) Granted to Government Employees";

WHEREAS, the said resolution was referred to the Committee on Human Resource Development, Labor and Employment for study, evaluation and recommendation;

WHEREAS, the said bill covers civilian government personnel at the local and national level whether elected or appointed or whether occupying regular, contractual, or casual positions, whose petitions are covered by Republic Act No. 6758 or the Compensation and Position Classification Act of 1989, the military and uniformed personnel will also receive the same amount, except for government personnel stationed abroad receive overseas allowances;

WHEREAS, earlier, the Sangguniang Panlalawigan of Agusan del Norte has adopted and approved Sanggunian Resolution No. 447 – 2023, in its 50th Regular Session, dated August 8, 2023, supporting Resolution No. 163-2023 from the Sangguniang Panlalawigan of Sorsogon, in support for the immediate passage of Senate Bill No. 1378 concerning the automatic adjustment of PERA granted to government employees from Two Thousand Pesos (₱2,000.00) to Four Thousand Pesos (₱4,000.00);

WHEREAS, the said bill is in line with Republic Act 8485, otherwise known as a Social Reform and Poverty Alleviation Act;

WHEREAS, based on the foregoing and considering the passage of said Senate Bill will greatly benefit all government employees, the committee recommends to express strong support for its immediate passage by passing a legislative measure to the Senate of the Philippines for its immediate appropriate legislative action.

NOW, THEREFORE –

BE IT RESOLVED, by the Sangguniang Panlalawigan of Agusan del Norte, in session assembled, to strongly support Senate Bill No. 1378 filed by Senator Mark A. Villar, entitled: “An Act Providing for an Increase and Automatic Adjustment Mechanism in the Personnel Economic Relief Allowance (PERA) Granted to Government Employees” and requesting the Senate of the Philippines for its immediate passage;

RESOLVED FURTHER: To furnish a copy of this resolution to the House of Senate through the Senate President, Hon. Juan Miguel Zubiri; and to Hon. Dale B. Corvera, Congressman, the House of Representatives, all of Manila, for their appropriate action; to all provinces in the country through their respective Sangguniang Panlalawigan for support; and to the Provincial Governor, Hon. Ma. Angelica Rosedell M. Amante, for information
