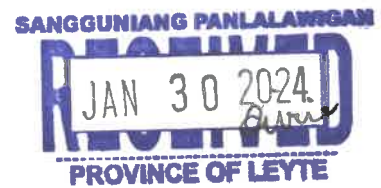

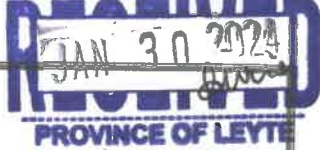

RESOLVED AS IT IS HEREBY RESOLVED, to ENACT the herein ORDINANCE:

MUNICIPAL ORDINANCE NO. 2023-30

AN ORDINANCE CREATING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO) OF THE MUNICIPALITY OF JULITA, LEYTE IN ACCORDANCE TO REPUBLIC ACT NO. 10121 OTHERWISE KNOWN AS THE PHILIPPINE DISASTER RISK REDUCTION AND MANAGEMENT ACT OF 2010.

WHEREAS, Section 2 of Republic Act No. 10121 states that to quote, "the state shall develop, promote and implement a comprehensive National Disaster Risk Reduction and Management Plan (NDRRMP) that aims to strengthen the capacity of the national government and the local government units (LGU's) together with partner stakeholders, to build the disaster resilience of communities and to institutionalize arrangements and measures for reducing disaster risks, including projected climate risk and enhancing disaster preparedness and response capabilities at all levels;"

WHEREAS, Section 76 of the Local Government Code of 1991 provides that, "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribe by the Civil Service Commission;

WHEREAS, Section 443 © of the Local Government Code likewise provides that "The Sangguniang Bayan may: (1) maintain existing offices not mentioned in subsection (a) and (b) hereof (mandatory and optional position); (2) create such other offices as may be necessary to carry out the purposes of the municipal government, or (3) consolidate the functions of any office with those of another in the interest of efficiency and economy;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Julita, Leyte in session assembled that:

Section 1. Title

This shall be known as an Ordinance Creating the Municipal Disaster Risk Reduction and Management Office (MDRRMO) of the Municipality of Julita, Leyte in accordance to Republic Act No. 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010.

Section 2. Creation of the Municipal Disaster Risk Reduction and Management Office (MDRRMO).

The Municipal Disaster Risk Reduction and Management Office (MDRRMO) is hereby created as one of the line function office of the Local Government Unit of Julita, Leyte.

Section 3. Functions of the MDRRMO

Joint Memorandum Circular No. 2014-1, of the NDRRMC, DILG, DBM and the CSC dated April 4, 2014 (Implementing Guidelines for the Establishment of Local DRRM Offices (LDRRMO's) or Barangay DRRM Committees (BDRRMC's) in Local Government Units (LGU's) specifically, 7.0 (Functions and Responsibilities of the LDRRMO or BDRRMC).

Section 4. Repealing Clause.

All previous ordinances and issuances inconsistent with this Ordinance are deemed amended or repealed.

Section 5. Effectivity.

This Ordinance shall take effect after the final review of the members of the Sangguniang Panlalawigan of Leyte and the requirement of posting is complied with.

Passed and enacted by the Sangguniang Bayan in session assembled on **December 22, 2023** Municipality of Julita, Province of Leyte, Philippines.
