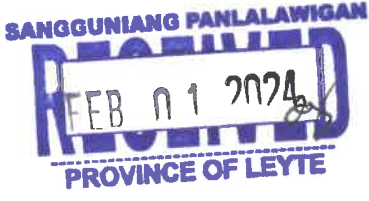

Furthermore, the opinions rendered herein are without prejudice to opinions rendered by higher authorities.

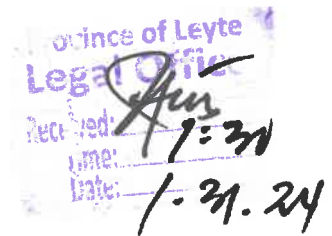

¹ Section 167. Time of Payment. - Unless otherwise provided in this Code, all local taxes, fees, and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The sanggunian concerned may, for a justifiable reason or cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months.

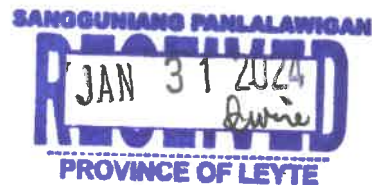



MUNICIPAL ORDINANCE NO. 2024- 01



AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF THE BUSINESS PERMIT IN THE MUNICIPALITY OF HILONGOS FROM JANUARY 20, 2024 TO MARCH 10, 2024 WITHOUT PENALTY, SURCHARGES AND INTERESTS

WHEREAS, pursuant to Section 192 of Republic Act 7160, also known as the Local Government Code of 1991, local government units may, through an ordinance duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary;

WHEREAS, Section 167 of Republic Act 7160, provides that:

"Time of Payment- unless otherwise provided in this Code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case maybe, the Sanggunian concerned may, for a justifiable reason or cause, extend the time of payment of such taxes, fees or chargers without surcharges or penalties, but only for period not exceeding six (6) months"

WHEREAS, in support to the financial recovery of business from the adverse effect on inflation, immediate increase of fuel and other related hindrances, the local government unit made consideration extending payment of regulatory fees and charges without surcharges nor penalties;

WHEREAS, there is an imperative need to extend the deadline and to give ample time for applicants who fail to meet the deadline to comply with the requirements for the renewal of business licenses;

NOW THEREFORE, on motion of Hon. Edwin F. Faller, as duly seconded by Hon. Trinidad V. Zarate

BE IT ENACTED by the 16th Sangguniang Bayan of Hilongos during its Second Regular Session assembled that:

SECTION 1. Title- The title of this ordinance shall be known "An Ordinance Extending the Deadline for the Payment of the Business Permit in the Municipality of Hilongos on January 20,2024 up to March 10, 2024.

SECTION 2. Coverage- The deadline for the payment of the Business Permit is hereby extended from January 20, 2024 up to March 10, 2024.

SECTION 3. Applicability- This ordinance shall cover all business establishments operating within the territorial jurisdiction of the Municipality of Hilongos.

SECTION 4. Repealing Clause- All ordinances, resolutions, executive orders, memorandum circulars and administrative orders are part s thereof, which are


SECTION 6. Effectivity Clause- This Ordinance shall take effect immediately upon its approval.


