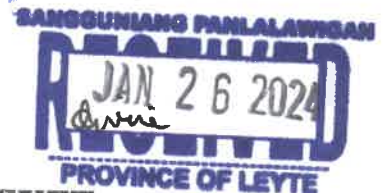

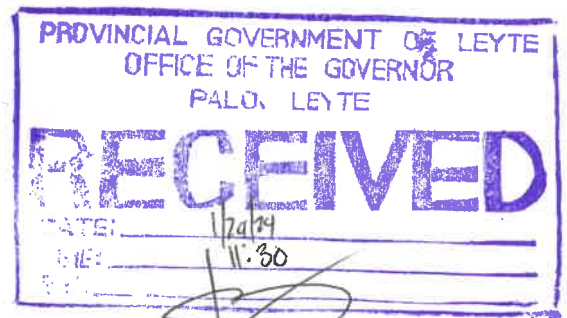

RESOLUTION NO. 2023 – 854

STRONGLY SUPPORTING SENATE BILL NO. 297 ENTITLED: “AN ACT PROVIDING AUTOMATIC PROMOTION OF GOVERNMENT OFFICIALS AND EMPLOYEES UPON RETIREMENT FROM GOVERNMENT SERVICE AND FOR OTHER PURPOSES”

WHEREAS, Senate Bill No. 297 was introduced by Senator Francis G. Escudero, entitled: “An Act Providing Automatic Promotion of Government Officials and Employees Upon Retirement from Government Service and For Other Purposes” in the Nineteenth Congress;

WHEREAS, Section 1 of the said Senate Bill No. 297 (Automatic Promotion) provides that all government officials and employees who are eligible for compulsory retirement shall be granted an automatic promotion equivalent to One Grade Level Higher than his/her position at the time of retirement, and the adjusted Salary Grade Level of the retiree shall be used as the basis for the computation of his/her retirement;

WHEREAS, Local Government Units recognizes its laudable/impressive purpose and eventually passed resolution of support stating among others that, the bill aims to give due recognition to government workers by the expedient act of promoting to One Salary Grade higher than at the time of their retirement;

WHEREAS, it is a shared/collective vision that dedicated and faithful government employees, like their counterparts in the military and the police organizations, deserve a comfortable or contented life after serving the government for twenty years (20) or more;











NOW THEREFORE, on motion of Hon. Roberto K. Canuto duly seconded, be it


