122 Presented for consideration is **Municipal Ordinance No.**
123 **2024-191** of **Carigara, Leyte** entitled : **“AN ORDINANCE**
124 **RECLASSIFYING THE 11,677 SQUARE METERS PORTION, OUT OF**
125 **THE TOTAL LAND AREA OF 12,198 SQUARE METERS IDENTIFIED**
126 **AS SURVEY NO. 4114, COVERED UNDER TAX DECLARATION NO.**
127 **08-11039-00294 AND TRANSFER CERTIFICATE OF TITLE (TCT) NO.**
128 **115-2014000454, IN THE NAME OF FERNANDO N. MORIEL,**
129 **LOCATED AT BRGY. SAGKAHAN CARIGARA, LEYTE, FROM**
130 **AGRICULTURAL TO COMMERCIAL USE.”.** Same is
131 recommended for the Local Council to follow and **adhere to**
132 **the guidelines set forth by DILG opinion No. 22** regarding
133 reclassification of the lands per 2nd indorsement dated
134 February 7, 2024 from the Provincial Legal Office.

137 Mr. Chair, will you please recognize the former Mayor of Carigara, the former
138 Congresswoman of the 2nd District, the Honorable Apostol.

139 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

140 The Honorable Apostol is recognized.

141 HON. TRINIDAD G. APOSTOL: 2ND DISTRICT BOARD MEMBER

142 Thank you, Mr. Chair. Thank you, Mr. Floor Leader.

143 Item No. 01 is Ordinance No. 2024-191 of the Municipality of Carigara, Leyte.

144 Mr. Chairman, Mr. Floor Leader, I would like to refer this particular ordinance to
145 the Land Use Committee for further study, if all the requirements for reclassification are
146 complied with, aside from the guidelines set forth by the DILG opinion No. 22 regarding
147 the reclassification of lands per 2nd Indorsement dated February 7, 2024 from the
148 Provincial Legal Office. That is my observation, Mr. Chairman, Mr. Floor Leader. Thank
149 you.

150 HON. FLAVIANO C. CENTINO, JR.: 4THDISTRICT BOARD MEMBER

151 Second.

152 HON. CARLO P. LORETO: FLOOR LEADER/5TH DISTRICT BOARD MEMBER

153 There's a motion to refer to the Committee on Land Use, Mr. Chair.

154 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

155 So, it is referred to the Committee on Land Use for further study.

156 HON. RONNAN CHRISTIAN M. REPOSAR: 1ST DISTRICT BOARD MEMBER

157 Mr. Chair, may I be recognized please.

158 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

159 Yes, the Honorable Reposar,

160 HON. RONNAN CHRISTIAN M. REPOSAR: 1ST DISTRICT BOARD MEMBER

161 I actually don't have any objection about the referral but I'd like to manifest that
162 articulated in the Minutes of the Public Hearing, referring to the reclassification of Lot
163 4114 which is the subject property of the subject ordinance. It says that in the year 2015,
164 the said property was already issued a Zoning Certification coming from the Municipal
165 Planning and Development Office, that under the Comprehensive Land Use Plan of the
166 Municipality of Carigara, the said property is already situated or located within the
167 Commercial Zone of the said municipality.

168 With that being said, I'd like to manifest, since this matter has been referred to the
169 committee, for the Sangguniang Bayan or the applicant of the reclassification, to produce
170 the specific provisions of the Comprehensive Land Use Plan declaring such property as
171 a Commercial Zone. Because, in that case, if there's already an approved
172 Comprehensive Land Use Plan and it has been legislated, I don't think that they would
173 still need another ordinance for the reclassification, if and when there's indeed an
174 approved CLUP which has been legislated. This is just for my reference and to facilitate
175 the drafting of the necessary report. Thank you very much, Mr. Chair and Mr. Floor
176 Leader.

177 HON. TRINIDAD G. APOSTOL: 2ND DISTRICT BOARD MEMBER

178 Mr. Chairman.

179 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

180 Yes, the Honorable Apostol.

183 HON. TRINIDAD G. APOSTOL: 2ND DISTRICT BOARD MEMBER

184 Conversion is needed to change the current use of the reclassified land. So, there
185 should be a conversion. That's my observation. So, we have to refer this for further
186 study, with all the requirements which have already been made. Conversion is needed to
187 change the current use of reclassified land.

188 HON. RONNAN CHRISTIAN M. REPOSAR: 1ST DISTRICT BOARD MEMBER

189 It will be taken, Honorable Chair. We'll still look into the requirements. Actually, the
190 jurisprudence, Supreme Court held in relation to reclassification and that's actually
191 agreed, as pointed out by Honorable Apostol, that reclassification alone will not suffice to
192 change the current use of the land. But the Minutes actually submitted say that it has
193 been for so long that the use of the said property is already commercial and residential
194 since it is along the national highway. That's the reason why I'm requesting that the
195 Sangguniang Bayan of Carigara or the applicant furnish us the specific section or
196 provisions under the Comprehensive Land Use Plan of the Municipality of Carigara, that
197 said property is situated within the Commercial Zone of the municipality.

198 I agree with the Honorable Apostol that the minimum requirements under the
199 Local Government Code and issuances from the Department of Agrarian Reform will be
200 considered. Hence, I didn't object with the referral of the same to my committee. Well
201 noted po, Honorable Chair and Honorable Majority Floor Leader and Honorable Apostol.
202 We will look into the requirements also. Thank you very much.

203 HON. CARLO P. LORETO: FLOOR LEADER/5TH DISTRICT BOARD MEMBER

204 Mr. Chair.

205 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

206 Yes, the Honorable Loreto.

207 HON. CARLO P. LORETO: FLOOR LEADER/5TH DISTRICT BOARD MEMBER

208 I would just like to add comment. If it is really true that the subject property has
209 been used for residential and commercial purposes for some time now, the implication is
210 that the provincial government has been deprived of taxes due on the property. Why do I
211 say this? Because commercial lots which are commercial in character are tax doubled

212 than that of the agricultural. So, it is imperative that we determine if indeed the property
213 is already commercial or residential in use. Because this has tax consequences on the
214 coffers of the provincial government, that's just my take on the matter, Mr. Chair.

215 HON. TRINIDAD G. APOSTOL: 2ND DISTRICT BOARD MEMBER

216 Mr. Chairman.

217 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

218 Yes, the Honorable Apostol.

219 HON. TRINIDAD G. APOSTOL: 2ND DISTRICT BOARD MEMBER

220 Now, as I observe, since I am from Carigara, this particular land that is being
221 converted from agricultural to commercial is very far from the commercial center. This is
222 located in one of the barangays in Sagkahan. So, I do not consider a barangay in
223 Sagkahan a commercial center. But it is in the highway that is correct. That is my
224 observation. So, I think we need a conversion for this, if all the requirements have
225 already been made. Thank you so much, Mr. Floor Leader, Mr. Chairman.

226 HON. VINCENT L. RAMA: 4TH DISTRICT BOARD MEMBER

227 Mr. Floor Leader.

228 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

229 Yes, the Honorable Rama.

230 HON. VINCENT L. RAMA: 4TH DISTRICT BOARD MEMBER

231 I just want to be clarified. This property in the Municipality of Carigara, am I on the
232 understanding that the municipality has been receiving tax payment as a commercial and
233 residential?

234 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

235 Agricultural pa.

236 HON. VINCENT L. RAMA: 4TH DISTRICT BOARD MEMBER

237 Agricultural pa. So, it's clear that they're paying taxes as an agricultural land.

238 Okay. Thank you.

239 HON. CARLO P. LORETO: FLOOR LEADER/5TH DISTRICT BOARD MEMBER

240 Mr. Chair, there's a motion, duly seconded.

241 If there are no more further discussions, may we request for a ruling?
242 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

243 So, what would be the pleasure of the Body?

244 HON. RONNAN CHRISTIAN M. REPOSAR: 1ST DISTRICT BOARD MEMBER

245 Refer to the Committee on Land Use, Mr. Chair.

246 I submit to all the manifestations and observations.

247 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

248 Okay.

249 So, Item No. 1, is referred to the Committee on Land Use.

258 **PRIORITIZING THE PANTAWID PAMILYANG PILIPINO EXITED**
259 **HOUSEHOLDS IN THE DELIVERY OF SERVICES BY THE**
260 **MUNICIPALITY OF LA PAZ, LEYTE AND MANIFESTING**
261 **COMMITMENT TO ADOPT REPUBLIC ACT 11310 OTHERWISE**
262 **KNOWN AS “AN ACT INSTITUTIONALIZING THE PANTAWID**
263 **PAMILYANG PILIPINO PROGRAM (4Ps)”**. Same is
264 recommended for the declaration of **VALIDITY** by the
265 Provincial Legal Office per 2nd indorsement dated February
266 13, 2024.

269 Presented for consideration is **Municipal Ordinance No.**
270 **02 Series of 2024** of **La Paz, Leyte** entitled : **“AN ORDINANCE**
271 **ESTABLISHING AN ANIMAL BITE TREATMENT CENTER UNDER THE**
272 **MUNICIPAL HEALTH OFFICE OF THE MUNICIPALITY OF LA PAZ,**
273 **PROVINCE OF LEYTE AND PROVIDING FUNDS THEREFOR”**. Same
274 is recommended for the declaration of **VALIDITY** by the
275 Provincial Legal Office per 2nd indorsement dated February
276 13, 2024.

278 HON. CARLO P. LORETO: FLOOR LEADER/5TH DISTRICT BOARD MEMBER

279 Mr. Chair, the Honorable Villasin, for Item Nos. 2 and 3.

280 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

281 The Honorable Villasin is recognized.

282 HON. RAISSA J. VILLASIN: 2ND DISTRICT BOARD MEMBER

283 Item Nos. 2 and 3, are both coming from the Municipality of La Paz, Leyte.

284 Item No. 2 is Municipal Ordinance No. 01, series of 2024, an Ordinance
285 prioritizing the Pantawid Pamilyang Pilipino exited households in the delivery of services
286 by the Municipality of La Paz, Leyte and manifesting commitment to adopt Republic Act
287 11310 Otherwise Known as "An Act Institutionalizing the Pantawid Pamilyang Pilipino
288 Program (4Ps).

289 Item No. 3, is Municipal Ordinance No. 02, series of 2024, and Ordinance
290 establishing an Animal Bite Treatment Center under the Municipal Health Office of the
291 Municipality of La Paz, Leyte and providing funds therefore.

292 Both Ordinances have been reviewed by the Provincial Legal Office. Item No. 2
293 has been recommended for the declaration of its validity pursuant to its power under
294 Section 56 (c) of Republic Act 7160, as the opinion of the Provincial Legal Office it is an
295 exercise of the power authorized under Section 16 of the Code in conjunction with the
296 provisions of RA 11310, which is an act institutionalizing the PantawidPamilyang Pilipino
297 Program.

298 Furthermore, for Item No. 3, it is also recommended for the declaration of its
299 validity pursuant to its power under Section 56 (c) of RA 7160, to the opinion of the
300 Provincial Legal Office, an exercise of the power authorized under Section 16 of the
301 Code in relation to RA 9482, which is an act providing for the controlling elimination of
302 human and animal rabies, prescribing penalties for violation thereof and appropriating
303 funds therefore.

304 If my motion is in order, I move to declare valid, Municipal Ordinance No.01,
305 series of 2024 and Municipal Ordinance No. 02, series of 2024, both coming from the
306 Municipality of La Paz, Leyte. I so move.

307 HON. RONNAN CHRISTIAN M. REPOSAR: 1ST DISTRICT BOARD MEMBER

308 Second.

309 HON. TRINIDAD G. APOSTOL: 2ND DISTRICT BOARD MEMBER

310 Mr. Chair.

311 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

312 The Honorable Apostol.

313 HON. TRINIDAD G. APOSTOL: 2ND DISTRICT BOARD MEMBER

314 The beneficiaries of the program should be the one to receive this benefit coming
315 from the 4Ps. Because I had observed, when I was the Mayor of Carigara, there were so
316 many complaints that some of the beneficiaries were not really the indigent ones. If you
317 are a friend of the one listing the beneficiaries you will be listed even if you are not
318 qualified under the program.

319 So, may I add that the Municipality of La Paz should check the proper
320 beneficiaries of this program. See to it that the one receiving this benefit should be the
321 right one and those classified under the program. Thank you, Mr. Chairman. Thank you,
322 Floor Leader.

323 HON. CARLO P. LORETO: FLOOR LEADER/5TH DISTRICT BOARD MEMBER

324 Any other discussion?

325 If there is none, Mr. Chair, may we request for a ruling?

326 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

327 So, there's a motion of Honorable Villain.

328 Any more discussion regarding Items 2 and 3?

329 Any more questions?

330 HON. TRINIDAD G. APOSTOL: 2ND DISTRICT BOARD MEMBER

331 Mr. Chairman, as I have said the Municipality of La Paz should check the proper
332 beneficiaries of this program because there are so many beneficiaries receiving which
333 are not really indigent.

334 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

335 The Department of Social Work and Development (DSWD) should be the one
336 checking it and they are the ones approving it.

337

338 HON. MA. MARTINA L. GIMENEZ: PROVL. LIGA NG MGA BARANGAY PRESIDENT

339 Mr. Chair.

340 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

341 Yes, the Honorable Gimenez.

342 HON. MA. MARTINA L. GIMENEZ: PROVL. LIGA NG MGA BARANGAY PRESIDENT

343 Mr. Chair, based on my experience with regards to the listing of the 4Ps especially
344 in the barangays, we've been told constantly that the determination of the qualifications
345 for being a 4Ps members lies within the Department of Social Welfare and Development
346 (DSWD).

347 HON. TRINIDAD G. APOSTOL: 2ND DISTRICT BOARD MEMBER

348 That's correct. But Mr. Chairman, there are some cases which I observed being
349 the mayor, the DSWD personnel having the listings, they just put there, they don't even
350 investigate whether they are really the beneficiaries of such program. There should be a
351 checking.

352 HON. MICHAEL L. CARI: TEMP. PRESIDING OFFICER/5TH DIST. BOARD MEMBER

353 Okay.

354 The motion is duly seconded.

365 **ADMINISTRATIVE ASSISTANT III (PRIVATE SECRETARY II) ITEM 159,**
366 **SG-15 UNDER THE SAME OFFICE, THIS MUNICIPALITY, PROVIDING**
367 **FOR ITS QUALIFICATIONS, DEFINING ITS DUTIES AND FUNCTIONS**
368 **AND APPROPRIATING FUNDS THEREFOR."** Same is recommended

375 Honorable Chingay Kabigting, you are recognized.

376 HON. MARIE KATHRYN V. KABIGTING: 3RD DISTRICT BOARD MEMBER

377 Thank you, Mr. Chair, Mr. Floor Leader.

378 Under the agenda No. 4 is a Municipal Ordinance coming from San Isidro, Leyte,

379 an Ordinance Abolishing The Plantilla Position of Supervising Administrative Officer Item

380 No. 95, Sg-22 Under the Office Of The Municipal Mayor and Creating the Plantilla

381 Position of Senior Administrative Assistant III (Private Secretary II) Item 159, SG-15
