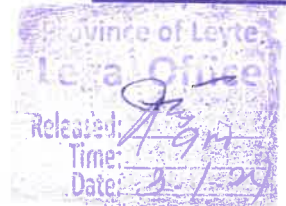


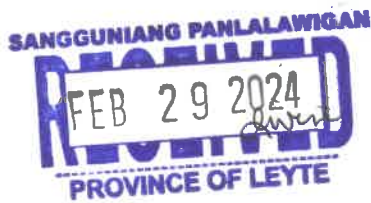

2nd INDORSEMENT
February 27, 2024

Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 2023-10 of the Sangguniang Bayan of Tabango, Leyte, recommending for the declaration of its validity, pursuant to its power under Section 56 (C) of R.A. 7160, to the opinion of the Provincial Legal Office (PLO), an exercise of the power authorized under Section 447(a)(1)(vii) and (vii)ⁱ, provided that the creation of the New Plantilla Positions does not violate the prohibition under Section 325(a) and (g)ⁱⁱ of the Code.

Furthermore, the opinions rendered herein are without prejudice to opinions rendered by higher authorities.

ⁱ (vii) Subject to the provisions of this Code and pertinent laws, determine the powers and duties of officials and employees of the municipality;
(viii) Determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government;

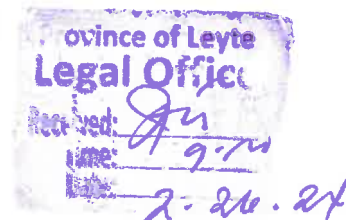
ⁱⁱ (a) The total appropriations, whether annual or supplemental, for personal services of a local government unit for one (1) fiscal year shall not exceed forty-five percent (45%) in the case of first to third class provinces, cities and municipalities, and fifty-five percent (55%) in the case of fourth class or lower, of the total annual income from regular sources realized in the next preceding fiscal year. The appropriations for salaries, wages, representation and transportation allowances of officials and employees of the public utilities and economic enterprises owned, operated, and maintained by the local government unit concerned shall not be included in the annual budget or in the computation of the maximum amount for personal services. The appropriations for the personal services of such economic enterprises shall be charged to their respective budgets;

g) The creation of new positions and salary increases or adjustments shall in no case be made retroactive;



AN ORDINANCE CREATING THE NEW PLANTILLA POSITIONS UNDER THE OFFICE OF THE MAYOR, MUNICIPAL ENVIRONMENTAL AND NATURAL RESOURCES OFFICE, MUNICIPAL ACCOUNTANT OFFICE IN THE MUNICIPAL GOVERNMENT OF TABANGO, PROVINCE OF LEYTE, PROVIDING FOR ITS QUALIFICATIONS, DUTIES AND FUNCTIONS AND APPROPRIATING THE NECESSARY FUNDS THEREOF.

BE IT ENACTED BY THE SANGGUNIANG BAYAN, IN SESSION DULY ASSEMBLED, THAT:

SECTION 1. CREATION AND QUALIFICATION STANDARDS - The following plantilla positions are hereby created with their respective salary grades, and qualification standards, to wit:

SECTION 2. POWERS, DUTIES, AND FUNCTIONS - The powers, duties, and functions of the above-stated positions shall be based on the Civil Service Commission Qualification Standards (CSC) and other relevant laws, rules, and regulations.

Section 3. FUNDING -The newly created position is made an integral part of the Plantilla of Positions of the Local Government Unit of Tabango and shall be funded accordingly.


Section 4. SEPARABILITY CLAUSE - If for any reason/s, any part of the provision of this ordinance shall be held unconstitutional or otherwise invalid, other parts or provisions hereof which are not affected thereby shall be in full force and effect.

Section 5. EFFECTIVITY CLAUSE - This ordinance shall take effect upon its approval.


