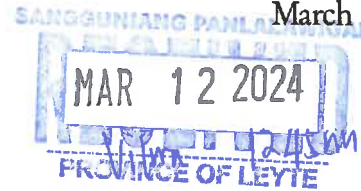

**ORDER**

On 15 January 2024, Energy Development Corporation (EDC) and Don Orestes Romualdez Electric Cooperative, Inc. (DORELCO) filed a *Joint Application*, dated 07 August 2023, seeking the Commission's approval of their Emergency Power Supply Agreement (EPSA), with motion for confidential treatment of information.

On 14 February 2024, the Commission issued an *Order* and a *Notice of Virtual Hearing* setting the case for hearing on the following dates: 14 March 2024 for the determination of compliance with the jurisdictional requirements and expository presentation; and 21 March 2024 for the pre-trial conference and presentation of evidence.

However, on 23 February 2023, Applicants filed a *Manifestation and Motion to Reset Initial Hearing* on the ground that Applicant EDC received the said *Order* and *Notice* only on 22 February 2024. Hence,

the Applicants would not have sufficient time to comply with the publication requirements as part of the jurisdictional requirements set forth in the said *Order*. Given the foregoing, the Applicant EDC prayed that the initial hearings be cancelled and rescheduled on a later date.

The Commission finds the *Urgent Manifestation with Motion to Reset Initial Hearing* dated 23 February 2024 filed by Applicant EDC in order. Accordingly, the same is hereby **GRANTED**.

**IN VIEW THEREOF**, the hearings set on 14 March 2024 and 21 March 2024 are hereby **CANCELLED**.

Consequently, the Commission hereby sets the instant *Joint Application* for determination of compliance with the jurisdictional requirements, expository presentation, Pre-trial Conference, and presentation of evidence on the following dates and online platforms for the conduct thereof, pursuant to Resolution No. 09, Series of 2020<sup>1</sup> and Resolution No. 01, Series of 2021<sup>2</sup> (ERC Revised Rules of Practice and Procedure):

Accordingly, DORELCO and EDC are hereby directed to host the virtual hearings at **DORELCO's Principal Office located at Barangay San Roque, Tolosa, Leyte, Philippines**, as the designated venue for the conduct thereof, and ensure that the same is open to the public. Moreover, DORELCO and EDC shall guarantee that, during the conduct of the expository presentation, the participation of the public shall not be impaired.

**RELATIVE THERETO**, DORELCO and EDC are hereby directed to:

- 1) Cause the publication of the attached *Notice of Virtual Hearing* in two (2) newspapers of nationwide circulation in the Philippines at their own expense, twice (2x) within two (2) successive weeks, the dates of publication not being less than seven (7) days apart, and the date of the last publication to be made not later than ten (10) days before the date of the scheduled initial hearing;
- 2) Furnish with copies of this *Order* and the attached *Notice of Virtual Hearing* the Offices of the Provincial Governor, the Mayors and the Local Government Unit (LGU) legislative bodies within DORELCO's franchise area for the appropriate posting thereof on their respective bulletin boards;
- 3) Inform the consumers within DORELCO's franchise area, by any other means available and appropriate, of the filing of the *Joint Application*, their reasons therefor, and of the scheduled virtual hearings thereon;
- 4) Furnish with copies of this *Order* and the attached *Notice of Virtual Hearing*, the Office of the Solicitor General (OSG), the Commission on Audit (COA), and the Committees on Energy of both Houses of Congress. They are hereby requested, if they so desire, to send their duly authorized representatives and attend the scheduled hearings; and
- 5) Furnish with copies of the *Joint Application* and its attachments, except those subject of a motion for confidential treatment of information, all those making requests therefor, subject to reimbursement of reasonable photocopying costs.

**Within five (5) calendar days** prior to the date of the initial virtual hearing, Applicants DORELCO and EDC must submit to the Commission via electronic mail (e-mail) at [docket@erc.ph](mailto:docket@erc.ph), and copy furnish the Legal Service through [legal@erc.ph](mailto:legal@erc.ph), the scanned copies of their written compliance with the aforementioned jurisdictional requirements attaching the following methodically arranged and duly marked documents:

- 1) The evidence of publication of the attached *Notice of Virtual Hearing* consisting of affidavits of the Editors or Business Managers of the newspapers where the said *Notice of Virtual Hearing* was published, and the complete issues of the said newspapers;
- 2) The evidence of actual posting of this *Order* and the attached *Notice of Virtual Hearing* consisting of certifications issued to that effect, signed by the aforementioned Governor, Mayors and LGU legislative bodies or their duly authorized representatives, bearing the seals of their offices;
- 3) The evidence of other means employed by Applicants DORELCO and EDC to inform the consumers within the affected franchise area of the filing of the *Application*, their reasons therefor, and of the scheduled hearings thereon;
- 4) The evidence of receipt of copies of this *Order* and the attached *Notice of Virtual Hearing* by the OSG, the COA, and the Committees on Energy of both Houses of Congress;
- 5) The evidence of receipt of copies of the *Joint Application* and its attachments, except those subject of a motion for confidential treatment of information, by all those making requests therefor, if any; and
- 6) Such other proofs of compliance with the requirements of the Commission.

Moreover, Applicants DORELCO and EDC are hereby required to post on their respective bulletin boards, the scanned copies of the foregoing jurisdictional requirements, together with the newspaper publication and certifications issued by the concerned Office of the Provincial Governor, Mayors, and Local Legislative Bodies, and to submit proof of posting thereof.

Applicants DORELCO and EDC and all interested parties are also required to submit via e-mail at [docket@erc.ph](mailto:docket@erc.ph), and copy furnish the Legal Service through [legal@erc.ph](mailto:legal@erc.ph), at least five (5) calendar days before the date of the scheduled virtual hearing and Pre-trial Conference, their respective Pre-Trial Briefs containing, among others:

- 1) A summary of admitted facts and proposed stipulation of facts;

- 2) The issues to be tried or resolved;
- 3) The documents or exhibits to be presented, stating the purposes and proposed markings therefor; and
- 4) The number and names of the witnesses, with their written testimonies in a Judicial Affidavit form attached to the Pre-trial Brief.

Applicants DORELCO and EDC must ensure that all the documents or exhibits proposed to be presented have already been duly submitted to the Commission **at least five (5) calendar days** before the date of the scheduled virtual hearing and Pre-trial Conference, pursuant to the preceding paragraph.

Failure of Applicants DORELCO and EDC to comply with the above requirements within the prescribed period shall be a ground for cancellation of the scheduled hearings.

Applicants DORELCO and EDC must also be prepared to make an expository presentation of the instant *Joint Application*, aided by whatever communication medium that they may deem appropriate for the purpose, in order to put in plain words and explain, for the benefit of the consumers and other concerned parties, the nature of the *Joint Application* with relevant information and pertinent details substantiating the reasons and justifications being cited in support thereof.

Applicants DORELCO and EDC are hereby directed to file a copy of their Expository Presentations via e-mail at [docket@erc.ph](mailto:docket@erc.ph), copy furnish the Legal Service through [legal@erc.ph](mailto:legal@erc.ph), **at least five (5) calendar days** prior to the scheduled virtual hearing. DORELCO and EDC shall also be required, upon the request of any stakeholder, to provide an advance copy of their expository presentations, **at least five (5) calendar days** prior to the scheduled virtual hearing.

Applicants DORELCO and EDC are further directed to submit, either through personal service, registered mail or ordinary mail/private courier, one (1) set of the original or certified true hard copies of its Jurisdictional Compliance, Expository Presentation, Pre-trial Brief, and Judicial Affidavits of witnesses, **within five (5) working days** from the date that the same were electronically submitted, as reflected in the acknowledgment receipt e-mail sent by the Commission.

**NOTICE OF VIRTUAL HEARING**

**TO ALL INTERESTED PARTIES:**

Notice is hereby given that on 15 January 2024, Energy Development Corporation (EDC) and Don Orestes Romualdez Electric Cooperative, Inc. (DORELCO) filed a *Joint Application (With Motion for Confidential Treatment of Information)* dated 07 August 2023 (Joint Application), seeking the Commission's approval of their Emergency Power Supply Agreement (EPSA), with motion for confidential treatment of information.

The pertinent allegations of the said *Joint Application* are hereunder quoted as follows:

1. Applicant DORELCO is a non-stock, non-profit electric cooperative duly organized and existing under and by virtue of

the laws of the Philippines, with principal office at Barangay San Roque, Tolosa, Leyte, Philippines, where it may be served with summons and other legal processes. DORELCO is represented here by its General Manager, Allan L. Laniba, who has been authorized by its Board of Directors to file the Joint Application as evidenced by the Board Resolution dated February 10, 2023, attached hereto as Annex "B-1".

2. Applicant EDC is a generation company duly organized, incorporated and registered under and by virtue of the laws of the Philippines, with principal office at Rockwell Business Center Tower 3, Ortigas Avenue, Pasig City, represented in this instance by its by its Vice President, Marvin Kenneth S. Bailon, who has been authorized by its Board of Directors to file the Joint Application as evidenced by the Secretary's Certificate dated October 13, 2022, attached hereto as Annex "D-1".
  - 2.1 EDC, as a generation company, falls within the ambit of Sections 6 and 29 of Republic Act No. 9136 or the Electric Power Industry Reform Act of 2001 ("EPIRA").
  - 2.2 Pursuant to the Honorable Commission's Resolution No. 02, Series of 2015 requiring distribution utilities and generation companies to jointly file applications for the approval of power supply agreements, EDC has joined in this Application as a co-applicant.
  - 2.3 While EDC is a co-applicant, it manifests that this Joint Application shall neither modify, diminish, nor constitute as a waiver of EDC's rights nor expand its obligations and responsibilities as a generation company under the EPIRA.
3. Applicant DORELCO is the exclusive franchise holder to own and operate a system for the distribution of electricity in the Municipalities of Tolosa, Tanauan, Dagami, Tabon-Tabon, Burauen, Julita, Lapaz, Dulag, Mayorga, Macarthur, Javier, Abuyog, Mahaplag, all in the Province of Leyte.
4. Applicant EDC owns and operates the approximately 592.33 MW Unified Leyte Geothermal Power Plant located in the Ormoc City and Kananga, Leyte ("Plant").
5. The Joint Applicants may be served with the orders, notices, and other processes of the Honorable Commission through their respective undersigned counsels at the address indicated herein.

#### NATURE OF THE APPLICATION

6. This is a Joint Application for the approval of the Emergency Power Supply Agreement ("EPSA") entered into by and between DORELCO and EDC, being submitted to this Honorable Commission for its review and approval.

STATEMENT OF FACTS

7. DORELCO is in immediate need of a 2MW contracted capacity for around one (1) year<sup>1</sup>. To maintain an uninterruptible and reliable power supply due to a high level of supply deficit of at least 2 MW, DORELCO decided to source the needed power at affordable and cheaper generation rates to help minimize the exposure of its customers to volatile Wholesale Electricity Spot Market ("WESM") prices.
8. Pursuant to Department of Energy ("DOE") Department Circular 2018-02-003, as amended by DC 2021-09-0030, DORELCO is allowed to enter into a negotiated procurement of emergency electric power supply agreements with a generation company for a period not exceeding one (1) year subject to such terms and conditions provided under Section 2.2.1.2 of DC 2021-09-0030.
9. DORELCO wrote to the DOE requesting for the issuance of Certificate of Exemption for a negotiated procurement of 2MW emergency power supply from EDC. The Letter expressed DORELCO's urgent need for supply of electricity due to circumstances beyond the control of DORELCO, and the limited time to conduct the said Competitive Selection Process ("CSP").
10. On 31 August 2022, DOE, in response to DORELCO's letter-request, issued Certificate of Exemption No. COE-CSP-2022-08-038, exempting it from the conduct of the CSP for the procurement of emergency electric power supply.
11. In view of DORELCO's supply deficit of at least 2MW for the period of 26 August 2022 to 25 August 2023, based on its Supply-Demand Scenario, and to protect its consumers from high electricity prices, DORELCO solicited for emergency power supply for one (1) year.
12. In response to DORELCO's demand, EDC has offered to supply a portion of the emergency electric power supply requirements of DORELCO at a rate equivalent to or lower than the ERC-approved generation tariff for the same or similar technology in comparable areas, and DORELCO has accepted the offer of EDC. Applicants executed the subject Emergency Power Supply Agreement ("EPSA") for the supply of 2 MW emergency power supply to DORELCO<sup>2</sup>.

**ABSTRACT OF THE POWER SUPPLY AGREEMENT AND  
RELATED INFORMATION**

13. Under the EPSA, EDC shall supply power to DORELCO for the term of the Cooperation Period, or unless sooner terminated pursuant to the EPSA, with a Contracted Capacity of 2 MW.<sup>3</sup>
- 13.1 Supply of Electricity – EDC shall make available to DORELCO the Contracted Capacity from the Power Plant and/or Other Sources throughout the duration of the Cooperation Period, subject to Section 2.2.1 of the EPSA. The Parties agree that EDC shall have no obligation to supply more than the Contracted Capacity to DORELCO. DORELCO shall submit to EDC the week-ahead and day-ahead Daily Generation Schedule. DORELCO shall purchase and EDC shall supply, for each Billing Month in accordance with Nomination and Dispatch Protocol.
- 13.2 Purchase of Electricity – DORELCO is obliged to purchase the Minimum Contracted Energy throughout the duration of the Cooperation Period.
- 13.3 Start of Supply of Electricity – The supply of electricity by EDC and acceptance by DORELCO shall start no later than Initial Delivery Date which shall mark the beginning of the Cooperation Period or such earlier date as the Parties may mutually agree upon in writing, and the satisfaction of the conditions precedent under Section 11 of the EPSA.
- 13.4 Electricity Fees – Electricity fees shall be 5.8798 PhP/kWh for the billing period August 26, 2022 to December 25, 2022. Beginning January 2023 billing period, the Electricity Fee shall be in accordance with the formula in Schedule 3, multiplied by (a) the Minimum Contracted Energy corresponding for the applicable billing period or (b) BCQ, whichever is higher. In relation to the supply of electricity, it is understood that any charges, costs, expenses, and fees that may be charged to, incurred and/or assumed by EDC or otherwise imposed by NGCP, any Governmental Authority or any third party, for transmission and/or Ancillary Services and other related services in connection with the delivery of electricity under the EPSA shall be paid by DORELCO.

**RATE IMPACT ANALYSIS**

14. DORELCO simulated a rate impact analysis which resulted in a Php 0.9046/kWh decrease with the execution of the EPSA with EDC, as can be seen below:
