

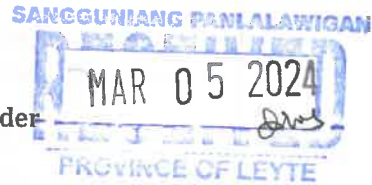

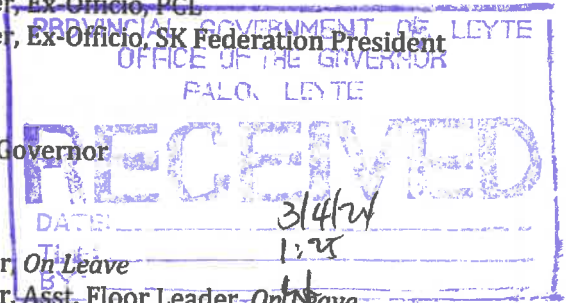

RESOLUTION NO. 2024-005

**URGING ALL PROVINCIAL SANGGUNIANs OF THE REPUBLIC OF THE PHILIPPINES, ALL SANGGUNIANG PANLUNGSOD, ALL SANGGUNIANG BAYAN, AND ALL BARANGAY COUNCILS TO PASS SIMILAR RESOLUTIONS URGING CONGRESS TO AMEND THE LOCAL GOVERNMENT CODE OR THE REPUBLIC ACT 7160 IN PARTICULAR SECTIONS RELATIVE TO THE IMPOSITION OF FINES AND PENALTIES AS HEREIN SPECIFIED.**

"WHEREAS, it was moved by Hon. Venzencio B. Arcamo during the SP Regular Session held on January 2, 2024, urging all Provincial Sanggunians of the Republic of the Philippines, all Sangguniang Panlungsod, all Sangguniang Bayan, and all Barangay Councils to pass similar Resolutions urging Congress to amend the Local Government Code or the Republic Act 7160 in particular sections as herein specified;

"WHEREAS, Hon. Venzencio B. Arcamo asserted that the increase of the rates of fines is necessary and imperative since it was first implemented thirty-two years ago in 1992;

"WHEREAS, Hon. Venzencio B. Arcamo manifested to amend the Local Government Code or the Republic Act 7160, particularly Section 447(a)(1). The power of the Sangguniang Bayan to impose fine and penalty, particularly (a), (1) and (iii), increasing the power of the Sangguniang Bayan to impose penalty as a fine as a maximum, from Two Thousand Five Hundred Pesos (P2,500) to Twenty-Five Thousand Pesos (P25,000). For Section 458, the power of the City to



impose fine as a penalty, particularly Letter (a) of that Section 1(iii), from Five Thousand Pesos (P5,000) to Fifty Thousand Pesos (P50,000). Similarly, Section 468 of the Local Government Code, (a)(1)(iii), power of the Province to impose fine as a penalty, as maximum, from (P5,000) to (P50,000), and lastly for Barangays, Section 391, Letter (a), Par. No. 14, from One Thousand Pesos (P1,000) to Ten Thousand Pesos (P10,000) as maximum to impose fines as penalty for the Barangays;

"WHEREAS, this Body finds merit in the said motion and approves the same;

"WHEREFORE, be it resolved, as it is hereby resolved, by the Sangguniang Panlalawigan of Bohol in session duly assembled -

That all Provincial Sanggunians of the Republic of the Philippines, all Sangguniang Panlungsod, all Sangguniang Bayan, and all Barangay Councils are hereby urged to pass similar Resolutions urging Congress to amend the Local Government Code or the Republic Act 7160 in particular sections relative to the imposition of fines and penalties as herein specified.

"RESOLVED FURTHER, to furnish copies of this Resolution to all concerned for their information and appropriate action;
