

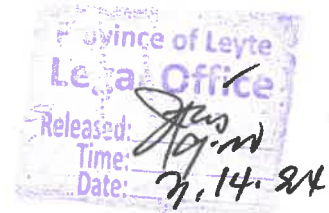

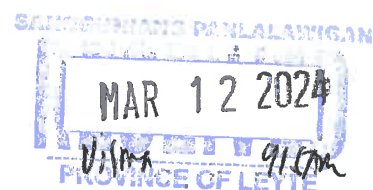



“AN ORDINANCE INSTITUTIONALIZING THE OFFICIAL LOGO OF THE SANGGUNIANG KABATAAN OF ALANGALANG, LEYTE”

APPROVED on 3rd and Final reading on November 28, 2023

On motion of SB Member JAN REIAN NIÑO C. SAAVEDRA and seconded in mass by all Sangguniang Bayan who's Present.

SECTION 1. TITLE

This ordinance shall be known as the “Ordinance Institutionalizing the Official Logo of the Sangguniang Kabataan of Alangalang, Leyte.”

SECTION 2. DECLARATION OF POLICY - It is hereby declared the policy of the Sangguniang Kabataan (SK) of Alangalang, Leyte, to adopt and institutionalize the official logo as a symbol that represents the identity, unity, and aspirations of the youth in the locality.

SECTION 3. OFFICIAL LOGO DESCRIPTION - The official logo of the Sangguniang Kabataan of Alangalang, Leyte, shall consist of a golden bell with the SK Logo incorporated within it. The design and elements of the logo are hereby defined and attached as Annex A to this ordinance.

SECTION 4. USE OF THE OFFICIAL LOGO

a. The official logo shall be prominently displayed in all official documents, correspondence, and publications of the Sangguniang Kabataan of Alangalang.

b. The official logo shall be used in official events, programs, and activities organized by the Sangguniang Kabataan.

SECTION 5. PROHIBITED USE - Unauthorized use, reproduction, or alteration of the official logo is strictly prohibited. Any individual or entity found in violation of this provision shall be subject to appropriate legal action.

SECTION 6. REPRODUCTION GUIDELINES - The Sangguniang Kabataan of Alangalang shall establish guidelines for the proper reproduction and usage of the official logo to ensure its integrity and consistency.

SECTION 7. IMPLEMENTATION - The Sangguniang Kabataan of Alangalang shall take necessary actions to implement the provisions of this ordinance.

SECTION 8. REPEALING CLAUSE - All Ordinance, executive orders, issuances including rules and regulations inconsistent with this ordinance are hereby repealed and/or in modified accordingly.

SECTION 9. SEPERABILITY CLAUSE - If provision of this ordinance is declared invalid, the remaining or any provision herein not affected thereby shall remain in force and effect.

SECTION 10. EFFECTIVITY - This ordinance shall take effect fifteen (15) days after its approval.






