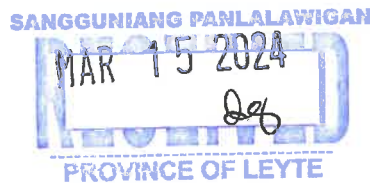

Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 01, Series 2024 of the Sangguniang Bayan of Alangalang, Leyte, recommending for the declaration of its validity, pursuant to its power under Section 56 (C) of R.A. 7160, to the opinion of the Provincial Legal Office (PLO), an exercise of the power under Section 336ⁱ of the Local Government Code, provided that the augmented savings be within the same expense class of their respective appropriations.

Furthermore, the opinions rendered herein are without prejudice to opinions rendered by higher authorities.

ⁱ **Section 336. Use of Appropriated Funds and Savings.** - Funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

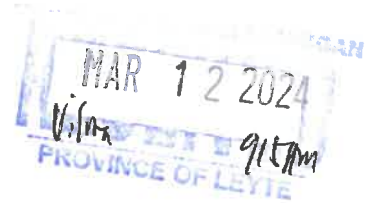

"AN ORDINANCE AUTHORIZING THE MAYOR AND/OR THE PRESIDING OFFICER OF THE SANGGUNIANG BAYAN TO USE SAVINGS FOR AUGMENTATION IN ACCORDANCE WITH THE LOCAL GOVERNMENT CODE OF 1991"

NOW THEREFORE, on motion of SB Member Kenneth Spice De Veyra duly seconded en masse by all Sangguniang Bayan Members present, be it-

BE IT ORDAINED as it is hereby ordained by the Sangguniang Bayan of Alangalang, in session duly assembled, THAT:

Section 1. Use of Savings and Augmentation.

In accordance with Section 336 of Republic Act No. 7160, the Local Government Code of 1991, the Mayor and/or the Presiding Officer of the Sanggunian is/are authorized to augment any item in the approved budget for their respective offices from savings in other within the same expense class of their respective appropriations.

For this purpose, "savings" refers to portions or balances of any programmed appropriation free from any obligation or encumbrance, still available after the satisfactory completion or the unavoidable discontinuance or abandonment for the work, activity or purpose for which the appropriation is authorized, or arising from unpaid compensation and related costs pertaining to vacant positions and leaves of absence without pay.

"Augmentation" implies the existence in the budget of an item, project, activity or purpose with an appropriation which, upon implementation or subsequent of needed resources, is determined to be deficient.

Section 2. Priority in the Use of Personal Services Savings.

Priority shall be given to the personnel benefits of local employees in the use of Personal Services Savings.

Section 3. REPEALING CLAUSE.

All Ordinances, executive orders, issuances including rules and regulations inconsistent with this ordinance are hereby repealed and/or modified accordingly.

Section 4. SEPARABILITY CLAUSE.

If any provision of this ordinance is declared invalid, the remainder or any provision herein not affected thereby shall remain in force and effect.


Section 5. EFFECTIVITY. This ordinance shall take effect upon approval. ENACTED, by the Sangguniang Bayan on February 19, 2024.
