Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 2 CY 2023** of the **Municipality of Mayorga**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 04 S. 2023** with a total appropriation in the amount of **P2,198,909.72** reveals compliance with the same law and its implementing Rules and Regulations.

"AN ORDINANCE REVERTING THE SAVINGS OUT OF THE VACANT POSITIONS UNDER PERSONAL SERVICES (PS) IN THE AMOUNT OF TWO MILLION ONE HUNDRED NINETY-EIGHT THOUSAND NINE HUNDRED NINE PESOS AND SEVENTY-TWO CENTAVOS (Php 2,198,909.72) AND RE-APPROPRIATING THE SAME FOR THE GRANT OF ONE TIME SERVICE RECOGNITION INCENTIVES (SRI) TO EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF MAYORGA, LEYTE BOTH PERMANENT AND ELECTED AT TWENTY THOUSAND PESOS (Php 20,000.00) EACH IN THE TOTAL AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (Php 1,500,000.00), FOR THE GRANT OF GRATUITY PAY FOR JOB ORDER (JO) EMPLOYEES AT THREE THOUSAND PESOS (Php 3,000) EACH IN THE TOTAL AMOUNT OF FOUR HUNDRED SEVENTY-ONE THOUSAND PESOS (Php 471,000.00), AND FOR THE PAYMENT OF TERMINAL LEAVE MONETIZATION AND OTHER BENEFITS IN THE AMOUNT OF TWO HUNDRED TWENTY-SEVEN THOUSAND NINE HUNDRED NINE PESOS AND SEVENTY-TWO CENTAVOS (Php 227,909.72), SUBJECT TO APPLICABLE LAWS, AUDITING RULES AND PROCEDURES."

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 grants the Local Government Units the authority to exercise powers for efficient and effective governance and those which are essential to the promotion of the general welfare:

WHEREAS, Administrative Order (AO) No. 12 dated December 7, 2023 authorizes the grant of one-time Service Recognition Incentive (SRI) for FY 2023 at a uniform amount not exceeding Twenty Thousand Pesos (Php 20,000.00) for each government employee;

WHEREAS, Administrative Order (AO) No. 13 dated December 7, 2023 authorizes the grant of one-time Gratuity Pay not exceeding Five Thousand Pesos (Php 5,000.00) to Contract of Service and Job Order Workers in Government for FY 2023;

WHEREAS, the Municipal Government of Mayorga has available and sufficient budget savings for the grant of one-time Service Recognition Incentive (SRI), Grant of one-time Gratuity pay for Contract of Service and Job Order employees as well as Terminal Leave Benefits, without in any way, adversely affecting the delivery of services to the public;

WHEREAS, the Municipal Government of Mayorga, which adheres to the policy and commitment of looking after the best welfare and well-being of its employees and their families, is grateful and eagerly implementing the windfall that will certainly benefit and boost the morale of municipal government employees;

WHEREAS, in the exercise of its discreet and prudent legislative functions, following the mandate provided for under RA 7160, the Sangguniang Bayan of Mayorga is satisfied with the final embodied set forth therein;

WHEREFORE, on motion of the Honorable Jairo C. Beltran duly seconded En Masse; be it

NOW, THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE MEMBERS OF THE SANGGUNIANG BAYAN OF MAYORGA, IN SESSION ASSEMBLED, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, THAT:

SECTION 1. The Supplemental Budget No. 02 of the Local Government Unit of Mayorga for Fiscal Year 2023: Reverting the Savings out of the Vacant Positions under Personal Services (PS) in the Amount of Two Million One Hundred Ninety-Eight Thousand Nine Hundred Nine Pesos and Seventy-two Centavos (Php 2,198,909.72) and Re-appropriating the same for the Grant of One Time Service Recognition Incentives (SRI) to Employees of the Municipal Government of Mayorga, Leyte both Permanent and Elected at Twenty Thousand Pesos (Php 20,000.00) each in the Total Amount of One Million Five Hundred Thousand Pesos (Php 1,500,000.00), for the Grant of Gratuity Pay for Job Order (JO) Employees in the Amount of Four Hundred Seventy-one Thousand Pesos (Php 471,000.00), and for the Payment for Terminal Leave Monetizations and other Benefits in the Amount of Two Hundred Twenty-Seven Thousand Nine Hundred Nine Pesos and Seventy-two Centavos (Php 227,909.72) is hereby approved.


