Furthermore, the opinions rendered herein are without prejudice to opinions rendered by higher authorities.

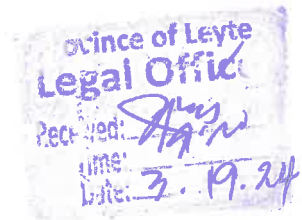

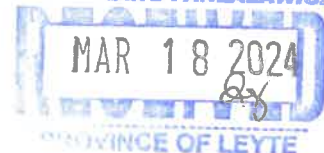

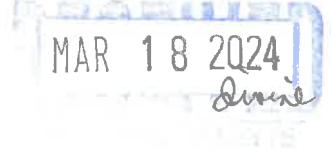

AN ORDINANCE PRESCRIBING THE DAY, TIME AND PLACE OF THE “TABO” OPERATION AND PROMULGATING RULES AND REGULATIONS THEREOF.

Be it ordained by the Sangguniang Bayan in session assembled that:

SECTION 1. The promulgation of the “Tabo” operation or “Market Day” is in accordance to Sec. 2242 of the Revised Administrative Code of 1987.

SECTION 2. Pursuant to Section 447 of R.A. 7160 as amended: It is the power and duty of Sangguniang Bayan to regulate any business operations within its municipal jurisdiction: to attain a smooth and orderly business environment.

SECTION 3. The Market Day “Tabo” shall start from 1:00 o’clock A.M. of every Wednesday until 3:00 o’clock P.M. of the same day at the taboan site (Municipal Plaza and Municipal Covered Court). The Tabo Operation shall be not be allowed during legal holidays.

SECTION 4. Implementing Rules and Regulations:

4a. All Tabo Vendors shall be required to secure a Mayors Permit from the Local Government Unit of Pastrana, Leyte. No permit, No vending.

4b. Requirements for the application of Mayor's Permit:

- a.) Community tax Certificate.
- b.) Barangay Business Clearance (Barangay District IV)
- c.) Payment:
 - Mayor's Permit fee
 - Sanitary Permit Fee
 - Garbage fee
 - Laboratory Fee (AFB/Fecalysis/Hepatitis)

4c. No vendor shall be allowed to sell goods/items not specifically reflected in their Mayor's Permit.

SECTION 5. Sectioning. Shall be in accordance to the commercial items/goods sold. The designated taboan site and the items/goods displayed therein shall:

a.) Municipal Covered Court:

- RTW (ukay-ukay, shoes, caps, accessories, plastic wares, curtains, blanket)

b.) Public Market (Beside fish and meat section)

- Fish, shells, seaweeds, and other kinds of sea foods
- Lechon (Pig)

c.) Municipal Plaza:

- Kakanin, Japanese cake, Native delicacies, breads/pastries

i. Near Entrance of Municipal Covered Court

- Fruits

ii. Municipal Plaza (Center)

- Vegetables, Spices, Condiments, root Crops, banana.

- Dried Fish

Municipal Plaza (Front)

- Salted Fermented Fish/Shrimp Paste

iii. Near Municipal Stage

- Farm/Gardening Tools

- Handwoven Mat (Banig)

- Housekeeping items (Sweeping Broom (siphid/silhig)

- Cutler (knife/blade sharpener)



- Grocery items

SECTION 7. No vendors shall be allowed to see/display their commercial items/goods outside their designated place. Cash tickets shall be issued to tabo vendor in the amount corresponding to the actual area/space occupied in the taboan site.

SECTION 8. No mobile vendors/peddlers shall be allowed inside the taboan site.

SECTION 9. All tabo vendors are required to provide their own table and shall start to arrange their tables in the taboan site at 1:00 O'clock A.M. of Wednesday. All tables shall be pulled out at the taboan site by

Magdalena C. Piola Jr.



3:00 o'clock P.M., Wednesday and they shall bring it with them upon leaving their respective rented area/space. Leaving behind tables and/or merchandise of vendor/s in the vicinity of Municipal Plaza, Municipal Covered Court, Municipal Auditorium, Municipal hall, is strictly prohibited.

SECTION 10: TABO will also be open for all Barangay who are willing to have their own "TABO" on their chosen day of the week, except, Wednesday which is exclusive in the town proper of this municipality.

SECTION 11. Every vendor is responsible in cleaning its rental space/area. Garbage shall be put in a plastic bag or container, properly segregated (Biodegradable/Non-Biodegradable). No segregation, No collection.

SECTION 12. Designated Comfort Rooms for Tabo Vendors and marketgoers are located in the Pastrana Public Market.

SECTION 13. A one-meter wide passage way shall be provided in every stall/table installed in all sections for easy access of marketgoers.

SECTION 14. Motor Vehicles of tabo vendors and marketgoers are strictly prohibited inside taboan site except during loading and unloading of items/goods. Designated parking space for vehicles shall be along San Francisco Street (Beside Municipal Covered Court) and along Osmeña Street.

SECTION 15. Personnel of Pastrana Rescue Unit (PASRU) will be posted in the taboan site to control and manage traffic. Presence of PNP personnel of Pastrana Police Station is also expected to ensure safe and orderly con-uct of business operation in the Taboan Area.

SECTION 16. Penal Provision. Any person, natural or juridical found violating this ordinance shall be penalized as follows:

FIRST OFFENSE - fine of five hundred pesos (P500.00)

SECOND OFFENSE - fine of One thousand pesos (P1000.00)

THIRD OFFENSE - Confiscation of items/goods and cancellation of Mayor's Permit, banned from displaying during tabo.

SECTION 17. Separability Clause. If, for any reason or reasons, any part or provisions of this ordinance shall be found unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

SECTION 18. Repealing Clause. All local laws, rules and regulations inconsistent with this Ordinance are hereby deemed repealed amended accordingly.







MINUTES OF THE COMMITTEE HEARING ON THE **PROPOSED ORDINANCE “AN ORDINANCE PRESCRIBING THE DAY, TIME AND PLACE OF THE ‘TABO’ OPERATION AND PROMULGATING RULES AND REGULATIONS THEREOF”** CONDUCTED BY THE COMMITTEE ON MARKET AND SLAUGHTERHOUSE LAST FEBRUARY 8, 2024 AT THE SANGGUNIANG BAYAN SESSION HALL

ABSENT:

The Presiding Officer Hon. Nathan G. Letrodo called the committee hearing at exactly 10:30 in the morning. He greeted everyone present in the meeting. Hon. Loida B. Villablanca was requested to lead the prayer. The Presiding Officer requested the Sangguniang Bayan Secretary- Designate to have the roll call. Then the Presiding Officer declared the presence of a quorum.

The Presiding Officer presented the agenda which is the **PROPOSED ORDINANCE “AN ORDINANCE PRESCRIBING THE DAY, TIME AND PLACE OF THE ‘TABO’ OPERATION AND PROMULGATING RULES AND REGULATIONS THEREOF”**. The Presiding Officer then presented the details of the proposed ordinance by reading each of its section and asking for corrections and suggestions.

Hon. Loida B. Villablanca raised her hand to be recognized and suggested that Tuesday is the right time to assemble their goods.

Hon. Angelina C. Diola raised her hand to be recognized and suggested that even before 4am of Wednesday will do for their assembly time.

Hon. Gerardo S. Carian raised his hand to be recognized and clarified if during the meeting conducted with the tabo vendors, were they all from Pastrana only and was there any reaction from those vendors living in the municipality.

The Presiding Officer suggested to the existing vendors to ask permission from the market supervisor and the Local Chief Executive if they want to continue selling even without scheduled tabo since he has no jurisdiction over the concern.

Hon. Gerardo S. Carian raised his hand to be recognized and asked if the barangays concerned where their stores are located, are they being issued ticket. He also added that they should stop issuing ticket if there is for them to have no reason to stay.

Hon. Angelina C. Diola raised her hand to be recognized and clarified on the stores located in the area of District I and District II which are along the highway if they are being issued tickets. She added that why not prioritized them if the public market will be done for all the stores to be in place.

Hon. Loida B. Villablanca raised her hand to be recognized and agreed to Hon. Diola, as for her all stores should be at the public market once it's done to be fair to all.

The Committee agreed that assembly time will be on Wednesday 1am and will end at 3pm.

The Presiding Officer expressed that the tabo should be inviting and maribhong so the time should be limited.

Hon. Gerardo S. Carian raised his hand to be recognized and clarified regarding parking spaces as to who are facilitating it to be in order.

Hon. Loida B. Villablanca raised her hand to be recognized and suggested to have a budget for tents for rent and even tables to have a uniform set up.


The Presiding Officer expressed that an additional section for Barangay Tabo will be added since some barangay want to have their own tabo especially Barangay Manaybanay and Barangay and Barangay Tingib. He added the concern regarding the associations with agricultural products and that it should be dispense first in the municipality before the others.

Hon. Gerardo S. Carian raised his hand to be recognized and expressed that the accredited organizations that we know is limited to farmers association.





I. Preliminaries

- a. The Public Hearing was conducted by the Office of the Sangguniang Bayan of Pastrana, Province of Leyte, spearheaded by the SB Committee Chairman on Finance and Appropriation and was joined by the members of the said committee.
- b. It was well participated by the tabo vendors, barangay officials, PNP and BFP personnel and all others interested to listen to this particular public hearing. (Attached is the Attendance sheet)
- c. The said public Hearing was Presided over by Honorable Nathan G. Letrodo, SB Committee Chairman on Finance and Appropriation.
- d. The said Public Hearing started at exactly 2:10 in the afternoon, and Prayer and the Philippine National Anthem was done thru an overture.

II. Parliamentary Proceedings

- a. The Draft Ordinance, “An Ordinance Prescribing the Day, Time and Place of the ‘TABO’ Operation and Promulgating Rules and Regulations Thereof” was presented by Hon Nathan G. Letrodo thru a power point presentation. After which Hon. Letrodo proceeded to the different Sections of the proposed ordinance and asked the participants if they have corrections and suggestions. Then, Hon. Villablanca solicited for suggestions and ideas from the participants and according to her

everyone is encouraged to share their opinions as all of those will be discussed and so they should not hesitate to do so.

- b. Mr. Christopher of Burauen Leyte, one of the TABO vendors expressed that opening of TABO at 4am until 4pm is okay with them.
- c. Hon Carian expressed that everyone is encouraged to give their opinions and suggestions whether they are living in the municipality or not.
- d. The Presiding Officer expressed that maybe assembly time will be at 2am and the opening or the time that patrons will be entertained is at 4am.
- e. Maam Rina M. Balagbis, Market Supervisor confirmed that at 2am TABO vendors are already in the venue to assemble their commodities.
- f. Hon Carian shared some clarifications on Section 2 on the phrase “a smooth and orderly business environment”.
- g. The Presiding Officer expressed that it is also best that each vendor stays with their assigned and designated areas to avoid conflicts, thereby being organized.
- h. Jennelyn Arsollon, one of the vendors expressed that as to the Circle of Rizal Monument it is okay since they are not using it every day.
- i. Maam Rina M. Balagbis, Market supervisor had a clarification on Section 8, with regards to mobile vendors. She explained that they are those selling around the municipality and paying different permit. She also added that as to the time Section 3 and Section 9 should be in uniform and that is from 1am assembly time, 4am opening time and will end at 3pm wherein all tables will be pulled out during this time.
- j. Hon. Carian expressed that with regards to the garbage that this TABO operation will have the department concerned should be called to better facilitate and assist proper segregation and waste disposal.
- k. Jennelyn Arsollon, one of the vendors expressed that their makeshift stores along the road shouldn't be demolished because that is their only venue in which excess products from TABO will be sold.
- l. The Presiding Officer expressed that the Local Government Unit understands their situation, however how can they operate smoothly and orderly when these makeshift stores will not be taken out from their temporary location which is not legal and very much hazardous to their customers since it is in the national highway where vehicles come and go.
- m. Maam Rina M. Balagbis, Market Supervisor expressed that these makeshift store owners are being offered stalls in the marketplace for their convenience, since their area right now is a waiting shed and along the national highway which is strictly prohibited.
- n. Hon. Villablanca explained that the area really prohibits makeshift stores aside from the fact that it is a national road. Accepting the offer of the LGU is one big advantage for them since when the public market will be constructed and done they will be prioritized to have slots for the stalls.
- o. Maam Rina M. Balagbis added that those street food vendors, they are allowed as of the moment but as soon as the public market is done they will be assigned to the designated place for street foods.

III. Finally, “An Ordinance Prescribing the Day, Time and Place of the ‘TABO’ Operation and Promulgating Rules and Regulations Thereof” presented was applauded by everyone present and thus, being moved by Hon. Delma S. Noyad , Brgy Chairperson of Brgy. Aringit for approval. And this was duly seconded by PSMS Christian Carlo Candaza and Jennelyn Arsollon, one of the tabo vendors.

IV. Since all participants were happy on the result of the Public Hearing with the approval of the majority participants present, so be it.

V. Adjournment

There being no other matters to be discussed, Public Hearing was adjourned at 3:20 in the afternoon.
