Furthermore, the opinions rendered herein are without prejudice to opinions rendered by higher authorities.

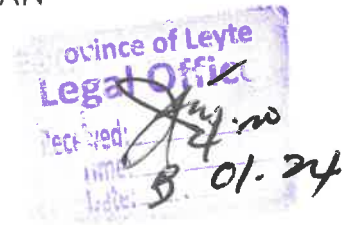



MUNICIPAL ORDINANCE NO. 24-02

“AN ORDINANCE GRANTING A MONTHLY INCENTIVE TO SENIOR CITIZENS CHAPTER PRESIDENTS CHARGEABLE UNDER THE ELDERLY WELFARE PROGRAM”

WHEREAS, Section 447 (a)(5)(xvi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates the approval of ordinances which, among others, “Establish a Municipal Council for the elderly which formulate policies and adopt measures, mutually beneficial to the elderly and the community, provides incentives for the non-governmental agencies and entities and, subject to the availability of funds, appropriate funds to support programs and projects for the benefit of the elderly;

WHEREAS, the Municipal Government of Burauen recognizes the untiring efforts and hard work of Senior Citizens Chapter Presidents, who actively help to ensure that the Municipal Government’s programs and services reach the senior citizens in their respective communities;

WHEREAS, by providing monthly incentives to Senior Citizens Chapter Presidents, the Municipal Government could motivate and aid them in their financial needs in connection with the rendition of their services;

NOW, THEREFORE, on motion of Hon. Cipriano R. Relatorres, Jr., seconded by all Members of the Sangguniang Bayan present:

Be it ordained by the Sangguniang Bayan of Burauen, Leyte, in session duly assembled, that:

Section 1. TITLE. This Ordinance shall be known as the “An Ordinance Granting a Monthly Incentive to Senior Citizens Chapter Presidents.”

Section 2. SCOPE AND COVERAGE. This Ordinance shall apply to Senior Citizens Chapter Presidents registered under the records of the Office of the Senior Citizens Affair.

Section 3. GENERAL PROVISIONS:

- 3.1. Senior Citizens Chapter Presidents, as provided in Section 2 hereof, are entitled to receive a monthly incentive of Three Hundred Pesos (P300.00), Philippine Currency.
- 3.2. Substitute or unregistered Senior Citizens Chapter Presidents shall not be entitled to the monthly incentives herein granted.
- 3.3. The monthly incentive shall be released every six (6) months.
- 3.4. The Municipal Social Welfare Development Office, in coordination with the Municipal Treasurer’s Office, shall be responsible for the release of the monthly incentive to the Senior Citizens Chapter Presidents.

Section 4. FUNDING. — An amount of at least Two Hundred Seventy-Seven Thousand Two Hundred Pesos (P277,200.00) shall be allotted annually for the monthly incentives of herein granted, chargeable against the Elderly Welfare Program of the municipality.

Section 5. REPEALING CLAUSE. — All ordinances, resolutions, and rules and regulations or parts thereof which are inconsistent or in conflict with any provision of this Ordinance are hereby deemed repealed or modified accordingly.

Section 6. SEPARABILITY CLAUSE. — If, for any reason, any section or provision of this Ordinance is held unconstitutional or invalid, other sections or provisions hereof which are not affected shall continue to be in full force and effect.

Section 7. EFFECTIVITY. — This Ordinance shall take effect immediately upon approval by the Sangguniang Bayan of Burauen.
