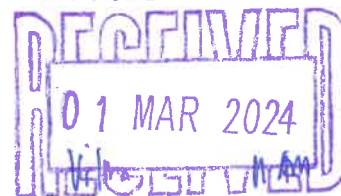

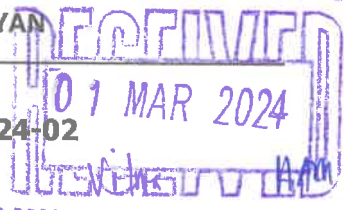

MUNICIPAL ORDINANCE NO. 2024-02

AN ORDINANCE DECLARING HULATAN FESTIVAL AS THE OFFICIAL FESTIVAL OF THE MUNICIPALITY OF JULITA, LEYTE, FURTHER DECLARING AUGUST 1-10 AS THE HULATAN FESTIVAL DAYS AND APPROPRIATING FUNDS THEREOF.

WHEREAS, the Hulatan Festival depicts the origin of the Municipality of Julita;

WHEREAS, the Hulatan Festival is also a special occasion that showcase the culture and tradition of the people of the Municipality of Julita;

NOW THEREFORE, on motion of the **Hon. Mark Joy E. Macaso**, duly seconded by the **Hon. Aliana Marie R. Tubi** and the **Hon. Irvin R. Dy**,

BE IT ENACTED by the Sangguniang Bayan of Julita, Leyte, in session duly assembled, that:

SECTION 1. Title. This Municipal Ordinance shall be known as "AN ORDINANCE DECLARING HULATAN FESTIVAL AS THE OFFICIAL FESTIVAL OF THE MUNICIPALITY OF JULITA, LEYTE, FURTHER DECLARING AUGUST 1-10 AS THE HULATAN FESTIVAL DAYS AND APPROPRIATING FUNDS THEREOF"

SECTION 2. Declaration of Policy. It is hereby declared that the Hulatan Festival shall be the official festival of the Municipality of Julita. Such festival depicts the unique culture and origin of the municipality and shall serve as a reminder to younger generation of their history. It shall also serve as a tool to attract local and international tourists.

SECTION 3. Date of the Hulatan Festival Celebration. The festival shall be held annually on August 1 – 10. This period shall be called the Hulatan Festival Days.

SECTION 4. Hulatan Festival Activities. The Hulatan Festival Celebration shall include activities such as, but not limited to the following:

1. Street Dancing Competition
2. Farmer - Agri Fair
3. Search for Miss Hulatan
4. Music Festival
5. Dance Festival
6. Arts Festival
7. Sports Activities

SECTION 5. Hulatan Festival Committee. The Hulatan Festival Committee is hereby created with the following composition and functions:

A. Composition

Chairman	Municipal Mayor
Vice-Chairman	Municipal Vice-Mayor
Members	Chairman, Sangguniang Bayan Committee on Tourism Chairman, Sangguniang Bayan Committee on Youth and Sports Chairman, Sangguniang Bayan Committee on Education and Culture Chairman, Sangguniang Bayan Committee on Finance President, Liga ng mga Barangay, Municipal Chapter Municipal Planning and Development Coordinator Municipal Budget Officer DEPED Julita District Representative Municipal Youth Representative Representative from the Culture and Arts Organization Two (2) NGO Representatives Municipal Local Government Operations Officer (MLGOO)

B. Functions and Duties:


1. To meet quarterly or as often as necessary to craft plans and programs for the celebration of the Hulatan Festival;
2. Select and set the schedule of the activities that will be included in the Festival Week annually; and
3. Evaluate the effectiveness of Hulatan Festival
4. Shall convene at least twice a year or as often as maybe necessary, with the majority of the Board to constitute quorum, to (1) Evaluate the effectiveness of the program; and (2) Evaluate and approve the applicants of these awards.

SECTION 6. Secretariat. The chairman of this committee shall appoint three (3) employees of the Local Government of Julita that shall serve as members of the secretariat.

SECTION 7. Funding. Funds shall be allocated annually by the municipality to cover the expenses for the conduct of the festival.

SECTION 8. Separability Clause. If, for any reason or reasons, any part or provision of this Ordinance is held to be unconstitutional or invalid,



SECTION 9. Repealing Clause. All ordinances, rules and regulations, or parts thereof, in conflict with or inconsistent to the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 10. Effectivity. This Ordinance shall take effect immediately after its approval and after its posting in all barangays of the Municipality of Julita, Leyte.
