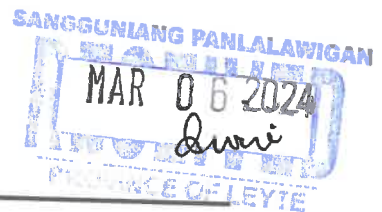

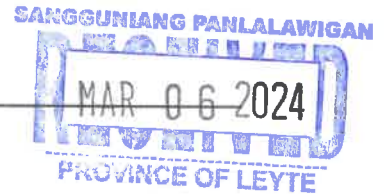

MUNICIPAL ORDINANCE NO. 488-260224

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 394-030815 (GENDER AND DEVELOPMENT CODE OF THE MUNICIPALITY OF PALOMPON, LEYTE AND MANDATING THE IMPLEMENTATION OF A COMPREHENSIVE AND SUSTAINABLE GAD PROGRAM), PARTICULARLY SECTION 56 BY INSERTING THEREIN ADDITIONAL PROVISIONS

BE IT ORDAINED by the Members of the Sangguniang Bayan of Palompon, Leyte duly assembled:

SECTION 1. – TITLE. This ordinance shall be known as the Amendment of the Gender and Development Code of the Municipality of Palompon, Leyte and Mandating the Implementation of a Comprehensive and Sustainable GAD Program.

SECTION 2. – AMENDMENT OF ARTICLE VII, SECTION 56.

Article VII, Section 56 (Continuing Education against Sexual Harassment) of Municipal Ordinance No. 394-030815 (Gender and Development Code of the Municipality of Palompon, Leyte and Mandating the Implementation of a Comprehensive and Sustainable GAD Program) is hereby amended by inserting therein as item 56.4 another provision intended for the adoption of Republic Act 11313, as stated below:

56.4 The provisions of Republic Act 11313 otherwise known as an act defining Gender-Based Sexual Harassment in streets, public spaces, online, workplaces and education or training institutions, providing protective measures and prescribing penalties thereof.

SECTION 3. – REPEALING CLAUSE. All ordinances, resolutions, rules and regulations inconsistent with this ordinance is hereby repealed accordingly.

SECTION 4. – SEPARABILITY CLAUSE. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by a decision of any court with competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION 5. – EFFECTIVITY. This Ordinance shall take effect upon its approval.
