COMMITTEE REPORT No. 05, Series of 2024

Referred to this Committee is Ordinance No. 2023-02 of the Municipality of Dagami, Leyte entitled “An Ordinance Prohibiting the Manufacture, Sale, Distribution, Possession and Use of Firecrackers, Pyrotechnic Devices, and Other Similar Devices Causing the Explosion of the Same or Other Explosives Within the Territorial Jurisdiction of Dagami, Province of Leyte”.

The Provincial Legal Office recommended for its validity as an exercise of the power essential to the promotion of the General Welfare, Health and Safety, authorized under Sec 16 of the Code.

This Committee upon examination of the subject ordinance finds that Section 5 of which provides:

“Section 5. Prohibited Acts. It shall be unlawful for any person or business establishment to manufacture, sell or offer sale, distribute, possess or use of any firecracker or pyrotechnic devices or such other similar devices within the territory of Dagami.” (Underlining and Emphasis supplied)

which may be contrary to the provision of the existing national law. Republic Act No. 7183 provides for the regulation and control of the manufacture, sale, distribution and use of firecrackers and other pyrotechnic devices and did not totally prohibit. While section 3 of Ordinance No. 2023-02 provide for examples of what firecrackers and pyrotechnic devices are, its definition pertains to all kind of firecrackers and pyrotechnic devices.

Contrary to Section 2 and 3 of Republic Act No. 7183, the law provides an enumeration of Firecrackers and Pyrotechnic Devices which may be allowed and prohibited respectively, to wit:

“SEC. 2. Types of Firecrackers and Pyrotechnic Devices Allowed in this Act. - The following common types of firecrackers and pyrotechnic devices may be manufactured, sold, distributed and used:

A. Firecrackers:

- 1. Baby rocket - A firecracker with a stick so constructed that lighting of the wick will propel the whole thing to lift a few meters before exploding. The firecracker is about 1 1/2 inches in length by 3/8 inch in diameter while the stick is about a foot in length;*
- 2. Bawang - A firecracker larger than a triangulo with 1/3 teaspoon of powder packed in cardboard tied around with abaca strings and wrapped in shape of garlic;*
- 3. Small triangulo - A firecracker shaped like a triangle with powder content less than the bawang and usually wrapped in brown paper measuring 3/4 inch length in its longest side;*
- 4. Pulling of strings - A firecracker consisting of a small tube about an inch in length and less than 1/4 of an inch in diameter with strings on each end. Pulling both strings will cause the firecracker to explode;*
- 5. Paper caps - Minute amount of black powder spread in either small strips of paper or on a small sheet used for children's toy guns;*

6. *El diablo* - Firecrackers tubular in shape about 1 1/4 inches in length and less than 1/4 inch in diameter with a wick; also known as *labintador*;
7. *Watusi* - Usually reddish in color about 1 1/2 inches in length and 1/10 inch in width usually ignited by friction to produce a dancing movement and a crackling sound;
8. *Judah's belt* - A string of firecrackers consisting of either diablos or small triangulos that can number up to a hundred or thereabout and culminating in a large firecracker usually a *bawang*;
9. *Sky rocket (kwitis)* - A large version of a baby rocket designed to be propelled to a height of forty (40) to fifty (50) feet before exploding;
10. Other types equivalent to the foregoing in explosive content.

B. Pyrotechnic Devices:

1. *Sparklers* - Pyrotechnic devices usually made of black powder on a piece of wire or inside a paper tube designed to light up and glow after igniting;
2. *Luces* - Any of several kinds of sparklers;
3. *Fountain* - A kind of sparkler conical in shape which is lighted on the ground and designed to provide various rising colors and intermittent lights upon being ignited;
4. *Jumbo regular and special* - A kind of sparkler similar to a "fountain" but bigger in size;
5. *Mabuhay* - Sparklers bunched into a bundle of a dozen pieces;
6. *Roman candle* - A sparkler similar to a "fountain" but shaped like a big candle;
7. *Trompillo* - A pyrotechnic device usually fastened at the center and designed to spin first clockwise and then counterclockwise and provides various colored lights upon being ignited;
8. *Airwolf* - A kind of sky rocket shaped like an airplane with a propeller to rise about forty (40) or fifty (50) feet and provide various kinds of light while aloft;
9. *Whistle device* - Any of the various kinds of firecrackers or pyrotechnic designed to either simply emit a whistle-like sound or explode afterwards upon being ignited;
10. *Butterfly* - Butterfly-shaped pyrotechnic device designed to lift above ground which providing light;
11. All kinds of pyrotechnic devices (*pailaw*); and
12. Other types equivalent to the foregoing devices.

SEC. 3. Prohibited Types of Firecrackers and Pyrotechnic Devices. - **The manufacture, sale, distribution and use of other types of firecrackers and pyrotechnic devices not mentioned in the foregoing section, of such explosive content that could endanger life and limb, such as atomic big triangulo and super lolo and their equivalent are hereby prohibited.** Determination of what constitutes prohibited firecrackers and pyrotechnic devices shall be vested with the Director-General of the Philippine National Police (PNP).” (underlining and emphasis supplied)

Further, Rule II Section 1 of the 2012 Revised Implementing Rules and Regulations governing the administration and enforcement of Republic Act No. 7183 provides the type of prohibited types of firecrackers and pyrotechnic devices, as follows:

“RULE II - Prohibited Types of Firecrackers and Pyrotechnic Device

The manufacture, sale, distribution and use of other types of firecrackers not mentioned in the foregoing section, with net explosive(s) ingredients content of more than 1/3 teaspoon, in which the technically safe equivalent of it is equivalent to not more than 0.2 gram, which will endanger life and limb, are prohibited. Pyrotechnic devices generally referred to as

fireworks have different nature of effect and purpose. It has also different packaging as compared with firecrackers.

SECTION 1. The manufacture, sale, distribution and use of other types of firecrackers and pyrotechnic devices not mentioned in the foregoing section, of such explosive content that could endanger life and limb, such as atomic big triangulo and super lolo and their equivalent are hereby prohibited.”

In addition, in 2017, Malacañang issued Executive Order No. 28, s. 2017 (EO No. 28) on the regulation and control of the use of firecrackers and other pyrotechnic devices and the designation of specific areas for the community fireworks display. Section 2 and 3 of the said Executive Order also provides, as quoted hereunder:

“Section 2: Pyrotechnic devices other than firecrackers may be used outside community fireworks display subject to existing laws, rules and regulations. xxx

Section 3: the Director-General of the PNP is hereby directed to promulgate criteria for what constitutes prohibited firecrackers and pyrotechnic devices within 30 days from the effectivity of this Order, and also to provide specific lists of such devices as may be necessary for the guideline of the public, which will be disseminated to all concerned. All fireworks falling under such criteria may not be manufactured, sold, distributed or used even as part of a community fireworks display” (emphasis supplied)

Clearly, R.A 7183, provides for the regulation and control of the manufacture, sale, and use of Firecrackers and Pyrotechnic devices and does not totally prohibit the same as the same has identified the types of which that may be allowed.

While EO No. 28 authorizes local government units (LGUs) to promulgate the necessary rules and regulations on firecrackers and other pyrotechnic devices within their territorial jurisdiction, it should be done in conformity with national standards, rules, and regulations. And, while it authorizes the LGUs to issue or to not issue special permits for the sale of consumer pyrotechnics or “pailaw” in their respective jurisdictions, Republic Act No. 7183 has clearly identified certain types of firecrackers and pyrotechnic devices which are allowed.

Let it be noted that administrative issuances such as Executive Orders, Administrative Orders and Memorandum Circulars issued by the executive branch of the government are there to implement the provisions of existing national laws and cannot be made to contradict, amend or modify the legislative intent of the law.

In view thereof, this Committee recommends that subject Ordinance be returned to the Sangguninag Bayan of origin for review and further study for it to conform to the provisions of RA 7183 and existing laws and for the same to comply with the basic requirement, that ordinances should not prohibit trade.

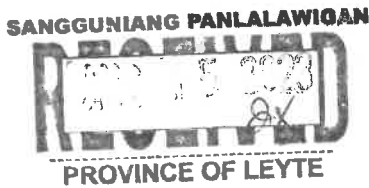

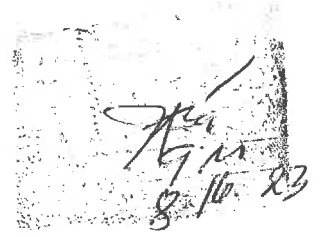

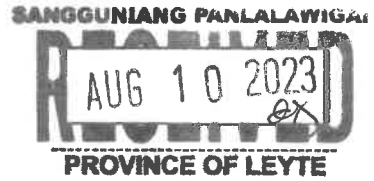

ORDINANCE NO. 2023-02

AN ORDINANCE PROHIBITING THE MANUFACTURE, SALE, DISTRIBUTION, POSSESSION, AND USE OF FIRECRACKERS, PYROTECHNIC DEVICES, AND OTHER SIMILAR DEVICES CAUSING THE EXPLOSION OF THE SAME OR OTHER EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF DAGAMI, PROVINCE OF LEYTE.

WHEREAS, firecrackers have become a source of not only huge fires but can kill or harm people, animals, and properties;

WHEREAS, bursting of firecrackers as the highlight in celebrating Christmas, festivities, and other occasions does not, in any way, invite good fortune but rather this only spark danger as it leads to injuries, even death, and is just pouring money down the drain;

WHEREAS, section 16 of the Local Government Code of 1991 (RA 7160) accords every local government unit the power and authority to promote the general welfare within its territorial jurisdiction including health and safety of its constituents;

WHEREAS, the Department of Interior and Local Government had issued Memorandum Circular No. 2007-165, dated December 27, 2007 titled "Reiterating DILG MC No. 2002-188 On the Strict Implementation of Republic Act No. 7183, titled: An Act Regulating the Manufacture, Sale, Distribution and Use of Firecrackers and Other Pyrotechnic Devices;"

WHEREAS, the said circular categorically states that in order to avoid unnecessary injuries, disabilities, and even deaths during Christmas, New Year, and other occasions, all Local Chief Executives' attention is again invited to the pertinent provisions of DILG Memo Circular No. 2002-188 dated 08 November 2002, which reads in part specifically under item no. 2, "The local sanggunian may also enact an ordinance totally prohibiting the manufacture, sale, distribution and use of any firecracker and pyrotechnic devices, if there is a reasonable ground to believe that radical groups may take advantage of the holiday season merriment for their lawless designs;"

WHEREAS, Memorandum Circular 2006-162 dated 03 November 2006 enjoins all Local Chief Executives to cause the cancellation or revocation of permits or licenses of business establishments found manufacturing, importing, distributing and selling any consumer product declared as injurious and dangerous to health and safety;

WHEREAS, during the multi-level consultation hearing, a strong manifestation of support was expressly shown by the stakeholders for the immediate passage of this ordinance;

WHEREAS, the Association of the Barangay Captains of this Municipality has passed Resolution expressing their support to the local law;

WHEREAS, an urgent measure to prevent the people from suffering firecracker accidents which may result to physical injuries such as loss of fingers, limbs, blindness, hand deformities, causes disturbance and affect their emotional well-being;

WHEREAS, considering that public welfare is of paramount importance, safety measures must be institutionalized to prevent accidents involving firecrackers and to ensure the safety of the lives and properties of the community-residents and visitors, it is necessary to prohibit the manufacture, sale, distribution, possession and use of firecrackers and pyrotechnic devices in the Municipality;

WHEREFORE, on motion of **HON. ANDRES BRYAN M. BAYONA**, with unanimous accord of the Members of the Sangguniang Bayan present, it was;

RESOLVED, as it is hereby resolved, by the Sangguniang Bayan of Dagami, province of Leyte, in session assembled, to enact the following Ordinance:

MUNICIPAL ORDINANCE NO. 02
Series of 2023

PROHIBITING THE MANUFACTURE, SALE, DISTRIBUTION, POSSESSION, AND USE OF FIRECRACKERS, PYROTECHNIC DEVICES, AND OTHER SIMILAR DEVICES CAUSING THE EXPLOSION OF THE SAME OR OTHER EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF DAGAMI, PROVINCE OF LEYTE


Section 1. Title. This ordinance shall be known as "The Total Ban of Manufacture, Sale, Distribution, Possession, and Use of Firecrackers, other Pyrotechnic Devices, and other Similar Devices causing the Explosion of the same or other Explosives within the Territorial Jurisdiction of Dagami, Province of Leyte."


Section 2. Purpose. To promote public safety, peace, order, and security of the community.

Section 3. Definition of Terms. The following terms shall be defined/referred as follows:

a) **Firecracker** - is a small explosive device primarily designed to produce a large amount of noise especially in the form of a loud bang; any visual effect is incidental to the goal. They have fuses and are wrapped in a heavy paper casing to contain the explosive compound. The following are the common types of firecrackers:


- Baby rocket
- Bawang
- Small triangulo
- Paper caps
- El Diablo (labintador)
- Watusi
- Judah's belt



- Skyrocket (kwitis)
- b) **Pyrotechnics** – is the science of using materials capable of undergoing self-contained and self-sustained exothermic chemical reactions for the production of heat, light, gas, smoke and/or sound.
- c) **Pyrotechnic devices** – are attention-getting devices that burn, sputter, smoke or explode. These produce flame; the residue can cause burns and ignite flammable materials. These are devices which combine high reliability with very compact and efficient energy storage, in the form of chemical energy which is converted to expanding hot gases either through deflagration or detonation. The following are the common types of pyrotechnic devices:

- Sparklers
- Trompillo
- Luces
- Airwolf
- Fountain
- Whistle device
- Jumbo regular and special
- Butterfly
- Mabuhay
- Roman candle

Section 4. Effects of firecrackers and pyrotechnics. Firecrackers, as fire hazards and known to cause bodily harms, injuries and even deaths were shown in studies and were proven to also cause the following:


- 4.1 Increase in toxic forms and gases like carbon dioxide, sulfur dioxide and nitrogen dioxide, as well as suspended particulate matter (SPM) in the air;
- 4.2 Increase in noise pollution above 125 decibels (dB) which is above the tolerable limits and can cause deafness;
- 4.3 Increase in incidents of respiratory diseases such as acute bouts of asthma and bronchitis and may also trigger heart attacks.

Section 5. Prohibited Acts. It shall be unlawful for any person or business establishment to manufacture, sell or offer sale, distribute, possess or use of any firecracker or pyrotechnic devices or such other similar devices within the territory of Dagami.


Exception. When the Municipal Government or the Barangay organizes a firework display, it shall be conducted in an open field.

Section 6. Penalties. Violation of the provisions of this Ordinance shall be penalized as follows:

6.1 For Minor Offenders who are users/possessors of firecrackers or pyrotechnic devices:



6.1a An offender who is aging above 15 years old to below 18 years old shall be meted to a penalty of four (4) hours of community service for every offense committed within the barangay where the offender resides.

6.1b An offender who is aging 15 years old and below, a confiscation of firecrackers/pyrotechnic device shall be done by the PNP enforcers and other authorities concerned, the confiscated items shall be turned-over to the Anti-firecrackers Task Force of the LGU for its proper disposition.

6.2 For adult offenders who are users/possessors of firecrackers/pyrotechnic devices:

6.2a First offense – a fine of Two Hundred Fifty (P250.00) or imprisonment of two (2) days, or both fine and imprisonment at the discretion of the court.

6.2b Second offense – a fine of Five Hundred Pesos (P500.00) or imprisonment of five (5) days, or both fine and imprisonment at the discretion of the court.

6.2c Third offense - a fine of One Thousand Two Hundred Fifty (P1,250.00) or imprisonment of fifteen (15) days, or both fine and imprisonment at the discretion of the court.

6.3 For adult offenders who are manufacturers/sellers:

6.3a First offense – a fine of Five Hundred Pesos (P500.00) or imprisonment of five (5) days, or both fine and imprisonment at the discretion of the court.

6.3b Second offense – a fine of One Thousand Pesos (P1,000.00) or imprisonment of ten (10) days, or both fine and imprisonment, at the discretion of the court.

6.3c Third offense – a fine of Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of one month, or both fine and imprisonment at the discretion of the court.

If the violation is committed by a business establishment, the President or General Manager or other person acting in behalf of either the President or General Manager shall be held liable in the case of a partnership or corporation, or the owner or proprietor or the person acting in his behalf shall be held responsible in the case of sole proprietorship.

In addition to the foregoing penalties, the business permit of the business establishment shall be cancelled by the Municipal Mayor upon the commission of the third offense.

Section 7. Creation, Duties, and Responsibilities of Anti-Firecrackers Task Force. There shall be created an Anti-Firecrackers Task Force which shall be composed of the following:

- 7.1. Municipal Health Officer
- 7.2. Barangay Captains
- 7.3. Any member of the Tourism Council
- 7.4. Solid Waste Management Coordinator
- 7.5. North and South District Supervisors
- 7.6. Principals of Secondary and Primary Schools
- 7.7. Municipal Social Welfare and Development Officer
- 7.8. Municipal Risk Reduction Management Action Officer
- 7.9. PNP Chief of Police
- 7.10. BFP Fire Marshal.

The Anti-Firecrackers Task Force shall 1.) alert the public about the safety and chemical and noise hazards from blasting firecrackers and other pyrotechnic devices 2.) to encourage the public to make use of alternative merry-making devices or instruments or noisemakers during Christmas and New Year revelry that are not toxic to humans, animals and the environment such as "tambol", horns or "torotot," bells, cans, agong, drums, music, and other safe noisemakers 3.) to disseminate health advisories and precautionary measures.

Section 8. Administration and Enforcement. Those who are planning to conduct fireworks display must apply and obtain a permit to conduct such display with the Dagami Bureau of Fire Protection (BFP).

Section 9. Confiscation. All confiscated firecrackers and pyrotechnic devices shall be destroyed under the supervision of the Municipal Mayor and the members of the Anti-Firecrackers Task Force.

Section 10. Separability Clause. Should any of the provisions of this ordinance be declared inoperative by the courts for being inconsistent with the Constitution or the law, the other provisions shall remain in full force and effect.

Section 11. Repealing Clause. Any and all ordinances or parts thereof which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 12. Effectivity. This Ordinance shall take effect after its approval and following its posting in conspicuous places.




