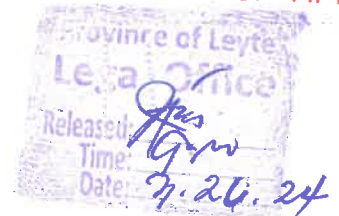

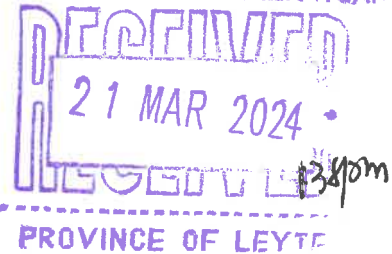

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 16, SERIES OF 2021 ENTITLED "AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO BARANGAY NUTRITION SCHOLARS, BARANGAY HEALTH WORKERS, BARANGAY SERVICE POINT OFFICERS, DAYCARE WORKERS, GAD FOCAL PERSONS AND FOR OTHER PURPOSES"

BE IT ENACTED by the *Sangguniang Bayan* of the Municipality of Capoocan, Province of Leyte in Regular Session duly assembled that:

SECTION 1. Section 1 of Municipal Ordinance No. 16, Series of 2021 is hereby amended to read as follows:

Financial Assistance and Benefits. In recognition of their services, all registered BNSs, BHWs, BSPOs, Day Care Workers and GAD Focal Persons who are actively and regularly performing their duties as certified by the concerned offices and/or Punong barangay shall be entitled to the benefits and incentives, as follows:

1. **Financial Assistance.** Registered Barangay Nutrition Scholars, Barangay Health Workers, Barangay Service Point Officers, Day Care Workers, and GAD Focal Persons shall receive financial assistance from the Municipal Government **once a year, in the amount of PhP1,500.00.**

2. **Schedule of Release of the Financial Assistance.** The identified eligible volunteers shall receive the financial assistance in the 1st Quarter of the succeeding year.

3. **Eligibility.** To receive the FULL amount of the Financial Assistance, the identified barangay volunteer must have rendered at least 6 months of

service in the current year and still in service as of December of the current year.

Identified barangay volunteers who rendered service less than 6 months as of December of the current year shall be entitled to a pro-rated Financial Assistance:

- 3 months to less than 6 months - 50% of the FA Full Amount
- 2 months to less than 3 months - 40% of the FA Full Amount
- 1 month to less than 2 months - 30% of the FA Full Amount
- Less than 1 month - 10% of the FA Full Amount

2. Prerequisites – to be eligible in claiming the assistance, the following shall be submitted:

- a) Certified True Copy of the Certificate of Registration from the concerned offices.
- b) Accomplishment Report duly signed by the concerned offices.
- c) Appointment of Service from the Punong Barangay.

Section 2. Separability Clause – If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect.

Section 3. Repealing Clause. Any ordinance found inconsistent hereof, in whole or in part, is hereby repealed or modified accordingly.

Section 4. Effectivity. This ordinance shall take effect immediately upon approval.



Financial Assistance and Benefits. In recognition of their services, all registered BNSs, BHWs, BSPOs, Day Care Workers and GAD Focal Persons who are actively and regularly performing their duties as certified by the concerned offices and/or Punong barangay shall be entitled to the benefits and incentives, as follows:

1. **Financial Assistance** - Registered Barangay Nutrition Scholars, Barangay Health Workers, Barangay Service Point Officers, Day Care Workers, and GAD Focal Persons shall receive financial assistance from the Municipal Government every December, with the following scheme:




